Addressing Our Housing Needs

Working together with the Senate and stakeholders, a range of bills were passed this session to help struggling families throughout the state.

The House and Senate conference committees approved an unprecedented \$1 billion to help the homeless, very-low income, moderate-income, and working families with rent relief and housing. Developers will apply for and compete for funding to develop affordable housing.

The Legislature appropriated \$300 million to build rental housing. For the first time, up to \$150 million has been set aside to develop rental housing for working individuals and families with income about 60 to and at or below 100% of the median family income for the State of Hawaii.

The Department of Hawaiian Home Lands (DHHL) will receive \$600 million infusion of funds to develop lots, purchase lands, and provide funding for mortgage down payments and/or rental assistance for families and individuals. This money will benefit 28,000 native Hawaiians on the Department's Home Land Waiting List.

The Department of Human Services (DHS) will build on the success of the Ohana Zone pilot program with an additional \$15 million to develop more housing options and services for houseless families.

Also, \$23 million was set aside for a \$500 per month housing subsidy for TANF families, and \$5 million for home ownership program.

Housing bills sent to the Governor for his signature include HB 2511, SB 3048, HB 2512, HB 1600, HB 2233, HB 1837, HB 1752, HB 1829, and SB 206.
