CRITICAL CAPITAL FOR SMALL BUSINESSES IN HAWAII

The State of Hawaii Department of Business, Economic Development, and Tourism, Business Development and Support Division has shared new information and resources for Hawaii's small businesses affected by COVID-19. See below for new programs, loans, and other resources to help you through this challenging time.

1. Paycheck Protection Program

The recently signed Coronavirus Aid, Relief, and Economic Security (CARES) Act establishes a new \$349 billion <u>Paycheck Protection Program</u> that prioritizes millions of Americans employed by small businesses by focusing on job retention and certain other expenses.

Small businesses and eligible nonprofit organizations, Veterans organizations, and Tribal businesses described in the Small Business Act, as well as individuals who are self-employed or are independent contractors, are eligible if they also meet program size standards. <u>Click here to learn more</u>.

2. Economic Injury Disaster Loans and Loan Advance

To apply for a COVID-19 Economic Injury Disaster Loan, <u>click here</u>. In response to the Coronavirus (COVID-19) pandemic, small business owners in all U.S. states, Washington D.C., and territories are eligible to apply for an Economic Injury Disaster Loan (EIDL) advance of up to \$10,000.

The SBA's Economic Injury Disaster Loan program provides small businesses with working capital loans of up to \$2 million that can provide vital economic support to small businesses to help overcome the temporary loss of revenue they are experiencing. The loan advance will provide economic relief to businesses that are currently experiencing a temporary loss of revenue. Funds will be made available within three days of a successful application, and this loan advance will not have to be repaid.
