HRS 302A-251 (Act 167)

Establishes a minimum requirement for student instructional hours and days that are incrementally increased through SY 2018-19.

Equitable Instructional Time

Students should receive equitable instructional time in accordance with the law (Act 167/Act 52). Multitrack schools are presently exempt from the law.

- To obtain 190 days per year, students would need to attend school on weekends, holidays, or during Winter Break (171 days available on multi-track calendar).
- To obtain 1140 hours per year, students would need to attend school until 4:00 pm (888 hours available currently; end time – 2:35 pm).

Chapter 37: Real Property Transactions Involving the City and County of Honolulu

Sec. 37-1.3: Disposal of real property other than surplus real property.

(a) The city may not dispose of real property that is not surplus real property, as determined in Section 37-1.2, except pursuant to this section.

(b) If the director or the mayor, with the concurrence of the corporation counsel, finds it to be in the interest of the inhabitants of the city to dispose of city real property that is not surplus real property, as determined in Section 37-1.2, the director or the mayor may propose to the council that real property be disposed of pursuant to this section.

Any such proposal shall state the public interest being served by the proposal and shall state that the real property is not surplus real property.

(c) The council, either pursuant to a proposal made under subsection (b), or on its own proposal, may, if it finds

it to be in the interest of the inhabitants of the city, adopt a resolution authorizing the director to dispose of city real property.

(d) After the council's adoption of a resolution pursuant to subsection (c), the director may dispose of the real property that is the subject of the resolution in accordance with the terms of the resolution and with Section 37-1.6, Section 37-1.7, or Section 37-1.8, whichever is appropriate.

- Construction of 15 classrooms: 12 months
 - \$25 million

Mililani Middle School Additional Positions

In order maintain a single-track system and a fifteen classroom facility the school will need increases in:

- Security Personnel
- Custodial Personnel

The construction of the fifteen classroom facility will be a one time fixed cost as opposed to a reoccurring cost if the school were to increase staff in areas to maintain a multi-track calendar. A single-track system will address sustainability and educational standards.

2015 Legislation

SB1345: Relating to Public Schools

 Requires the department of education to develop a transition plan to end multitrack schedules in public schools and report to the legislature regarding the plan and any proposed legislation. Requires the department of education to give priority to overpopulated schools, including multi-track schools, among capital improvement project appropriation requests submitted to the legislature.

HB500: Relating to State Budget

- Appropriates funds for the operating and capital improvement budget of the Executive Branch for fiscal years 2015-2015 and 2016-2017
- Capitol Improvement Projects Item No. 45
 - Appropriates \$1.5 million for the plan and design for fifteen classroom buildings, ground and site improvements; equipment and appurtenances
