# STATEWIDE STAY AT HOME ORDER EXTENDED UNTIL MAY 31

Governor Ige signed a **6th supplementary emergency proclamation** on April 27 extending the stay-at-home order across the State through May 31.

Similar to the previous stay-at-home order, residents may leave their homes only for various essential needs such as: healthcare; purchasing food, medicine, and gasoline; caring for the elderly, minors, or those with disabilities; picking up educational materials for distance learning; and receiving meals or other related services.

Beaches remain closed. However, running, jogging, or walking on the beach is permitted as long as physical distancing requirements are observed. Outdoor exercise is also permitted, which includes swimming, surfing, solo paddling, and walking pets.

Also, the 14-day quarantine for both visitors and residents entering the State and for interisland travelers is also extended through the end of May.

The Governor's proclamation also requires the four county mayors to get his approval before making any new rules or orders.

"Extending the Statewide stay at home order was not an easy decision for the Governor, but it was one that I believe was necessary to ensure that we do not see an increase in positive test cases," said Sen. English. "Rebuilding our economy will be a major priority once the stay at home order is lifed, but for the time being, protecting the health and safety of our community is of utmost importance. We can always rebuild an economy, but we cannot bring back a life."

## COVID-19 TESTS ON MOLOKA'I AND HĀNA ARE NEGATIVE

Sen. English and Rep. DeCoite recently announced that all results from a COVID-19 community testing earlier this month in Hāna and on Moloka'i came back negative.


"We are so pleased that these initial test results are negative for Moloka'i and Hāna and have not found any more COVID-19 cases in these remote communities," remarked Sen. English. "We thank Mayor Victorino for his efforts in providing funding and Dr. Miscovich of Premier Medical Group (PMG) in Honolulu and his team for travelling to our community to administer the tests."

Testing took place on April 10 and 17 in Hāna, and April 7 and 16 on Moloka'i following the first confirmed cases in those communities. The community tests were sponsored by the County of Maui and PMG.

# NATIONAL GUARD BEGINS ENFORCEMENT AT HĀNA HIGHWAY AND PI'ILANI HIGHWAY CHECKPOINTS

The County of Maui has set up checkpoints after Twin Falls on Hāna Highway and at Ulupalakua Ranch on Pi'ilani Highway to restrict road traffic to East Maui. The checkpoints were implemented as a response to calls from residents to restrict the flow of tourists into East Maui and to prevent the introduction of the virus from travel related sources.

"The checkpoints were requested by many residents in our East Maui communities and I believe that the National Guard is doing an excellent job in enforcing the various checkpoints" emphasized Sen. English. "While I do understand that these checkpoints may be an inconvenience for some residents, the actions were necessary to prevent the spread of COVID-19 from reaching

our most isolated communities."

Travelers along the highways will be required to show a driver's license, registration, proof of insurance, and reason for travel or placard. Although not mandatory, an official placard is available to East Maui residents to help streamline the checkpoint process.

Residents may pick up a placard from 7 a.m. to 3 p.m. weekdays at Hāna Post Office, Hāna Police Station, Hasegawa General Store, Hāna Health, Hāna Ranch Store, Hāna Pit Stop, and the Ulupalakua Ranch Office.

# GOVERNOR ISSUES MORATORIUM ON ALL EVICTIONS

# COUNTY OF MAUI LAUNCHES H.E.L.P. FINANCIAL ASSISTANCE PROGRAM

In his fifth supplementary proclamation, Governor Ige issued a moratorium on evictions as the State continues to experience an economic downturn due to the COVID-19 shutdown. According to the order, landlords cannot evict anyone who fails to pay residential rent. Violators of the order face a misdemeanor charge, punishable of up to a year in jail or a \$5,000 fine.

"Without this moratorium, we may have seen an increase in homelessness across the State," said Sen. English. "Over 30% of Hawai'i residents are unemployed and this policy provides temporary relief as many families continue to deal with the financial hardship of this health pandemic."

## HAWAIIAN AIRLINES, 'OHANA BY HAWAIIAN, OFFERS RELIEF CARGO TRANSPORTATION TO MOLOKA'I AND LĀNA'I



In response to the closure of Friendly Market on Moloka'i, Hawaiian Airlines is providing free transportation of food and household items from O'ahu to both Moloka'i and Lāna'i. 'Ohana by Hawaiian will transport up to two packages from O'ahu shippers sending food and/or household items to Moloka'i or Lāna'i.

"There was a shared desire by community members and government officials to offer transportation service for essential items to Moloka'i and Lāna'i. It was great to see our team band together to launch a complimentary shipping program," said Blaine Miyasato, managing director of State government affairs at Hawaiian Airlines.

"I'm very appreciative to Hawaiian Airlines and their leadership for helping our rural communities during this difficult time," expressed Sen. English. "The closure of Friendly Market on Moloka'i has had a measurable impact on the community's food supply and the generous support of Hawaiian will ensure the continued arrival of essential items for residents."

Shippers must present a valid ID and adhere to maximum package weight and size restrictions and program guidelines before dropping off items between 10 a.m. – 1 p.m. Monday through Friday at Hawaiian Air Cargo facility.

Cargo space will be offered on a first-come, first-serve basis to the first 25 customers per flight each day. Shippers are encouraged to call (808) 835-3799 prior to going to the facility.

Receiving customers can pick up their shipments at the Moloka'i (MKK) or Lāna'i (LNY) airports within one hour of the following 'Ohana by Hawaiian arrivals: Moloka'i, HA 672 scheduled arrival is 5:01 PM; and Lāna'i, HA 684 scheduled arrival is 7:16 PM.

## Use Of Cloth Face Coverings To Help Slow The Spread Of COVID-19

The Center for Disease Control (CDC) recommends wearing cloth face coverings in public settings where other social distancing measures are difficult to maintain (e.g. grocery stores and pharmacies), especially in areas of significant community-based transmission.

The cloth face coverings recommended are not surgical masks or N-95 respirators. Those are critical supplies that must continue to be reserved for healthcare workers and other medical first responders, as recommended by current CDC guidance.

CDC advises the use of simple cloth face coverings to slow the spread of the virus. This helps people who may have the virus and are unaware of that from transmitting it to others. Low cost homemade face coverings assembled from common materials, such as t-shirts can be used for this purpose.

Cloth face coverings should: fit snugly and comfortably against the side of the face; be secured with ties or ear loops; include at least two layers of fabric; allow for breathing without restriction; and be able to be laundered and machine dried without damage or change to its shape.

Cloth face coverings should not be placed on young children under age 2, anyone who has trouble breathing, or is unconscious, incapacitated or otherwise unable to remove the mask without assistance.
