

- Vaccination of Kupuna 75+ is in process.
  - 41,350 Kupuna still have not received a first dose
- Vaccination of age 70+ is expected to begin around March 15<sup>th</sup>.
- Vaccination of age 65+ is expected to begin a couple weeks later.

  - 4 million doses made available to the U.S. Sunday night
  - 11,900 doses will arrive in Hawaii this week (<u>https://www.hawaiitribune-</u> herald.com/2021/03/02/hawaii-news/nearly-12k-doses-of-johnson-johnson-inoculation-headed-for-hawaii/)
  - 16 million more doses will be available to the U.S. by the end of March
  - 100 million total doses expected to be available to the U.S. by the end of June
  - Requires only one dose

### COVID-19 Emergency Rules

- All businesses, operations, and activities are permitted to remain open, except:
  - Nightclubs
  - Large indoor venues
  - Large outdoor venues
  - Road races (marathons, triathlons, etc.)
- Face coverings required while in public settings.
- Elderly and others at high risk for COVID-19 are urged to stay in their residences to the extent possible.
- Persons who are sick or are exhibiting symptoms such as fever or chills, cough, shortness of breath, fatigue, muscle or body aches, headache, sore throat, or any other symptoms of COVID-19 identified by the CDC shall NOT report to their places of employment and shall stay at their residences, except as necessary to seek medical care.

### COVID-19 Emergency Rules

- All persons shall maintain a minimum of six (6) feet of physical separation from all other persons to the fullest extent possible.
- Businesses
  - Limited customer occupancy
  - Hand sanitizing products for employees and customers
  - Disinfection
  - Safeguards for high-risk populations
  - Online and remote access
  - Pick up at store or delivery (if feasible)
  - Signage (mask rule, physical distance rules, symptoms, etc.)

## COVID-19 Emergency Rules

#### • Gatherings

- Indoor or outdoor social gatherings of groups up to ten (10) persons are permitted.
- Face coverings are required and physical distancing (6 ft) between separate groups must be maintained.
- Members of a single residential or family unit who share the same address are not restricted.
- A social gathering is defined as a planned or spontaneous event, assembly, or meeting that brings together multiple people from separate households in a single space or area, indoors or outdoors, at the same time and in a coordinated fashion.
- A social gathering includes but is not limited to, such get-togethers as a banquet, barbeque, concert, fair, festival, funeral, luau, parade, party, picnic, or wedding.
- A social gathering does NOT include, and this definition does not apply to:
  - Federal, State, and County government operations and functions.
  - Educational and childcare facilities.
  - Businesses, operations, and activities operating under Section A of Mayor's COVID-19 Emergency Rule No. 14.

# SAFE TRAVELS HAWAI'I QUICK FACTS



#### To Bypass Quarantine:

- Proof of negative test result must be uploaded or brought in hand in hard copy prior to departure or remain in quarantine for 10 days
- Must take a nucleic acid amplification (NAAT) pre-travel test within 72 hours from the final leg of departure. The State of Hawai'i will accept test results ONLY from TRUSTED TESTING AND TRAVEL PARTNERS.
- · Applies to all passengers ages 5 and over; travelers pay for test
- · Must complete Safe Travels Hawai'i online form prior to arrival
- · Or other exemption provided by the state
- Travelers to Kaua'i must receive a negative pre-travel test result before departure and a 2nd negative
  test result after 72 hours at an approved Enhanced Movement Quarantine "resort bubble" property.

#### To Bypass Quarantine:

- Traveling into City and County of Honolulu No test and no quarantine required

### Puna Library Update

- Two new libraries will be planned for Puna, the first being in Pāhoa and the next location being in Kea'au. The proposed construction of the new Pāhoa Public Library will include 8,000 square feet (SF) of enclosed, air conditioned, interior space and 1,000 SF of indoor-outdoor entry. The proposed sites are:
  - Site 1 Pāhoa Fire Station/DMV
  - Site 2 Pāhoa District Park
  - Site 3 Highway 130 Mauka (DLNR); approximately 0.4 miles to the northwest of the intersection of Niaulani Street and Highway 130
- Kea'au Library sites are being proposed for Environmental Assessment.

- Department of Hawaiian Home Lands (DHHL)-Makuu-HawaiianTel is expanding to provide fiber internet.
- Starlink possibility in 2022.
- \$50 credit towards broadband bill per latest Federal act.
  - The FCC on Thursday (Feb 25) adopted the Federally funded broadband discount program to help households afford internet service during the pandemic. The Emergency Broadband Benefit (EBB) program will provide eligible households with discounts of up to \$50 a month for broadband service, and up to \$75 a month if the household is on Tribal lands (Hawaiian Homelands). It also will provide a one-time discount of up to \$100 on a computer or tablet for eligible households.
  - Emergency Broadband Benefit Program will roll-out second half of April of this year.
  - Aloha Broadband is exploring their participation in the EBB program.

- Emergency Broadband Benefit Program will roll-out second half of April of this year.
- EBB is not taking applications from consumers yet. More info will become available at: <u>https://www.fcc.gov/broadbandbenefit</u>
- Under the law, the Emergency Broadband Benefit program is open to households that participate in an existing low-income or pandemic relief program offered by a broadband provider; Lifeline subscribers, including those that are on Medicaid or accept SNAP benefits; households with kids receiving free and reduced-price lunch or school breakfast; Pell grant recipients; and those who have lost jobs and seen their income reduced in the last year.
- Because Lifeline service users will automatically qualify them for EBB folks may want to sign-up for Lifeline now.

- Aloha Broadband is exploring how they can participate in EBB program.

#### • Starlink:

• In addition to the current ISPs, Starlink is in the process of launching more Low Earth Orbit (LEO) satellites to cover the globe with satellite services. Current download speeds in beta testing have ranged between top speeds of 50-150Mbps. Hawaii residents signing up for service at the Starlink website are generating a note that a target deployment for service by the year 2022 on a first come, first serve basis. ### • Spectrum

• Spectrum wants to expand their network on Hawaii Island. No timetable has been provided.

### • Cellphone Carriers

• The companies have made various proposals for additional cell towers and using advanced technologies for more coverage and speed.

- HawaiianTel
  - HawaiianTel has was awarded \$24M from the Federal Rural Digital Opportunity Fund (RDOF) to expand their 1Gbps fiber to rural areas. (HawaiianTel's timeline is by 2027).
  - Currently reviewing EBB and considering how to best participate.
  - In the meantime, Internet Kokua Program remains available to those who qualify: <u>https://www.hawaiiantel.com/Residential/Discounted-services-for-qualified-Hawaii-residents</u>
  - 2021 fiberoptic build plans include deploying broadband infrastructure to enable high-speed internet to the following locations:
    - Mountain View 1,532 locations
    - Kea'au 5,752 locations
    - Na'alehu 175 locations

### Pohoiki Boat Ramp Update

- Department of Land and Natural Resources (DLNR) moving forward with plans to dredge a channel restoring access to the current boat ramp.
- The State is working with Limtiaco Consulting Group on engineering and design.
- Dredging project will use \$1.5 million previously appropriated by the Legislature and will supplement it with Federal Emergency Management Agency (FEMA) monies.
- Dredging project qualifies for environmental assessment exemption. Maintenance of already existing infrastructure.
- Key to economic recovery.

# Pohoiki Boat Ramp Update: Restoration Options

#### Excavation and Dredging


- Removal of approximately 15,000 cubic yards of sand by dredging or excavation
- Placement of sand back on the beach
- Estimated construction cost: \$2.5M
- Construction timeline: approximately 9 months

#### Entrance Channel Improvements


- Follow-up to dredging and excavation
- Installation of permanent structures to protect entrance channel
- New swim area
- Estimated construction cost: \$6M
- Construction timeline: 2-3 years


#### New Boat Ramp Facility

- New ramp on new lava flow on the north side of the bay
- Construction of new breakwater, boat ramp, loading dock, trailer turn around and parking area
- Estimated construction cost: \$28M
- Construction timeline: 5-6 years+

# Child Abuse; Keiki Protections



- Adds immunity from civil and criminal liability for individuals who provide information or assistance in child abuse investigations.
- On January 7, 2019, the federal Victims of Child Abuse Act Reauthorization Act of 2018, P.L. 115-24, was enacted, further amending the Child Abuse and Prevention and Treatment Act (CAPTA). The amendment grants immunity from civil and criminal prosecution to people who provide information or assistance to a good faith report of child abuse and/or neglect. This includes medical evaluations and professional consultations.

# Persons with Disabilities; Minimum Wage



- Repeals the exemption of persons with disabilities from minimum wage requirements.
- Under the law, being "disabled" or "handicapped" allows an individual to be considered exempt from minimum wage within the State of Hawaii. The subminimum-wage law for workers with disabilities was enacted as part of the Fair Labor Standards Act (FLSA) in 1938, before the civil rights era as a means of easing disabled persons into the workforce (this law is no longer relevant and no longer serves the purpose it was originally intended to fulfill).

## Homelessness



- Allows the governor's coordinator on homelessness, in conjunction with the Hawaii Interagency Council on Homelessness, to develop plans for the City and County of Honolulu and the counties of Hawaii, Kauai, and Maui to coordinate the services and shelter facilities of public agencies and nonprofit organizations to meet the concerns of communities impacted by homelessness and the needs of the homeless population within each county.

# Sex Trafficking; Minors



 Includes coercion as a means of committing the offense of sex trafficking. Removes the criminal statute of limitations for sex trafficking and promoting prostitution. Designates solicitation of a minor for prostitution as a form of sex trafficking. Specifies that sex trafficking of a minor is a strict liability offense. Repeals the offense of solicitation of a minor for prostitution.

# Domestic Violence



- Adds abuse of a family or household member to those felonies that qualify for repeat offender sentencing.
- Existing law does not provide for enhanced sentencing for defendants who continue to abuse beyond a third offense. These repeat offenders may serve terms that are substantially shorter than five years, or worse, receive probation.

# Kupuna Support



- Allows the Executive Office of Aging to relax the thirtyhour employment requirement for qualified caregivers under the Kupuna Caregivers Program during a statedeclared state of emergency. Adds the option of kupuna caregiver-directed services to the Kupuna Caregivers Program. Includes assisting the care recipient and caregiver with the enrollment process as the duty of a coach. Allows funds under the Kupuna Caregivers Program to be issued to the care recipient's financial management service provider.

# Public Assistance; General Assistance During State of Emergency



 Allows the Department of Human Services to administer and provide public assistance to eligible residents of the State during a governor-declared state of emergency period to persons who are not otherwise provided for under this chapter and who are unable to provide sufficient support for themselves or those dependent upon them, provided that such persons meet the criteria.

## Food Donations; Charitable Protections



• Expands liability protection for donors to include donations of food and similar donations made to needy persons by organizations. Authorizes the donation of expired food when the donor reasonably believes in good faith that the food remains fit for human consumption.

# Ambulance; Emergency Services; Medicaid



- Requires Medicaid and insurance coverage of ambulance services. Authorizes Medicaid programs, and requires private insurers, to pay for community paramedicine services provided by emergency medical technicians or paramedics. Appropriates moneys for costs resulting from Medicaid coverage of ambulance service and community paramedicine services provided by emergency medical technicians or paramedics. Requires the Auditor to submit a report to the Legislature.

# Agricultural Cooperative Associations

- Authorize agricultural cooperative associations and consumer cooperative associations to operate as agents to sell the products of their members and nonmember patrons on a nonprofit basis, under certain conditions;
- Allow agricultural cooperative associations and consumer cooperative associations to convert to cooperative associations;
- Authorize an agricultural cooperative association to be formed for purposes in connection with leasing land to its members;
- Authorize the articles or bylaws of an agricultural cooperative association to provide for referendum upon the affirmative vote of two-thirds of its members voting at any meeting; and
- Exempt membership stock or membership certificates issued by a cooperative and preferred stock, equity, or notes issued to members of a cooperative.

# Agricultural Structures; Building Permit and Code Exemptions

- The purpose and intent of this measure is to increase the maximum area for each agricultural shade cloth structure, cold farm, and greenhouses that could qualify the structure for an exemption from building permit and building code requirements.
- The existing maximum area for each agricultural shade cloth structure, cold frame, and greenhouse that qualifies the structure for an exemption from building permit and building code requirements is twenty thousand square feet. Increasing the maximum area allowed from twenty thousand to sixty thousand square feet will support local food production.
- This measure will drastically cut construction costs and effectively utilize the open areas currently required between smaller greenhouses. This will in turn make farming more productive and economically feasible for farmers and will further help Hawaii reach its self-sustaining food production goals.

# Food Labeling (not heard yet but still alive)



- Prohibits certain food labeling practices with regard to foods with non-genetically-modified-organisms, organic foods, and gluten-free foods.
- Prevents some food manufacturers from making less than factual health claims on their food labels that take advantage of a consumer's preference to eat healthy foods.

# Advanced Practice Registered Nurses; Rural Healthcare



- Authorizes advanced practice registered nurses to certify whether a person is totally disabled under the income tax code. Authorizes advanced practice registered nurses (APRN) to make capacity determinations. Adds APRN as primary providers in advance mental health care directives.
- There is a need for greater access to healthcare in the State, especially in rural communities and on the neighbor islands. Because there is a welldocumented physician shortage in the State, authorizing the readilyavailable APRN workforce to engage in activities within their scope of practice and in accordance with their education, training, and licensure provides a reasonable means of addressing this problem.

# Community Health Workers; Rural Healthcare



- Requires the Department of Health to establish a task force to plan the certification and training process for community health workers and submit a report to the legislature.
- Hawaii is facing a shortage of medical professionals, especially in geographically isolated and homeless communities. Community health workers help support medical practices by providing essential health education and working with social service programs, which are currently struggling to keep up with the demands placed on the behavioral health care system as a result of the coronavirus disease 2019 pandemic. Community health workers have been underutilized and this measure would establish a pathway for certification and reimbursement for services rendered by community health workers.

# Telehealth



- Authorizes the establishment of a physician-patient relationship via a telehealth interaction, if the physician is licensed to practice medicine in the State.
- Currently, the law is ambiguous as to when a physician-patient relationship is established via telehealth. As written, the physician-patient relationship with a telehealth provider can only be established if the patient was first referred to the telehealth provider by another health care provider who has conducted an in-person consultation with the patient. The 2019 COVID-19 pandemic has resulted in an increase in the use of telehealth services and the establishment of telehealth as a community standard of care is a strategic priority for the Department of Health. This measure will make clear that a physician-patient relationship may be established via telehealth by a physician licensed to practice medicine in the State.

# Commercial Rent Relief; Local Businesses; Federal Aid




- Establishes a Commercial Rent Relief Grant Program. Requires that the commercial rent relief grants be given priority for moneys received through federal funding.
- As a result of the coronavirus disease 2019 (COVID-19) pandemic and stagnation of the tourism economy, it is estimated that more than one thousand four hundred local businesses have closed their doors permanently, with another two thousand suspending their operations at least temporarily. Commercial rent remains one of the largest fixed costs for a business, and without the ability to take on more debt or additional governmental support, the expenses being absorbed by both lessors and lessees will result in additional closures, further damaging this sector of the economy.

# Medical Cannabis



- Authorizes the sale and distribution of cannabis propagules, cuttings, cannabis seeds and cannabis clones by medical cannabis dispensary licensees, subject to quantity limits and quality requirements.
- Patients and primary caregivers who wish to cultivate medical cannabis have no legal means of obtaining safe, laboratory-tested genetic material from which to propagate their plants. Currently, state law authorizes qualifying patients to cultivate up to ten medical cannabis plants but does not specify by what means propagules, cuttings, or other cannabis genetic material necessary to produce these plants may be obtained. This measure will allow authorized patients and primary caregivers to obtain laboratory-tested genetic material without resorting to illicit markets.



## Civil Asset Forfeiture

- Restricts asset forfeiture to cases involving the commission of a covered criminal misdemeanor or felony offense. Requires seized property to be forfeited only when the property owner has been convicted of an underlying covered criminal misdemeanor or felony offense. Changes the standard of proof that the State must meet in order for property to be forfeited from "preponderance of the evidence" to "beyond a reasonable doubt." Requires the State to prove that owners consented to or possessed knowledge of the crime that led to the seizure of their property. Requires that the agency seizing the property pay for safe and secure storage of the seized property until the completion of the forfeiture proceeding or final disposition of the property. Directs any proceeds from a civil forfeiture to the general revenue fund for public education purposes.

#### Civil Asset Forfeiture (cont.)



- A 2017 report by the Institute for Justice, a civil rights law firm, gave Hawaii a grade of "D+" for its civil asset forfeiture program overall and an "F" on its accounting for how seized cash and property proceeds are later spent by law enforcement agencies
- In 2017, I passed a resolution requesting an audit of the Attorney General's Civil Asset Forfeiture Program.
- The audit revealed mismanagement of the Asset Seizure Program.
- Failure to account for forfeited property.
- Failure to spend \$2M for drug prevention programs as required by the law.
- Lack of administrative rules to provide guidance to law enforcement, county prosecutors, and the public.
- Lack of transparency and accountability.
- According to the audit, 26 percent of the \$11.5 million-worth of civil asset forfeitures by Hawaii law enforcement between 2005 and 2017 were not accompanied by criminal charges.

# Landlord-Tenant Code; Tax Evasion; Unfair Evictions



- Requires certain landlords, lessors, or plaintiffs in a summary possession action to provide a general excise tax license in good standing.
- If passed, this bill would serve the dual purpose of encouraging tax code compliance and discouraging frivolous and illegal eviction efforts by landlords who don't care to respect their tenants' rights. Landlords who use the taxpayer-funded court system to evict tenants should be required to prove they are complying with their tax-related obligations.



- Authorizes qualifying patients and qualifying out-of-state patients to transport cannabis between islands of the State for personal medical use.
- This measure assures access to legal medical cannabis to qualifying patients regardless of where they live or where they travel within the State.

# Abandoned Properties; Squatters; Public Safety



- Requires counties to establish expedited procedures to approve demolition permits for vacant and abandoned residential homes. Allows the Department of Taxation to seek sale of the property through nonjudicial foreclosure of vacant and abandoned residential properties with outstanding recorded state tax liens after establishing vacancy and abandonment.
- Abandoned residential properties can impose significant costs on the community and become public safety hazards and magnets for criminal activity. Furthermore, it is in the public's interest to encourage the use of residential properties and reduce the number of vacant and abandoned homes in the State. This measure will reduce the potential hazards associated with vacant and abandoned residential properties and ensure that they are promptly removed from Hawaii communities.

# Keiki Caucus; Emancipation



- Allows a minor who has reached the age of 16 to petition the Family Court for emancipation, and directs the court regarding investigation of the petition, appointment of legal counsel and a guardian ad litem for the petitioner, and the findings necessary to grant the petition. Specifies the rights gained by the minor upon emancipation and authorizes the court to require the minor's parents or legal guardians to pay for any services ordered by the court.
- Provides support for minors seeking to escape abuse and/or neglect. This bill provides a means of allowing a minor to seek emancipation while also requiring parents to provide financial support. This reduces the risk of minors entering into marriage with adults and/or engaging in prostitution.

# Medical Cannabis; Cultivation Licenses

- Creates a cultivation facility license, which allows cultivators to grow cannabis for sale to licensed dispensaries. Establishes requirements for license application and qualifications for license holders.
- Currently, only holders of medical cannabis dispensary licenses may legally cultivate and sell medical cannabis in retail locations. Allowing residents, farmers, and families to grow cannabis for retail would provide a positive social and economic impact across the State and creates better access to safe, regulated products for qualified patients.

# Wage Garnishment; Moratorium; Emergency Proclamation

- Prohibits a creditor from initiating or continuing any action to garnish wages from a debtor during the period of an emergency proclamation in relation to the coronavirus disease 2019 (COVID-19) pandemic and some time thereafter. Prohibits a creditor from garnishing more than ten per cent of a debtor's wages for six months thereafter.
- Many households, particularly those of the economically vulnerable, often depend on several incomes to make ends meet. Due to the economic devastation created by the COVID-19 pandemic, many of these households now have fewer incomes on which they can rely. Existing law allows creditors to garnish approximately twenty-five percent of a person's net wages, but for many in this State experiencing hardships related to COVID-19, that amount can directly impact whether a household can continue to pay for basic needs.




### Minimum Wage Increase



- Increases the minimum wage for certain employees to \$12.00 per hour beginning 7/1/2022.
- A vast majority of credible studies conclude that higher minimum wages appreciably boost workers' earnings with little or no effect on employment. A 2018 study by the U.S. Census Bureau found that raising the minimum wage benefits a large majority of low-income workers by putting them on the path to higher earnings in the long term and decreasing income inequality. There is currently, a significant difference between the minimum wage and what is needed to afford basic needs in Hawaii.


### 2021 Homelessness Summit




