The University of Hawaii Professional Assembly (UHPA) **supports GM 597**, to confirm the appointment of Alapaki Nahale-a to the Board of Regents of the University of Hawaii.

As an indigenous serving institution, the involvement and participation of Native Hawaiian and other Pacific Island members on the University of Hawaii (UH) Board of Regents is essential. During his first term as a Regent, Mr. Nahale-a was a vocal advocate for Native Hawaiian issues and for ensuring the University was growing to meet its educational and research goals. An active participant on the Board, Mr. Nahale-a held multiple roles, serving one year as second vice-chair, two years as the first vice chair, as well as chair of the Planning and Facilities Committee for two years and chair of the Maunakea Permitted Interaction Groups. As a result of his on-going leadership, the Board elected Mr. Nahale-a to Chair of the Board in July 2023, one of only three Native Hawaiians since the 1980s to ever serve in the position. Since stepping into the role of Board Chair, Mr. Nahale-a has successfully led the Board in a fair, thoughtful, and organized manner, encouraging a robust discussion of University issues and providing members the opportunity to question and explore important issues within their committees.

While Mr. Nahale-a may not have extensive knowledge in faculty labor issues, he has been open to discussing and understanding faculty concerns and compliance with the Collective Bargaining Agreement. I feel confident that, under his leadership, UHPA will work well with the Board as it advocates for important faculty issues.

Thank you for the opportunity to provide testimony in support for GM 597, to confirm the reappointment of Alapaki Nahale-a to the Board of Regents of the University of Hawai'i.

My name is Lennie Espinoza and I am a community leader and alumni of UH Hilo. Graduating in 2023, I was a dormer at Hale Ikena F204 and F303 from Fall 2022 to Fall 2023. I am writing in opposition of Chair Alapaki Nahale-a being confirmed into the UH Board of Regents, and request that the Higher Education Committee vote against his appointment. Through first hand experience as a UHH student, I firmly believe that as a Hawai'i County Regent, Nahale-a has done nothing of significance that can be felt by the UHH student body, and has remained silent when confronted by the issues faced by students across campus.

Despite his many years working in community engagement and resources, Hawai'i county regent Nahale-a shows very little passion about the quality and quantity of resources accessible to students on UHH campus. Our laundry mats are constantly having issues, and the Hale Ikena dryers do not work. My roommates and I began going out in town to do our laundry, paying more for gas and public transport as well as spending more time away from our studies. Our appliances are rusted and quite literally falling apart, with paint chips and rust dust covering our kitchen floors. Along with black mold in our bathrooms that housing has told us "they can't do anything about", I believe it is time we have regents who care enough about the **health** and **wellbeing** of students to delegate time, initiative, and funding to the living conditions we pay to live in.

Within my 4 semesters living on campus, as well as at this very moment, students are being consistently **displaced** and moved around the dorms due to plumbing and electricity issues. In the middle of semesters, we are having to pack our things and move due to flooding and power outages. The following are images sent to me by a peer and member of Ngelekel Belau Club, who has had to relocate dorms with no answer regarding refunds or support as of 02/08/24. This impacted his school work, as well as practice for UH Hilo's beloved annual International Night:



Lastly, as a 2 spirit LGBTQIA+ community member and activist, the lack of respect and support there is for queer students across campus and housing is disgusting. We are placed with genders that we do not identify with or are isolated due to the university "not knowing what to do with us". We are **dead-named**, **misgendered**, and consistently **disrespected** by both student staff and administration. Despite Chris Holland's lies during the last Board of Regents meeting (02/15), UHH and UHH housing is well aware of the issues 2STGNC+ UHH students face when housing on campus and working with UH staff. I, as well as my transgender siblings on campus, have brought up our issues **repeatedly**, going to Chris Holland, UHHSA, and the Office of Equal Opportunity on many separate occasions.

As a UHH alumni, I find myself hesitant to show pride in my school due to the lack of care the board of regents and UH leadership as a whole show for our student body. As the Higher Education Committee, the treatment of students, who are the heart and soul of the University of Hawai'i, should be of utmost importance to you. Student leaders currently enrolled at the University of Hawai'i asked for my support in opposing the confirmation of Alapaki Nahale-a to the University of Hawai'i Board of Regents. The students have evaluated his service as a Regent over the last 5 years and their assessment is far from stellar. They have found that Mr. Nahale-a works against transparency and openness in Regent business.
