Dear Senator San Buenaventura:

Mahalo for the opportunity to reach out to you ahead of my confirmation hearing to submit response to the questions posed in your letter of February 20.

- 1. <u>Description of experience in the field of the State Health Planning and Development Agency (SHPDA), or related field:</u>
  - While a practicing physician in internal medicine (primary care), public health, cardiovascular medicine, and health policy throughout my career, I know Hawai'i's health system well. I practiced clinical medicine in my early career in Maui in various roles, including seven years as a staff physician at Maui Memorial Hospital (HHSC), including working in the half-time (mornings) in intensive care unit, Chairing the Pharmacy and Therapeutics Committee; and serving simultaneously half-time (afternoons) as Chief Physician at Kula Hospital and Director of Kula Clinic for HHSC prior to being appointed as Hawai'i's Director of Health in January 1986 by Governor John Waihe'e.
  - My most significant experience related to the functions of and familiarity with SHPDA itself was as Hawai'i's Director of Health from 1986 to 1994 under Governor john Waihe'e. The DOH Director indirectly oversees SHPDA, which is administratively attached to the DOH, and I worked closely over those years with Kina'u Kamali'I, the then Administrator, on many health policy matters, on streamlining the Certificate of Need (CON) program and collaborating on inventorying and updating Hawai'i's statewide facilities and services in health and long term care. But SHPDA's original statutory goal to serve as Hawai'i's health care oversight agency was never funded or realized.

- Other relevant experience in health planning, and in improving health care access, equity, quality improvement, and cost-effectiveness was gained as:
  - Director of Health for the tri-state (Arizona, New Mexico, Utah) Navajo
     Nation as a US Public Health Service Physician Commissioned Officer;
  - CEO of the American College of Cardiology in Washington DC; and
  - President/CEO of the Cardiovascular Research Foundation (New York, New York).
- In terms of health system reform efforts:
  - Assisted the Waihe'e Administration with full implementation of the Prepaid Health Care Act (PHCA) as Director of Health after it was rescued from a decade of legal challenges by the US Chamber and business community through a Congressional exemption from ERISA (the Employee Retirement Income Security Act);
  - Designed and implemented the State Health Insurance Plan (SHIP) in 1990 to provide coverage to Hawai'i's remaining uninsured population.
     SHIP was later folded into Med-QUEST;
  - Worked with President Clinton and the First Lady on her health reform plan, based on the PHCA, which was unsuccessful;
  - Worked with California's Governor Gray Davis and Speaker Willie Brown on the successful passage of the California version of the PHCA, but which was overturned by incoming Governor Schwarzenegger and his party by ballot initiative, and;
  - Worked with President Obama on the Affordable Care Act.
  - My bio is attached.

#### 2. Assessment of strengths and weaknesses:

Strengths: I stand on my career record. I am asked by our Governor to help coordinate development and achievement of his vision of "universal access to high-quality, equitable, and affordable health care for ALL: my entire career has been focused on this elusive national and state goal. Nothing could excite me more. I have a determination to 'get things done' when assigned as my kuleana. I enjoy challenges and working with others to create a shared vision. I consider myself an ethical manager, a team player, and an honest and capable communicator.

 Weaknesses: I can be impatient when things get bureaucratically bogged down. But I am learning to transform the frustration of impatience into considerate determination.

#### 3. Assessment of the agency's (SHPDA's) strengths and weaknesses:

- Strengths: SHPDA (once federally funded with 65 staff in the 1970s) is currently a team of 6, focused mainly on the CON and inventorying state health and long term care facilities and services. It does those limited but important things well. Every member of the team is competent and dedicated to the mission. And the team thinks the bigger mission and challenge of assuming the originally intended role of being the state health care oversight agency is sorely needed.
- <u>Weaknesses</u>: 6 people cannot possibly take on effectively the broader, necessary health oversight role in monitoring and assuring health care access and workforce gaps, quality, equity, and cost-effectiveness for ALL in Hawai'i.
   We lack funding and staffing to tackle this essential mission.
- 4. Overall vision for SHPDA, specifically what goals can be accomplished in the next 4 years, what benchmarks can be used to evaluate progress?
  - 2024: Build on the original impressive 1975 statutory mission with some additional improvements to fund and staff SHPDA as the Hawai'i health care oversight agency. This will depend initially on passage of SB 2285 SD1 with 7 new staff positions, \$1.93 M in funding in 2024. This also includes highly technical actuarial, data analytics, health policy consulting expertise to use existing sources of data and UH expertise to build the data reporting systems needed, and importantly to train the new staff to assume their necessary roles over the first three years of early operation. Other states with this capacity have shared that this approach will be necessary to move forward expeditiously.
  - 2025: Begin early reporting on statewide gaps in access, quality, equity and cost-effectiveness in 2025; including percent total spending on primary care, rural health, and improvements in long-term care spending for home and community based services.
  - 2026: More refined reporting in 2026 to include more sophisticated workforce improvement tracking (with UH, JABSOM, others), health status monitoring around disease specific foci (heart disease, cancer, maternal/child health,

etc.), and a first attempt at producing a total-cost-of-care (TCOC) global budget for Medicaid, Medicare, and commercial coverage to monitor at least 75 percent of total statewide health spending as compared with general inflation and population health status. Develop data interoperability reporting and improvement plan to assure collection of clinical data from missing sources including rural and small practices/clinics, and critical access hospitals. Achieve voluntary submission of missing commercial insurance data from the 250,000 persons not covered by the existing legislative mandates to SHPDA.

- 2027: Phase out consultant services in 2027, with staff capability assuming health care oversight responsibilities. Reporting to accurate data-sharing on performance factors for hospitals, physicians and other clinicians, and on long-term care to motivate quality improvement and cost-effectiveness.
   Achieve close to 100% of data reporting from missing sources and produce a TCOC global budget for 100% of delivery system for tracking affordability of health and long-term care.
- 2028: Evaluate and improve the entire health data collection, data analytics, and monitoring of access, quality, equity, and cost-effectiveness processes for the future.

#### 5. The Agency's top budgetary priority for the Biennium:

 Obtain the funding and staffing in 2024 (7 staff, consultants, \$1.93 M) as described previously.

#### SHPDA Modernization:

- Digitalize the 49 years of SHPDA CON 100% paper data for easier public access, and implement digital CON processes for the future.
- Clear out several rooms full of filing cabinets and old equipment from 49 previous years to make room for new staff and streamlined operations. Build out the office to accommodate 7 new staff.
- Bring on a 1-year consultant to update the Statewide Health Facilities and Services Plan in late 2024, to be published in early 2025. Future updates will be performed with newly acquired staff, who most likely won't be realistically on board until early 2025 if funded in July, 2024.
- Recruit consultants needed to kick-start the actuarial, data analytics, and data reporting processes needed for health and long-term care

- oversight activities from 2024 to mid 2027; and to train new staff to independently manage these responsibilities by 2027; and
- o Recruit and hire the seven new staff required.

#### 6. Assessment of Agency's staff morale and turnover rate:

- Staff morale is excellent. The group works as a team. Speaking for myself, I
  enjoy getting up and coming to work every day.
- Turnover is minimal. One vacant position following a recent employee relocation is being rapidly filled. Only one position (with a long commute) teleworks one day per week. People want to be in the office working together. One staff has worked for DOH/SHPDA for 40 years and will retire soon. One has been a SHPDA for 21 years but will be here years more. The others are also long-term state employees.

#### 7. Foreseeable conflicts of interest:

- None I can report. I have no family or relatives working in health care in Hawai'i. Nor do SHPDA team staff members.
- We will follow standard state policy on contracting and conflicts.

Chair San Buenaventura, Vice Chair Aguino and Members of the Committee:

My name is Robert Hirokawa and I am the Chief Executive Officer of the Hawaii Primary Care Association, a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA <u>SUPPORTS</u> the confirmation of JOHN (JACK) LEWIN, as the Administrator, State Health Planning and Development Agency (SHPDA), for a term to expire on December 7, 2026.

By way of background, the HPCA represents Hawaii's Federally Qualified Health Centers (FQHCs). FQHCs provide desperately needed medical services at the frontlines to over 150,000 patients each year who live in rural and underserved communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of healthcare.

The HPCA has long held that the social determinants of health – more than any other factor – contribute to the overall wellbeing of our people. Persons who experience homelessness, language barriers, and poverty are more likely to suffer persistent, chronic health issues, and have shorter life expectancies than those who do not.

We believe that Dr. Lewin's impeccable credentials, steadfast dedication and tireless commitment to furthering the health and wellbeing for all of Hawaii's communities make him uniquely qualified for the position of SHPDA Administrator. As demonstrated throughout his career, Dr. Lewin fully understands the importance of socio-economic equity in the pursuit of optimal health outcomes for all our citizens.

RE: Testimony in support of confirming John C. Lewin, MD as Administrator of SHPDA

To Chair Senator San Buenventura and Vice-Chair Senator Aquino

My name is Francis Chan and I am the Chief Executive Officer of Hawai'i Health Information Exchange HHIE). HHIE is the entity designated by the State of Hawai'i to administer exchange Health Information among Health Insurance Companies, Hospitals, Physicians, Pharmacists and other healthcare providers to reduce cost and improve patient outcome.

HHIE supports the Governor's nomination of John C. Lewin, MD as Administrator of SHPDA.

While the State of Hawai'i has been ranked as among the top states in the country in terms of health care accessibility and outcome, based on the data that HHIE has been able to analyze, we have identified gaps in healthcare access and outcome among Native Hawai'ians and Pacific Islanders. For example, in Census Tracts where there are higher percentage of Native Hawai'ians and Pacific Islanders, their household income is lower, and children tend to uninsured and rely on Emergency Rooms for primary care. More focused leadership and collaboration between the State and Providers are needed to address the disparities among the population.

Dr. Lewin has shown insight into how the situation can be improved. Coupled with the experience that he has, his knowledge about the local and national landscape, and the initiatives he has launched in the past few months to promote collaboration among the healthcare stakeholders, I believe that Dr. Lewin is the best candidate to serve as Administrator of a revitalized SHPDA. The agency under his leadership can continue the important work to bring about universal, quality healthcare to the citizens of Hawai'i.

My name is Melvin Sakurai and I am a management consultant with healthcare policy planning experience working with the State Department of Health (SHPDA), Governor's Executive Office on Again, Governor's Blue Ribbon Panel on Health Care, Legislative Auditor, and the Hawaii Health Systems Corporation on projects ranging from developing a publicly funded long-term care financing system to the regulation of adult residential care homes and formulating a public-private partnership solution for acute hospital wait listed patients.

As a member of the SHPDA Universal Access Advisory Council we are actively engaged with addressing the critical need to modernize and reform Hawaii's health care system to substantially improve achieving elevated quality of care and outcomes, universal equitable access, and cost-effective affordability for all.

In support of enacting SB2285-SD1, I ask that the newly added Section 2(a)5 be further amended as follows:

- (5) Develop an annual state global budget based on total costs of health care <u>for all</u> <u>inpatient and outpatient hospital service providers</u> to:
  - (A) Prevent costs from rising faster than general inflation; and
  - (B) Assure all purchasers of health care facility services including Medicare and Medicaid under Section 1115 of the Social Security Act waivers, Medicare Advantage, private health insurance plans, and other service purchasers that:
    - i.The total costs of all hospital serviced offered by or through a facility are reasonable such that all purchasers shall pay for services only as set forth herein;
    - ii.The aggregate rates of the facility are reasonably related to the aggregate costs of the facility; and
    - iii.Rates are set equitably among all purchasers of services without undue discrimination.
  - (B) Assure affordability of health care services; provided that tThe plan shall be developed no later than 2025 and shall be updated annually thereafter; provided further that the plan shall be developed and updated in consultation with the governor, department of budget and finance, Hawaii employer-union health benefits trust fund, and all public and private health plans and providers of health insurance coverage.

SB2285-SD1 offers a pivotal opportunity to move the health care reform narrative beyond resignation and lamenting glaring problems and deficits in having high quality accountable, affordable, equitable, and accessible health care for all in Hawaii to establishing the critical tools and authorities that would actually affect the kind of fundamental changes needed. The requested amendments help to reinforce and strengthen the Legislative resolve to accomplish such change.
