Ms. Davidson is driven by vision, purpose, and the mission of the Family Court and the ICJ, to ensure the best interests of our juveniles are prioritized and not by personal alliance, agendas or self-interests. She oversees the juvenile detention facility and youth shelter, the juvenile probation and status offender units, the Juvenile Drug Court and Girls Court, as well as the special services unit that handles child abuse and neglect cases, the Zero to Three Court, the Permanency Court and Imua Kakou (a program for young adults exiting foster care). Ms. Davidson has a wealth of experience and knowledge in child welfare and juvenile justice, both as a Case Manager for social service organizations, a Juvenile Probation Officer, and Juvenile Probation Officer Field Supervisor. Ms. Davidson was first appointed as the Compact Administrator of the ICJ for the State of Hawai'i in 2020, and under her leadership and management, Hawai'i has and will continue to fulfill its responsibilities to promote public safety, protect the rights of victims, control movement of offenders, provide for effective tracking of offenders, and engage in the supervision and rehabilitation of offenders.

This is the testimony on GM619

I support this bill, and I would like to raise some issues that need to be considered and resolved, as follows:

Remember, the purpose of all government systems is to work for people and to protect the good and the right people. We cannot protect the criminals and the scammers. We cannot protect wrong-doing people.

The bank can take that person's house, business, and all their assets if that person refuses to pay the bank. We must have such strong measures, and then we can end the criminals and social evils occurring across America.

We must arrest those who cause harm to others and be responsible for compensating for the damage they cause. We cannot allow fraud and theft to continue to occur in our country.

I will also establish all legal aid government attorney offices in all states. We will always have lawyers on duty in these offices to help those who need help. We will work for people and

protect the good and the right. We will protect justice. We will regain the people's trust by enforcing the law fairly and justly.

As I said, justice delayed is justice denied. Unfortunately, this often happens to the poor and victims of crime. They may not have the necessary resources to hire a lawyer and fight for their rights. This is when I will establish new humanitarian law offices to gradually help turn their humanitarian work into a masterpiece to help the poor and the victims.

I will establish humanitarian law clinics as beacons of hope for the less fortunate, working selflessly to empower the poor and victims of crime. These offices provide legal services to people who cannot afford them. Their goal is to ensure that everyone has access to justice and fair treatment, regardless of their economic circumstances and social status.

I will make sure that government law offices work diligently and fairly to ensure that all citizens have equal and fair access to justice.

These humanitarian law offices will work on a contingency basis, meaning they will only be paid if the case is won. Attorney fees range from 10% to 20% of the total amount of the case.

This is fair compensation for their services, considering the amount of work and resources they expended to win the case. If the lawsuit is unsuccessful or damages cannot be recovered, these offices will waive attorney fees for clients as compensation to the victims.

The work of humanitarian law offices has turned a difficult job into a life's masterpiece. Their dedication to helping the oppressed and fighting for justice is noble.

They represent people in difficult circumstances and are also a good opportunity for them to express themselves, hone their skills to become good lawyers in the future, and give them a voice in social legal issues.

This shows the government's sincerity and willingness to help the poor and oppressed. It shows the level of respect for the law and raises the importance of maintaining it.

This shift towards fairness in the legal system is a testament to the government's commitment to humanity and justice. Recognizing the urgent need for support from humanitarian law clinics, especially for victims of crime, is the first step to strengthening the legal system and empowering those affected. Disadvantaged and persecuted. These noble efforts are inspiring and revitalizing to create a fair and equal society for everyone.

In short, I will be the person who directly operates and manages all these humanitarian law offices and provides full costs and funding for them so that they can work effectively and ethically to protect justice.

Humanitarian law offices play an important role in our society. They bring hope and a sense of security to vulnerable and oppressed people. Their work is an expression of true humanity, changing lives and making the world a better place. Our mission is to support such offices and help those in need of justice and assistance. Importantly, these humanitarian offices will still receive financial support from the government to continue operating and develop sustainably.

Furthermore, all court and lawsuit fees, as well as government agency paperwork costs, will be appraised at fair market value and in accordance with the circumstances. Each person who is sued by another person must pay the court a criminal fee. This is a way for the government to create cash for court staff while also preventing crime.

I also need to stop all crimes and criminals from misbehaving.

The government is to protect the people, not to rob or harm them. There are no government agencies that are responsible for all the bad things that have happened in our country. That is why criminals and corruption have colluded to harm people. From now on, I will be the president, and I will not let such unjust and unreasonable situations continue to happen in our country. I will establish new laws. to protect fairness and integrity for the people. I will hold those who work in government accountable for all their failures and responsibilities in their jobs to ensure that all our people will be properly protected, fair, and just. We will defend good people and defend what is right; we will defend justice for all.

Starting today, anyone who discovers someone's wrongdoings, or anyone who lies to get your money, lies to sign a contract, takes your money and runs away, lies on the website or online, takes your money and doesn't do as they say, then all of you just need to call the police. Immediately, the police will come to the scene and make a report, then arrest all the criminals and put them in jail first, then send the report to the family members to invite them to court, or the lawyers will have to go to court and ask for their release. To resolve all disputes that have occurred immediately, we will resolve all disputes for the people, and we will stop all criminals and fraud businesses immediately. We will not let criminals and fraud businesses be free from doing wrong anymore.

Another issue to which we need to pay attention and fix it. That is how central banks and individual banks operate and manage money. We will have to manage and re-operate the entire banking system through this central and intermediate banking system software to ensure that all information related to the banking system is transmitted through a management system.

We also need to pay attention to them and heal all the wounds in their hearts, so that they can return to a normal life and be helpful to our society.

Patients in mental hospitals and homeless people are victims of the evils of our society today; they are victims, and they really need our help. We need to deal with them conscientiously, not just lock them up in insane asylums like prisoners, which is too unethical and too immoral of the crazy government.

Through today's stories, I hope everyone will wake up and stand up to work with me, so that together we can heal the bleeding wounds of everyone in society.

Together, we will heal the world. Together, we will change the world to be a better place for all of humanity.

Again, I am a victim, and I am also a witness to all the sins and failures of this government's system. Today, I come here to present all the facts clearly and truly, so that we can all accept the truth, change and amend the constitution, and move towards a perfect system of government for everyone.

If you make the law, but you don't follow it according to the law, no one will listen and follow it. Once people no longer respect the law and no longer believe in it, they will stand up for themselves and act on their own instincts.

A real example today is that many Americans are very dissatisfied with the current law, precisely because they do not believe in it. They find the law unfair to them, not protecting them, with no freedom or equality. They are oppressed, exploited, assaulted, attacked, raped, despised, persecuted, abandoned, etc.

And when they brought the lawsuit to the court or government agency, they didn't get help or were rightfully treated, and they lost faith in the government. That's why they can only rely on themselves, that is, to commit suicide or shoot others, steal, kill, drink, gamble, commit crimes and sex assaults, etc.

The time has come for you to realize the errors of your laws and to amend them, to enact strict and just laws, to protect the good people, and to uphold justice, fairness, civility, and transparency in the law.

All bad people, villains, criminals, terrorists, and fraudsters who take property and cause harm to others must go to jail and have to work in prison to compensate for the damage and harm caused

to others. Only such a strict law can punish evil and sinners. It is time for us to appreciate kindness and treat good people well, and evil and sinners must be severely punished.

With regard to training the current generation of young people, in public schools, children from kindergarten to grade 12. All teachers must be retrained in how to raise children. It is to teach our children how to live independently and know how to choose the right and the good to develop according to each person's ability. One of the most important things is to teach them gratitude, first of all to be grateful to God for creating this universe for them to live in and to be grateful for their parents.
