Re: Nomination to the Hawaii Children's Trust fund Advisory Board

It is an honor to be nominated to the Hawaii Children's Trust Fund Advisory Board. Please see my written statement below that addresses your questions:

 I wish to be a member of the Hawaii Children's Trust Fund Advisory Board because I am qualified to do the job. My own life experiences can help guide the board as tough decisions are faced. My time as a Social Worker IV at Child Welfare Service and Department of Health, both in case management positions and as a foster parent, emergency foster parent, legal guardian, and adoptive parent help qualify me in making decisions and asking difficult questions. As a case manager, I was able to get to know individuals, many of whom I still stay in contact with. I understand how having a child with mental health issues and developmental disabilities affect our lives as a parent, teacher, and community.

I have firsthand experience of being a parent (legal guardian) of a child with mental health issues. This experience has given me a clear understanding of the individualized needs of these children who will someday become adults in our communities.

2. I see the role and responsibilities of a member of the Hawaii Children's Trust Fund as attending board meetings, monitoring and assessing the development of the grant application process to ensure that we reach diverse communities and organizations, assisting with the review of grant applications and the selection of funded projects in an impartial and professional manner. Also, supporting the efforts of the Trust Fund whenever called upon, advocating for the Trust Fund, as needed and monitoring funds received by organizations receiving Trust Fund dollars. I also see this role as an advocate for and support of children at risk for abuse and neglect through policy recommendations, advocacy, public awareness, and education.

3. I am qualified for this position because I have compassion and love for children. I also have a bachelors in Sociology, an associate in administration of justice and 21 years of Experience working for the State of Hawaii as a social worker.

I am the Chief Executive Officer of the Island of Hawai'i YMCA and oversee a budget of over \$1,000,000. I am proud to say that since I was appointed to this position in 2018, the YMCA's budget has gone from a deficit to a surplus.

I can manage money, manage staff, and problem solve difficult situations. I am extremely creative and love to do arts and crafts. I have found a new love in cooking.

My decision-making ability goes as far as doing what needs to be done, making tough decisions, and remaining focus on "the bottom line." Sometimes situations need to be explained to individuals in a way that they can understand, using local terms and examples.

I am not an expert in any area; however, I am a functional member of the Hilo community in the State of Hawaii, have experience with the State DHS and DOH systems, and have compassion and love for children at heart. My roots are deep in the community that I was born in, raised my children in and continue to live in. My family has been in Hilo for 5 generations.

- 4. I am not sure what I want to accomplish during my term of service. I do know that I want to do what is best for the children of Hawaii. I do know that each child is a precious gift from God and should not be in any shape or form hurt or damaged by any other living being. I will do my best based on the situations at hand. I will have a better understanding of what I wish to accomplish during my term after I've been able to get my feet wet at the meetings.
- 5. Four qualities that best describe me are creativity, understanding, patience, and fairness. These qualities would benefit the Hawai'i Children's Trust Fund Advisory Board as I have a creative mind, and love to think out of the box or

around the circle. I have an understanding heart and can recognize times to be empathetic and firm at the same time. I am not afraid to ask people to wait, or to ask for clarity, because at times I get confused, especially when issues do not add up correctly. I am patient, sometimes too much so that others get irritated. However, with my patience, I am sure to document and proceed carefully, so that matters are done correctly.

- 6. I am not sure what experience would make me stand out, I like to lay low, but be steadfast. I would like to know all the facts, and then proceed. I received an award for Remarkable Women 2023 by Nextel (KHON) Broadcasting for the State of Hawaii. I received that honor for the work I have been doing for the past 6 years at the Island of Hawaii YMCA. In a nutshell, the Y was on the verge of closing, there were numerous issues, low membership, inconsistencies in finances, employee issues, building issues, programing issues. I worked on one issue at a time, one wall at a time, one employee at a time, with no money. Now, six years later, the Y has 4K members strong, 1900 fitness center members programing for keiki to kupuna and moving strong and plowing forward. We are creating new programs, joining forces with other non-profits, applying for new and innovative programing, and building a bigger and better Y based on the needs of the community. I am proud of my staff and members.
- 7. Yes, I can foresee possible conflicts of interest that could arise during my service on the Hawai'i Children's Trust Fund Advisory Board. I would overcome these conflicts of interest by abstaining from voting or commenting on issues and requests pertaining to the Island of Hawaii YMCA, YMCA Oahu, Maui Family YMCA, and YMCA Kauai.
