# **EXECUTIVE OFFICE ON EARLY LEARNING'S POSITION: Support**

Aloha, I am Yuuko Arikawa-Cross, Director of the Executive Office on Early Learning (EOEL). EOEL supports the nomination and confirmation of Kau'i Burgess to the Early Learning Board (ELB).

EOEL is statutorily responsible for the development and administration of the State's early learning system, which shall ensure a spectrum of high-quality early learning opportunities for children from prenatal care until the time they enter kindergarten, with priority given to underserved or at-risk children.

The ELB was established as a governing board through Act 202, Session Laws of Hawai'i (SLH), Regular Session 2017, and is responsible for directing the EOEL on how best to meet the developmental and educational needs of children from prenatal care to entry into kindergarten; providing recommendations to the EOEL on improving the quality, availability, and coordination of early learning programs; promoting collaboration across agencies and stakeholders serving young children; and appointing and evaluating the EOEL director on an annual basis.

Ms. Burgess retired as the Director of Government Relations at Kamehameha Schools (KS) and served as a leader in KS' operations for a number of years, during which time Ms. Burgess worked to align key stakeholder groups and the community with KS' mission and activities in supporting educational opportunities for children of Hawaiian ancestry across the State.

Ms. Burgess satisfies the requirements of HRS § 302L-1.65, which provides, in relevant part, that the ELB nominees shall demonstrate integrity, civic virtue, and high ethical standards and be willing to hold fellow members to the same; commit to being a conscientious and attentive board member; have an understanding of best practices in early learning governance or be willing to be trained in best practices in early learning governance; and have a clear understanding of the board's role in developing and protecting a clear, long-term strategic vision for early learning.

As demonstrated by her resume, Ms. Burgess possesses a wealth of experience in government relations and legislative advocacy. Her experiences indicate a valuable ability to function among diverse colleagues as a member of an effective team and provides substantial support of her deep and abiding interest in early learning and the support of families and children across Hawai'i.

#### Achievements/Highlights

• COMMUNITY ENGAGEMENT: Over the past three years, I created and convened a hui of more than 30 Native Hawaiian organizations to collectively strategize on legislative issues impacting Native Hawaiians and Hawai'i. We gathered to support the legislative priorities of each organization and submit testimony on issues that impact the lives of Hawai'i's people. Since the establishment of the Native Hawaiian Legislative Hui, we've successfully created joint letters, testimonies and efforts of support that successfully secured and increased funding for Native Hawaiians and Hawai'i, demonstrated the solidarity of the Native Hawaiian organizations, secured consensus of Native Hawaiian serving organizations, supported the leadership of Hawai'i's Congressional Delegation, and spurred positive feedback and hope in the future of our Native Hawaiian community.

- EARLY LEARNING: At the end of 2019 and in the 2020 legislative session, my priority was to
  advocate for a Universal Public Preschool system in Hawai'i. I successfully supported the writing of,
  advocacy for, and enactment of Act 46 collectively with Native Hawaiian serving organizations, business
  leaders and state government leaders.
- EARLY LEARNING FUNDING: In 2022, my priority during the legislative session was to advocate for the enactment of Act 257, which appropriated \$200,000,000 for fiscal year 2022-2023 for the School Facilities Authority (SFA) to expand access to pre-kindergarten to eligible children of the State of Hawai'i, as identified in Act 46. I achieved my goal with the collective help of business and state leaders and the support of members of the Native Hawaiian Legislative Hui.
- STUDENT CIVIC ENGAGEMENT: Our team's goal is to increase civic engagement in Hawai'i and our strategy is to start with the youth. In school year 2019-2020, while other senior students around the nation were coordinating school "walkouts", Kamehameha Schools seniors had a pre-planned fieldtrip to vote and be civically engaged due to the efforts of my team. Because of this effort, Kamehameha Schools' students ended up in CNN's online publication, bringing positive attention to Hawai'i.

Aloha e ka Luna Hoʻomalu Kidani, ka Hope Luna Hoʻomalu Kim, a me nā lālā o ke Kōmike Hoʻonaʻauao o ka ʻAha Kenekoa.

I submit this testimony requesting your support for my nomination to the Early Learning Board.

Hānai i ke keiki, ola ka lāhui (Nurture the children and the people will thrive) is a saying used to clearly demonstrate the priority at Kamehameha Schools, which is where I spent my last 18 years of employment, most recently as the Director of Government Relations. In my opinion, this saying is a very meaningful 'ōlelo no'eau, or Hawaiian proverb, which also defines my belief of what is needed in Hawai'i in order for Hawai'i, and its people, to thrive. Based on what I learned while working at Kamehameha Schools, I strongly believe that if Hawai'i is unified in prioritizing the care and wellbeing of its children, our economy and everyone in the state will thrive.

I am now a retired grandmother of my two-year-old mo'opuna, and I provide her with early learning in my home, where my home now looks like a mini preschool. I am a mother of three adult children. However, when they were 3 and 4 years old, I was a very young mother and wife. We lived in Hilo, and we were struggling to make ends meet. But both my husband and I believed in strongly in early learning for our children, and we sacrificed to put all three of them in preschool. When my oldest went to Haili preschool in Hilo, I was a middle school teacher at Nāwahīokalani'ōpu'u, a Hawaiian language immersion Public Charter School in Kea'au, and my husband worked for the University of Hawai'i at Hilo. We were struggling financially, and it's safe to say that we were one of the ALICE (Asset Limited, Income Constrained, and Employed) households living on Hawai'i at the time. There were nights that we ate PB&J sandwiches or rice and eggs for dinner. I share this as a demonstration of my understanding of the struggle that is required to participate in early learning. And this is one of the reasons I so strongly pushed and lobbied for Act 46 (2020) and Act 257 (2022). I was so passionately involved in each legislative measure to change the system not only because of my own experiences but because of the many, like me, who either must choose between eating well or sending their children to preschool. I don't believe that should be the case for Hawai'i's families. As we know, many are struggling, and some elect to not send their keiki to preschool. Why is this the case? It should not be the situation for young families. Equity in education should never be questioned and our families should never have to choose between education or food. I believe our early learning system can be better in helping to uplift all of Hawai'i. One generation at a time.

My passion for keiki and my love for Hawai'i are the reasons why I'd like to be a member of the ELB. I also believe in Hawai'i's ability to achieve its early learning goals and I know that I can kōkua.

My previous work in systems change through policy, and my work in education can support the EOEL and ultimately the families and keiki of Hawai'i. I will bring with me my experiences in Community Relations, Government Relations, communications, policy, and collaborative work to help advance the goals of the EOEL, specifically the coordination of the early childhood system, which requires collaboration between State departments and leaders for the simplicity of sharing information and data.

I am known as a person who "gets things done," and I'm excited to see the backgrounds of the other nominees who have been selected to serve on the ELB. I believe that in serving with this group, I can bring my passion, skills, experiences and relationships to the board to help achieve the state's goals and advance education and the wellbeing of Hawai'i's people throughout the pae'āina.
