Aloha Chair Gates, Vice-Chair Kahaloa, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

**The Hawai'i Farm Bureau supports HB 1815,** which includes agritourism in the definition of "enterprise" to authorize the Agribusiness Development Corporation to financially support businesses engaged in agritourism.

We strongly support agritourism as it represents an excellent revenue enhancement opportunity for farmers and ranchers as well as an educational opportunity for the public. Fostering the profitability of farmers and ranchers will significantly contribute to the State's goal of increased self-sufficiency.

The Agribusiness Development Corporation (ADC) was initiated by the agricultural industry as sugar and pineapple downsized. It was established to help transition Hawaii's agricultural industry from plantation agriculture to smaller diversified agricultural operations. Transitioning large tracts of monoculture farmland into smaller diversified ag lots and finding and supporting bona fide farmers to work those lands is a long and complex process. ADC has had success developing a productive diversified sector out of former sugar and pineapple lands.

ADC assists farmers and ranchers with land and water issues, regulatory mandates, invasive species, global competition, financing, marketing, and research funding. As the entrepreneurial agricultural arm of the state, ADC should have the authority to support agritourism.

My name is Brandi Corpuz,

I would like to ask you all to vote no on bill 1815 for the following reasons.

As the Executive Director of a 3 island community nonprofit whose mission is to grow food and family together on Maui, Molokai and Oahu we stand in direct opposition of the ADC and their unsustainable agribusiness development. We have worked together with our ohana community towards food sustainability and community advocacy since 2018. We began our organization in Whitmore Village to stop the ADC from destroying our fruit trees and community farms that once surrounded the entire community.

We have fought to stop the excessive pesticide use around our island communities, that is sprayed on a regular basis. We believe that sustainable agriculture should not be in corporate hands, as corporations are not concerned about our aina. Since we are part of our aina, traditional farming and sustainable practices are the only way to assure our future of food sustainability.

ADC stands for Agribusiness Development Corporation. They have proven over the decades that they are not the best stewards for sustainable agriculture lands in Hawaii. They were created to "conserve and convert arable lands and their associated infrastructure that were formerly large mono-crop plantation lands". These mono-crop businesses were corporations too. It seems that ADC did nothing more than lease to new corporations, with new sometimes more dangerous (heavy pesticide use, seed and testing,GMO) mono-crops. These new corporations do not grow sustainable food for us. These new corporations are just like the old ones and the insanity must end.

The entire Whitmore Project created by ADC and supported by Donavan Delacruz was not created to help with Hawaii's food sustainability goals. In fact, it is in direct opposition. ADC seeks to lease to Corporate farmers, create tourist attraction (agrotourism), spend excessive amounts of State funds as in the \$35 million dollar pedestrian bridge (for tourists), a food hub for corporate farmers with tax exempt export of our precious and finite locally grown food supply.

Although ADC may have new leadership, they are still working in the past mindset of "EXPORT" and "TOURISM". Why do we have food security goals if we are only going to import tourism and export our food supply? How are we going to sustain our food supply for us, if our government is only concerned about the mighty dollar?

We have allowed corporations to control our farm lands and most valuable resources for far too long. Hawaii imports 85-90% of our food! We export more than \$100 million dollars of edible food every year. We spend approximately \$3 billion dollars importing food for us to eat? How does this add up? We have some of the most fertile (what hasn't been killed) soils with the longest growing time so our land is highly valuable to exporters around the world. We must stop giving away our valuable resources to the highest bidders.

As your committee is focused on agriculture and food supply, you should be looking to stop the ADC all together, rather than supporting their destructive practices. We could save this state \$3 billion dollars if we stop allowing the export of our food source and demand that the food grown here stays here. Sustainability and security are the key words and you must keep this in mind especially when fulfilling your duty to our shared communities.

Vote no to Bill 1815 and support locally sustainable food production! Vote no to Bill 1815 and create food security for your community and mine. Vote no to Bill 1815 and save \$3 billion for our state by growing our own food. We do not need another tourist attraction, we need a sustainable food supply. Please help to stop the export of our food and our people by voting NO.
