H.B.1936 H.D. 2 RELATING TO HARBOR SAFETY

Senate Committee on Transportation and Culture and Arts

The Hawaii Department of Transportation (HDOT) provides the following **comments** on this measure that requires the department to regulate the labor responsible for manning the mooring lines for certain vessels in state commercial ports.

HDOT considers the effect of the proposed legislation a regulation of labor and not a regulation of facilities. However, the current version of this measure authorizes HDOT to require that the securing of mooring lines from vessels to our facilities be performed by labor subject to collective bargaining. HDOT may ask vessel owners and agents to affirm that this requirement is met, but lacks the resources necessary to investigate or enforce lack of compliance.

Chair Lee and Members of the Committee:

The Department of the Attorney General provides the following comments:

Section 1 of this bill states that the bill's purpose is "to require that the securing of mooring lines from vessels to the State's commercial docks, wharves, piers, quays, and landings be performed by labor subject to collective bargaining." The bill amends chapter 266, Hawaii Revised Statutes, by adding a new part, entitled "Mooring of Vessels to Commercial Docks" (page 1, line 8), that contains a single section titled, "Labor subject to collective bargaining; required", which proposes to mandate the State of Hawaii Department of Transportation to require "that the securing of mooring lines from vessels to commercial docks, wharves, piers, quays, and landings be performed by labor subject to collective bargaining" (page 1, lines 9 to 14). The subject matter expressed in the bill's title is "harbor safety." The content of the bill, however, does not make the connection between the expressed subject, "harbor safety," and the requirement of having mooring lines handled only by labor that is subject to collective bargaining.

Article III, section 14, of the Hawaii State Constitution requires that "[e]ach law shall embrace but one subject, which shall be expressed in its title." The requirement of this section is mandatory, and a violation results in invalid legislation. Schwab v.

Ariyoshi, 58 Haw. 25, 31, 564 P.2d 135, 139 (1977). In Schwab, the Hawaii Supreme Court established the germaneness standard that, as long as all parts of an act

embrace one general subject, and these parts are so connected and related to each other, whether logically or in popular understanding, as to be parts of or germane to that general subject the bill satisfies the one-subject requirement. "[T]he germaneness standard is an established and enforceable standard and one which courts in Hawaii have ably applied to the single subject and subject-in-title requirement for over a century." League of Women Voters of Honolulu v. State of Hawaii, 150 Haw. 182, 200, 499 P.3d 382, 400 (2021).

In applying the germaneness standard, the content of the bill does not make the connection between the subject matter, "harbor safety," expressed in the bill's title, and the content of the bill that requires that securing of mooring lines be performed only by labor that is subject to collective bargaining.

We recommend that section 1 of the bill be amended to explain how the requirement of securing of mooring lines only by labor that is subject to collective bargaining is germane to the subject matter, harbor safety, as expressed in the bill's title.

We respectfully request the Committee to address the constitutional requirement discussed above.

My name is Max Lindsey, 2023 Government Relations Committee Chair of the Building Industry Association of Hawaii (BIA-Hawaii). Chartered in 1955, the Building Industry Association of Hawaii is a professional trade organization affiliated with the National Association of Home Builders, representing the building industry and its associates. BIA-Hawaii takes a leadership role in unifying and promoting the interests of the industry to enhance the quality of life for the people of Hawaii. Our members build the communities we all call home.

BIA-Hawaii offers the following comments regarding HB 1936, Relating to Harbor Safety. This bill would require that the securing of mooring lines from vessels requiring tug assistance to commercial docks, wharves, piers, quays, and landings be performed by a stevedoring company, defines "stevedoring company", exempts, under certain circumstances, vessels operating on behalf of an authorized intrastate or transpacific water property carrier holding a certificate of public convenience and necessity issued under section 271G-10, HRS.

BIA Hawaii is concerned about the possible unintended consequence of this bill raising the cost of housing in Hawaii. Adding an additional layer of cost onto shipping would raise the cost of building materials, which could in turn further raise the already-high cost of construction.

The state of Hawaii is in a dire housing crisis. As the Legislature is aware, the cost of housing in Hawaii is extremely high, and out of touch for many kama`aina. Approximately 153,967 U.S. households are priced out of buying a home for every \$1000 increase in price, according to the National Association of Home Builders (NAHB).

Senator Chris Lee, Chairman, Senator Loranine Inouye, Vice Chair, and Members of the Committee:

I am testifying in opposition to House Bill 1936 House Draft 2 (HB1936 HD2) "Relating to Harbor Safety" on the basis that it is an unnecessary and unconstitutional government intervention into the collective bargaining relationship between employers and employees in the private sector.

The Hawaii Shippers' Council (HSC) is a business league organization representing merchant cargo owners known in law and the transportation industry as "shippers" (as opposed to those who carry the cargo including water, ocean, air, truck, pipeline and rail carriers).

The House Committee on Consumer Protection & Commerce (CPC) heard HB1936 HD1 on February 27, 2024 and completely removed and replaced its text. This wholly new version of the bill crossed over to the Senate as HB1936 HD2 and is being heard by your committee today.

The current text of HB1936 HD2 is seemingly innocuous in that it mandates the obvious, declaring in Section 2 the Hawaii State Department of Transportation (HDOT) ". . . shall require that the securing of mooring lines from vessels . . . be performed by labor subject to collective bargaining." However, as all private sector employment in the U.S. has been subject to collective bargaining under federal law since 1935, 1 this is not a revelatory nor particularly useful legislative proposal. It may also be unconstitutional.

In regards to the constitutionality of the instant legislative proposal, the Illinois Policy Institute wrote in 2022 about an analogous situation: ²

The state [of Illinois] is not allowed to provide unionization or collective bargaining rights to workers in the private sector because the federal government has already done so through the National Labor Relations Act [NLRA]. Whenever the federal government regulates something, states can't also try to regulate the same thing. Doing so runs afoul of the Supremacy Clause of the U.S. Constitution.

In their opinion, the Institute cited a 1986 U.S. Supreme Court decision which held, "The NLRA preempts the Wisconsin [state] . . . statute."

The constitutional issue of preemption⁴ seems to be anticipated by HB1936 HD2:

Section 3. The provisions of this Act shall be enforced to the extent they are not held to conflict with any federal or state constitutional provision, law, rule, or regulation.

This begs the question: Why enact a state statute that is understood in advance to be preempted by federal law under the supremacy clause (Article VI, Paragraph 2)⁵ of the U.S. Constitution?

There is also the issue of enforcement. HB1936 HD2, Section 2 would require the HDOT – as delegated to its subsidiary agency, the Harbors Division – to enforce the proposed collective bargaining requirement for the securing of mooring lines (also known as "line-handling").

The Hawaii State Harbors Division does not currently possess the regulatory facility to implement this requirement because it functions only as a "landlord port," which is described as follows:⁶

As a landlord, a port authority manages the port assets under its jurisdiction. This commonly concerns the provision of infrastructure such as piers and the dredging of waterways.

The landlord port status of the Hawaii State Harbors Division is different than a port authority that functions additionally as a regulator, and even more involved as an operator, of port services such as terminal, stevedoring, line-handling, tug assistance and pilotage.

It's not reasonable to impose the additional role of services regulator on the Harbors Division for the sole purpose of enforcing an unneeded and potentially unconstitutional statutory requirement covering a relatively small portion of overall maritime activity in the state's commercial harbors.

For the foregoing reasons, among others applicable to previous versions, HB1936 HD2 and its Senate companion should not be passed by the Hawaii State Legislature.

Chair Lee, Vice Chair Inouye, and members of the committee,

Hawaii Gas offers comments on HB 1936 HD2 which requires the Department of Transportation to require that the securing of mooring lines from vessels to commercial docks, wharves, piers, quays, and landings be performed by labor subject to collective bargaining.

Since 1904, Hawaii Gas has been a pioneer in the gas industry. Hawaii Gas is again at the leading edge of our industry given our integration of both renewable natural gas (RNG) and hydrogen into our fuel supply mix and distributing it through our utility pipeline system. We appreciate the amendments made by the previous committee and incorporated into the HD2 version which addresses our earlier concerns that this bill would create additional costs and cause unnecessary delays of critical energy resources to our customers.
