# SUBJECT: HB1976 HD1 RELATING TO THE OFFICE OF ELECTIONS

The Hawaii State Council on Developmental Disabilities **SUPPORTS HB1976 HD1**, which requires the Office of Elections to annually request funding for the Statewide Elections Accessibility Needs Advisory Committee. Appropriates funds to the Office of Elections Statewide Elections Accessibility Needs Advisory Committee to gather information and provide outreach and voter education services for individuals with accessibility needs.

The committee is under the State Office of Elections however, there was no funding designated for the committee's use or control. Without funding, they cannot be proactive in increasing the accessibility for voters with disabilities through the entire voting process, from registration through casting ballots.

The Americans with Disabilities Act (ADA) requires state and local governments and their election officials to ensure that people with disabilities have a full and equal opportunity to vote in all elections. This includes federal, state, and local elections. And it includes all parts of voting, like voter registration, selecting a location for polling places, and voting, whether on election day or during an early or absentee voting process. We appreciate the creation of the Statewide Elections Accessibility Needs Advisory Committee, to meet this ADA requirement. By funding the Statewide Elections Accessibility Needs Advisory Committee, will help our state toward compliance of this ADA requirement.

Thank you for the opportunity to submit testimony in **support of HB1976 HD1**.

**DEPARTMENT'S POSITION**: The Department of Human Services (DHS) appreciates the measure's intent and provides comments. DHS defers to the Office of Elections on the implementation of this measure and respectfully requests that the appropriation not replace or reduce budget priorities identified in the executive budget.

**PURPOSE:** This bill requires the Office of Elections to annually request funding for the Statewide Elections Accessibility Needs Advisory Committee. Appropriates funds to the Office of Elections Statewide Elections Accessibility Needs Advisory Committee to gather information and provide outreach and voter education services for individuals with accessibility needs. Effective 7/1/3000. (HD1)

The Committee on Judiciary and Hawaiian Affairs (HD1) amended the measure by:

- Codifying the requirement that the Office of Elections annually request funding for the Statewide Elections Accessibility Needs Advisory Committee in the Hawaii Revised Statutes;
- (2) Changing the effective date to July 1, 3000, to encourage further discussion; and
- (3) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

DHS recognizes the importance of promoting greater participation in voting by individuals with access needs who may otherwise be excluded, including the removal of barriers for persons with voting accessibility needs to ensure that all individuals have equal access to the voting process. DHS supports the intent of this measure to fund the Advisory Committee's activities.

Testimony of James Gashel Joint hearing: Committee on Judiciary (JDC), and Committee on Health and Human Services (HHS) Hawaii State Senate Thirty-second Legislature, regular session of 2024 March 19, 2024, 9:55 AM, hearing on HB1976 H.D. 1

Aloha chairs, vice chairs, and members. I am James Gashel, Vice Chair of the Statewide Elections Accessibility Needs Advisory Committee, proudly supporting HB1976 H.D. 1, which you last considered as SB2752 on February 8. Thank you for scheduling this hearing.

The purposes of HB1976 as amended in H.D. 1 are to:

(1) Require the Office of Elections to annually request funding for the Statewide Elections Accessibility Needs Advisory Committee; and

(2) Appropriate funds to the Office of Elections for the Statewide Elections Accessibility Needs Advisory Committee to carry out its mandate.

The legislature created the Statewide Elections Accessibility Needs Advisory Committee and comparable county committees as enacted in sections 11-10.5 and 11-10.6, Hawaii Revised Statutes, passed in 2021.

These committees are to advise election offices on barriers to access for persons with disabilities and ways to remove them. The goal is to promote greater participation in voting by persons with access needs who may otherwise be overlooked.

Federal law, called the Help America Vote Act, says voters with disabilities, such as blindness, have the right to vote privately and independently. Hawaii is a vote by mail state, so ballots are sent out in standard print to everyone. Being blind, how can I vote privately and independently if I just get a ballot in standard print? It's questions like this that our statewide committee helps the Office of Elections to understand and address.

Our statewide accessibility needs advisory committee has the challenge of being in touch with voters with disabilities in all parts of the state, including on the neighbor islands, where voter service centers, formerly polling places, are few and far between. This lack of polling places presents unique challenges to some voters with access needs.

Therefore, the Statewide Committee is really the voice of voters with disabilities, expected to play a crucial role in ensuring that persons with accessibility needs have equal access to participate fully in the voting process. To support this work, HB1976 H.D. 1 seeks a modest appropriation for information gathering, outreach, and voter education activities conducted by the statewide committee.

The Committee recommends \$10,000 to be appropriated in fiscal year 2024-2025 for this purpose. This appropriation will serve as a critical step towards achieving greater inclusivity for citizens with voting accessibility needs in the electoral process, aligning with the principles of equal representation and access to the democratic rights of all citizens.

If approved, the appropriation sought in HB1976 H.D. 1 will be dedicated for exclusive use by the Statewide Elections accessibility needs advisory committee, not intended to be a general increase in the Office of Elections baseline budget. Information gathering, outreach, and voter education activities, focusing on accessibility needs will have particular importance as we prepare for the 2024 fall election and find better ways to meet accessibility needs in the future.

Please move this bill forward to affirm the value of this statewide committee's work. Mahalo for your consideration.

I am writing as Chair of the Statewide Elections Accessibility Needs Advisory Committee. I greatly appreciate your holding this hearing on HB 1976, HD1.

The purpose of this legislation is to appropriate funds to the Office of Elections to be used exclusively by the Statewide Elections Accessibility Needs Advisory Committee in carrying out its duties. In 2021, as you know, Chairman Rhoads introduced this legislation to create the Statewide Elections Accessibility Needs Advisory Committee and comparable county committees. The Governor signed it into law.

The Statewide Committee, the voice of voters with disabilities, is expected to play a crucial role in ensuring that persons with accessibility needs have equal access to participate fully in the voting process. To support this work, HB 1976, HD1 seeks a modest but needed appropriation for information gathering, outreach, and education activities to further the Committee's work.

Especially important to the Committee is facilitating participation by people with disabilities — assisting and supporting registration and voting, including the online options; educating poll workers on how to assist people with disabilities voting in person, including easy and quick access to accessible voting equipment; educating people with disabilities about ballots, including the purpose of charter amendments; preparing materials in accessible formats; and helping the mayors' offices on Maui establish a parallel committee to our Committee. There are functioning county level committees on Oahu and Kauai, an recently the Big Island. Arranging for and conducting these various activities require time, travel, access to expertise, and other resources that come with costs. These costs are beyond what the Office of Elections can absorb with ease in a timely manner. Committee members, at no charge to the state for time, are willing to facilitate and coordinate these activities. Committee members could travel to all island counties to advise and support county committees; oversee drafting of relevant educational materials; work with appropriate organizations to coordinate training, organize volunteers, survey voters with disabilities on their voting experiences this year, and provide feedback to the Legislature and Governor.

We all value informed, invested voters. People with disabilities are a key constituency in the State. Their informed vote and perspectives provide benefits to the state economically and socially in tourism, employment, education, health care, transportation, and more.

In 2021-2022 the Statewide Committee created and conducted a survey of voters with disabilities. I personally financed that. The survey gave a sense of the scope of accessibility needs people with disabilities had experienced and wanted addressed. A modest \$10,000 budget

dedicated to the Committee's work would allow us to tackle these identified needs. Hawaii is at the forefront of states that have formed structures to address election accessibility issues. Through a partial search on the web, other than Hawaii, California may be the only state, with state and county level committees to directly address voting accessibility for persons with disabilities.

Voters with disabilities will value your being a champion on this modest request.

Mahalo for hearing my testimony. My name is Katie Keim, a blind business woman and member of the Statewide Voters with Accessibility Needs Advisory Committee. I am in strong support of HB1976 H.D. 1.

The purpose of HB1976 H.D. 1 is to appropriate funds to be used by the Statewide Voters with Accessibility Needs Advisory Committee in executing its duties as introduced by Senator Rhoades in 2021 and signed into law by the Governor.

Through HB1976 H.D. 1 The Statewide Accessibility Needs Advisory Committee requests a modest, yet much needed appropriation for the fiscal year 2024-2025.

The state office of elections has no budget for the committee's important outreach and education work to be executed.
