

Purpose of Bill:	Appropriates moneys to the Department of Education for the establishment of 3 full-time equivalent (3.0 FTE) Kaiapuni education curriculum specialist II positions and 10 full-time equivalent (10.0 FTE) Kaiapuni classroom teacher positions. Declares that the appropriation exceeds the state general fund expenditure ceiling for 2024-2025.

Department's Position:

Welina me ke aloha e nā lālā o ka 'Aha 'Ōlelo:

Kākoʻo piha ka ʻOihana Hoʻonaʻauao o ke Aupuni Hawaiʻi (ʻOihana) i ka pila HB 2074. He noi kēia no 10 kūlana kumu Kaiapuni hou a me 3 kūlana laekahi hoʻonaʻauao Kaiapuni. Ma nā makahiki he ʻumi i hala iho nei, ua ulu nō ka papahana Kaiapuni ma ka ʻOihana, he ʻaneʻane 1,000 hou aʻe a i 2,374 haumāna e kula ʻia ana ma ka ʻōlelo Hawaiʻi a ua hemo 8 hou kula Kaiapuni a ka ʻOihana a i 22 kula Kaiapuni ma kekahi mau kaiāulu hou aʻe.

The Hawaii State Department of Education (Department) fully supports HB 2074. We are requesting 10 additional Kaiapuni teacher positions and 3 Kaiapuni Educational Specialist positions. In the past decade, the Department's Kaiapuni program enrollment has grown by almost 1,000 students to 2,374 students that are being educated in the medium of the Hawaiian language and 8 new schools in the Department to 22 schools in additional communities.



Growth of HIDOE Kaiapuni Enrollment in the Past Decade

The Kaiapuni program has expanded significantly over the last decade: nearly 60% increase in both the number of Kaiapuni programs and student enrollment. The Kaiapuni program has been expanding in response to student and family demand as well as to provide "reasonable access to a Hawaiian immersion program" as required by the Clarabel case in the State Supreme Court in 2019.

He kōkua nui ka pu'u kālā pekelala a me ka pu'u kālā a ke Kia'āina e kāko'o ai i nā papahana ko'iko'i no ka papahana Kaiapuni i kēia mau makahiki i hala akula. E pau ana kēia mau waihona kālā ma ka hopena o kēia lune i ka wā e pau ai ka makahiki ho'olilo kālā a ka 'Oihana. Ko'iko'i kēia noi kālā 'Aha 'Ōlelo e ho'omau ai i nā papahana e kū nei a me ka ho'oulu 'ana i nā papahana no kēia makahiki kula a'e a ma 'ō aku.

Federal pandemic education funding and the Governor's discretionary funds provided critical support for Kaiapuni program development over the last few years. These funds conclude at the end of this fiscal year. Legislative funding is necessary to sustain existing programs and to expand growing programs for next year and beyond.

The Office of Hawaiian Affairs (OHA) will recommend that the Board of Trustees (BOT) <u>SUPPORTS</u> this House Bill 2074, which appropriates funds to the Department of Education for the establishment of three full-time equivalent (3.0 FTE) curriculum specialist II positions and ten full-time equivalent (10.0 FTE) classroom teacher positions for Ka Papahana Kaiapuni schools.

For Hawaiians, the life of our language, 'Ōlelo Hawai'i, is tied to the health and well-being of our people and culture. I ka 'ōlelo no ke ola, i ka 'ōlelo no ka make is a revered 'Ōlelo No'eau or proverb that translates to "life is in speech/language; death is in speech/language." Ka Papahana Kaiapuni is an important program that both advances the revitalization of our language and educates the next generation of students. Its success supports the health and well-being of Hawaiians, our language and our culture.

Ka Papahana Kaiapuni programming has also been and continues to be integral to the State fulfilling its constitutional obligations. Article X §4 of the Hawai'i State Constitution gives the State the duty to "promote the study of Hawaiian culture, history and language." Further, the Constitution states that the "State shall provide for a Hawaiian education program consisting of language, culture and history in the public schools. The use of community expertise shall be encouraged as a suitable and essential means in furtherance of the Hawaiian education program."

As this bill notes, demand for Hawaiian language immersion education has grown over the past decade despite resources declining. Kaiapuni programming requires professionals who have expertise in multiple disciplines including Hawaiian language and their curriculum area or grade level. OHA supports this bill's appropriations and establishment of a total of 13 positions for Ka Papahana Kaiapuni programming. It is an important step to provide Kaiapuni programs the specialized staffing it needs for its expansion and sustainability.

Accordingly, OHA urges this Committee to **SUPPORT** Ka Papahana Kaiapuni by advancing HB2074. Mahalo nui for the opportunity to testify on this important issue.

Chair Woodson, Vice Chair La Chica, and members of the committee,

The Hawai'i State Teachers Association **supports** HB2074, relating to kaiapuni education. This bill appropriates monies to the Department of Education for the establishment of 3 full-time equivalent (3.0 FTE) kaiapuni education Curriculum Specialist II positions and 10 full-time equivalent (10.0 FTE) kaiapuni classroom teacher positions.

We know that the Hawaiian language is an official language of the State of Hawai'i. As an official state language, the state has an obligation to support the growth and use of Hawaiian. Currently, the state funds 28 kaiapuni (Hawaiian immersion) schools statewide. The state has also made a promise to increase access to Hawaiian language to all keiki in Hawai'i.

Although promises have been made and documented, the state still has failed to create a sustainable, measurable plan to expand the Hawaiian language to all our students. Although we have 28 kaiapuni schools in Hawai'i, only 15 of these schools have a pipeline to graduation. In addition, at most, only 39 English medium schools offer Hawaiian as a world language.

It is imperative to grow our own Hawaiian language speakers throughout the state so that there is a consistent pipeline of Hawaiian language speakers. These native speakers will be able to fill the critical shortage areas where the Hawaiian language is being taught.

To ensure that 'olelo Hawai'i is never endangered again and those opportunities to learn the Hawaiian language are available for all keiki in Hawai'i, the Hawai'i State Teachers Association asks your committee to **support** this bill.

My name is Andrea Dias-Machado. I am the Hope Pelekikena (Vice President) of Hui Mākua o Kapolei, the parent group of Ke Kula Kaiapuni o Kapolei. I am also the alaka'i, leader, of the EAducation 'Ewa Moku Hui Mākua, the parent group that engaged the community and the HIDOE to establish Kapolei in order to address the lack of access to secondary Hawaiian Immersion Education in the 'Ewa Moku. Kapolei enrolled its first 7th-grade class of 7 students this school year. We will add a second grade level next year in an laser-focused effort to achieve our vision and goal of building a self-contained K-12 kula kaiapuni in the 'Ewa Moku within 5 years.

I am testifying in STRONG SUPPORT of HB 2074 - Relating to Education because it will:

- A Pathway to Hawaiian Immersion Access, Equity and Accountability: This bill will ensure equitable access to resources and education specifically for Hawaiian immersion education on all islands in Hawai'i's public schools, and uphold guidelines set forth in BOE policy 105-8. This bill will also ensure that the State upholds both its constitutional responsibility to Article X, Section 4, and Article XV, Section 4 of the Hawaii State Constitution (1978) and the Clarabal decision where the Hawai'i Supreme Court found that the State is also constitutionally required to make all reasonable efforts to provide reasonable access to Hawaiian immersion education.
- Addressing the Exponential Need and Demand for Hawaiian Immersion Education across the Pae'āina: There has been an increase of 8 kaiapuni schools in the last 10 years. The last 10 years has also witnessed an enrollment increase of almost 1,000 students. In recent years, a significant number of families wanting to register their children in a kula kaiapuni nearest to them have been turned away by the DOE due to a a lack of qualified Hawaiian Immersion teachers available as well as classroom space.

In conclusion, there is a clear and compelling case that the kaiapuni model of education needs to be scaled to meet the growing number of families that are choosing this medium of learning.

My name is K Puaokamele Dizon. I am a Special Education Hawaiian-Immmersion public school teacher on Maui, a parent to Hawaiian-immersion public school students, and an elected representative of Aha Kauleo.

I am testifying in STRONG SUPPORT of HB 2074 - Relating to Kaiapuni Education.

Though it is wonderful to see, enrollment in Hawaiian-immersion is rising rapidly and stretching the resources we have to facilitate these numbers in alarming ways. For example, my daughter's third grade class has 27 students with several of them having different abilities requiring accommodations and/or specialized instruction. Though her kumu is exceptional, it is difficult to ensure adequate education under these conditions. Our school is one seeking a DOE/OHE funded position in order to alleviate conditions like these happening across the school.

I hold that the state has a consitutionally mandated obligation to support Hawaiian-immersion education under Article X, Section 4 of the Hawaii State Consitution. The State of Hawaii has historically upheld legislation, such as The Republic of Hawai'i's Act 57 passed in 1896, intended to exterminate the native language of this land, the Hawaiian language, which was nearly successful. Therefore, the State has a responsibility to do everything it can to reverse that damage. It has an opportunity to remedy this damage through HB2074, which will fund more Hawaiian-immersion teaching and curriculum specialist positions that the program sorely needs.

In conclusion, due to the increase of students in Hawaiian-immersion causing our schools to be overburdened, and due to the constitutional obligation of the State to further Hawaiian education, I support this bill and I urge the committe to PASS HB 2074.

My name is Leimomi Ka'aihili Leong and I am kaiapuni parent, HSTA active member, kaiapuni & SPED teacher at Ke Kula Kaiapuni 'o Ānuenue, and a member of 'Aha Kauleo. I am testifying in **STRONG SUPPORT of HB 2074** - *Relating to Education*.

The Department of Education has **two educational pathways**, English medium and Hawaiian medium. Kaiapuni (Hawaiian immersion) is not a program outside of the department's educational responsibilities. This bill will be a start to **equitable access to resources and education** for the Hawaiian medium educational pathway on all islands and to **uphold Board of Education policy 105-8**.

By supporting this bill you will ensure that the **State upholds its constitutional responsibility to Article X, Section 4, and Article XV, Section 4 of the Hawaii State Constitution (1978).**

The department has not done its due diligence in equitable access by **funding** 35 positions across the state for 22 schools which **has not changed in over 10 years.** It is clear that the community demand for kaiapuni education is increasing. <u>Student enrollment has increased by almost 1,000 students</u> in the past 10 years but there has <u>not been an increase in resources</u>. This is not for Hawaiian keiki only, <u>students enrolled are of all ethnicities</u>. There is actually a greater demand than 1,000 students because many families are denied access to Hawaiian medium education.

Although 8 new schools have opened in the past 10 years, more communities are trying to open in their community and have licensed teachers (Such as Keonepoko Elementary) but the DOE has not responded to the educational rights of the community. The DOE also does not provide access to kaiapuni on the entire island of Kaua'i along with 6 other complex areas across the state.

In conclusion, I urge the committee to please <u>PASS HB 2074</u> to uphold the State Constitution, Board of Education Policy, and support the DOE strategic plan of increasing Hawaiian education in both English and Hawaiian medium pathways.

Aloha mai e na poo a me na lala o ka Aha Olelo,

My name is Keonilei Lealiifano and I am a parent of 2 current Kaiapuni students, and have 2 more children who will enter next school year. I am also former resource teacher at Kaiapuni and have close relations who are current Kaiapuni faculty.

I am testifying in STRONG SUPPORT of HB 2074 - Relating to Kaiapuni Education.

There's a large amount of families wanting to choose Kaiapuni schools evident in the demand for more schools opening, 9 new schools in just under 10 years, with an increase of 1,000 students and their families that the Kaiapuni system supports. Our family is one of those families.

Even with increased placements for students, people are still being turned away.We recently returned to live in Hawaii and I dreamed of having my children learn and speak their mother tongue. We were living overseas in New Zealand where there was no Hawaiian education available. It has been a true blessing to have my children attend Kaiapuni, but I know just how lucky we were to get a space for them. I have 2 more keiki who will be entering school soon, and I want to ensure that there is space for them as well.

Currently, only 35 teachers are funded for over 22 schools across the state of Hawaii. With 1 island still without funding for Kaiapuni education. This bill will address the dire need for funding to increase teaching and special resource faculty. My sister is a FTE Kaiapuni teacher in Maui, with the recent wildfires there, their schools have had to pivot and make so many adjustments to their delivery and care for students. I'm immensely proud of the particular way Kaiapuni teachers and staff have welcomed, sheltered, protected and cared for the children and families impacted by the fire. We need more Kaiapuni teachers to meet the needs of the community.

The state of Hawaii has 2 official languages, and therefore rightly so, public education has 2 pathways, English and Hawaiian. Both have equal standing in importance and legality in our state constitution and therefore, we should see more representation of Hawaiian education on the BOE with secure seats for Kaiapuni representation. This secures Hawaiian education within the BOE's objectives and commitments. Let's make our state successful by meeting the needs of our diverse and distinct community.

This bill, SB2064 will ensure that the State upholds its constitutional responsibility to Article X, Section 4, and Article XV, Section 4 of the Hawaii State Constitution (1978), ensuring equitable access to resources and education specifically for Hawaiian immersion education on all islands in Hawai'i's public schools, and uphold guidelines set forth in BOE policy 105-8.

In conclusion, I strongly support SB2074, and feel the state needs to pass this to ensure constitutional requirements of the needs of the state of Hawaii's Hawaiian education community which is undeniably growing in number and support.

My name is Briann Piliana Starkey and I am a Hawaiian Immersion Special Education teacher at Kula Kaiapuni o Kualapuu on Molokai. I am a supporter and have attended 'Aha Kauleo Meetings representing my Papahana Kaiapuni on the island of Moloka'i. However, I am testifying as an individual.

I am testifying in STRONG SUPPORT of HB 2074 - Relating to Kaiapuni Education.

It is for these reasons for my support, first, to ensure equitable access to resources and education specifically for Hawaiian immersion education on all islands in Hawai'i's public schools, and uphold guidelines set forth in BOE policy 105-8. Currently I am employed at the only Public Charter School on Molokai and am fortunate that the school I work at is supported currently with 7 Kaiapuni positions and a Curriculum Coordinator. In general, we are all aware of how hard, tiring and somewhat frustrating it is for teachers like myself to work day in and day out for our students. Now to plan, prepare and create units and lessons in another language where our resources are limited; finding the time to do this to students ages 5-12, who are learning a second language and then go home daily; switch hats to become a mom, a wife, a daughter, a college student and then repeat for 5 days of the week. Having Curriculum Coordinator/Specialist positions in our DOE Public Schools will reduce the extra time that our teachers put in to create lessons and curriculum so all they have to do is what they do best: TEACH. Often times, our teachers are found defeated, unmotivated and worn out because of the 'extra' that they put out for our keiki. With this position of the Curriculum specialist, it will be able to support our DOE Public School Kumu colleagues with all the current responsibilities they have on top of teaching equitably. As a Charter school, sure, we are fortunate to have these positions, but what about the equitability of ALL Kaiapuni Teachers at ALL Kaiapuni Schools, regardless if we are a Charter or a DOE school. We are all teaching and working as hard for all of our haumana.

Secondly, some of our start up Charter School and DOE Kaiapuni schools are lacking teaching positions. With the increased interest in our Native State language of 'Ōlelo Hawai'i, some or our schools are having to combine grades with already a class size of more than 20 students in one grade. Therefore, combining grades with more than 26 students is not good as it makes it difficult to concentrate on Core Curriculum grade level standards. It also makes it hard for new language learners to learn and communicate in their native language. It also violates our teaching ARTICLE VI, A-6. Teacher to student ratio is 15:1.

In conclusion I am testifying in STRONG SUPPORT of HB 2074 for more teacher positions and more Curriculum Specialist postions to ensure equality among ALL teachers at ALL schools.

TESTIMONY IN STRONG SUPPORT

Thank you for scheduling this measure, HB2074 to be heard. Nā Leo Kākoʻo o Oʻahu, the family organization that exists to promote the educational activities of Ke Kula Kaiapuni 'o Ānuenue, is in **strong support.**

Our keiki attend Ke Kula Kaiapuni 'o Ānuenue, the kula kaiapuni nestled in the back of Pālolo Valley. Po'okumu Babā Yim and the Kumu (teachers) and Limahana (staff) of this kula are uniquely qualified - having knowledge and expertise in both K-12 educational principles as well as fluency in 'Ōlelo Hawai'i. Through our networks of likeminded 'ohana, we know the commitment to ensure our youth have access to high quality education in their native tongue is one that many families have, yet accessing student seats within kula kaiapuni are limited. There are far fewer seats than interested students.

To address the lack of access to secondary education in the 'Ewa Moku, a group of mākua (parents) engaged the community and the DOE to establish Ke Kula Kaiapuni o Kapolei, a satellite site of Ānuenue based at Kapolei Middle School. Kapolei enrolled its first 7th-grade class of 7 students this school year. As an established K-12 kula kaiapuni, Ānuenue is providing critical programmatic and administrative support to Kapolei to build its capacity to transition into its own school. Thus, our kula acknowledges that the educational needs and goals of our haumāna (students) and 'ohana (family) are best served within the communities they come from.

Presently, we still feel the urgent need for more regional kula kaiapuni options. Even with Ke Kula Kaiapuni o Kapolei, 'ohana from across O'ahu send their keiki on buses for hours every day to attend school at Ke Kula Kaiapuni 'o Ānuenue. While we remain grateful for the community that our kula kaiapuni provides, and the access to high quality education that the Kumu at Ke Kula Kaiapuni 'o Ānuenue deliver; we see that the demand for kula kaiapuni education is overflowing.

In recognition, this bill comes at the perfect time. Expanding educational resources for Kaiapuni programs, including new programs/site, new FTEs for teacher positions, and classroom materials and equipment are desperately needed. In addition, the curriculum specialists will promote the Kaiapuni pedagogy training, curriculum development, support teacher professional growth, and result in an increase in qualifications of teacher candidates.

My name is Lauren Kikukawa and I am a former parent of Hawaiian immersion keiki, former kumu, and a strong supporter of Hawaiian language and culture in all of our schools in Hawai'i. I am testifying in STRONG SUPPORT of HB2284 HD1 - Relating to Equitable Distribution of Grow Our Own Resources for Hawaiian Immersion Teachers.

With approximately 50 kaiapuni teacher vacancies across the state for the start of school year 2021-2022 and approximately 60 kaiapuni teacher vacancies for school year 2022-2023 (HIDOE

TATP, 2022) and the rising enrollment of kaiapuni haumāna, we need to allocate moneys for curriculum coordinators and additional kumu to be able to provide quality educational opportunities for our keiki.

This bill requests equitable distribution of an already committed funding resource. We are not asking for an additional budget, but simply equitable distribution of these existing resources for Hawaiian language immersion teachers to meet the critical need and shore up the teacher shortage.

The United States Department of Education has identified Hawaiian language and Hawaiian language immersion (HLI) as Federal Teacher Shortage areas (Hawai'i Superintendent, 2019). This Federal designation, recognized by the State, demonstrates that there is a critical need to increase stakeholder access to Hawaiian language and pedagogical content courses, which will increase Hawaiian language fluency at both the pre-service and in-service levels.

In conclusion we need to support our keiki and the future of our lāhui by ensuring there is funding to hire highly qualified kumu for our kaiapuni schools. If Hawaiian language is one of our official languages, we should be supporting programs like kaiapuni and ensuring that they have the resources they need to be successful!

Mai ka lā hiki mai a ke komohana, mai ka moa'e aheahe a nā kona, aloha e nā hoa o nā kūkulu 'ehā o ke ao! My name is Wendy Akioka, also known as Kumu Kalae in my community. My son graduated from a kaiapuni school, my daughter attends my school, Ke Kula Kaiapuni o Kailua, and my husband teaches at a kaiapuni school, Pū'ōhala. I am also an active member of the 'Aha Kauleo and the chair of the Hawaiian Education Committee for the HSTA. Needless to say, kaiapuni is a part of our 'ohana and lifestyle.

I can provide a unique perspective, because I have worked in many capacities of the education system, from high school Hawaiian language teacher, to elementary kaiapuni teacher, to OHE resource teacher, to Early College Coordinator for kaiapuni under a grant a Windward Community College, back to high school kaiapuni teacher. I understand this system from various, unique perspectives.

I am testifying in STRONG SUPPORT of HB2074 - Relating to Kaiapuni.

This is because there is a desperate need for these positions. HB2074 asks for three curriculum specialists. When I worked at the HIDOE's Office of Hawaiia Education (OHE), where these positions would be housed, the task of creating curricula for the entire kaiapuni program seemed insurmountable. I worked on it myself, but one person is not enough. Two people are not enough. In fact, I might argue that three people are not enough. If you take any classroom textbook and look at the credits, there are 10-15 people working for years to produce that one textbook. Now, imagine needing to create comprehensive, rigorous, and appropriate curricula for all subject areas for K-12 grade levels. People often ask why kaiapuni has been around for nearly 30 years, yet no curricula has been created and I often respond, when has there been a team 10-15 people employed for just that - to create curricula? NEVER! All the resources we have are from full-time teachers creating curriculum on their own time, or from 25 year old grant-work, mostly translations. Some of us still use that, because it is what we have! However, our students should have equitable access to cutting edge technology and modern curricula, just as their counterparts do in the English language pathways.

Regarding the ten teaching positions, I admit that this affects me directly. Ke Kula Kaiapuni o Kailua began nearly three years ago out of thin air. My former principal, Stacey Oshio, agreed to make it happen when asked by Phyllis Unebasami, then I came in and voila! We had a program. The importance of a program like mine to its community is to provide a Hawaiian language pathway for all who value our host culture. Unique to Kailua, I provide a continues pathway in 'ōlelo Hawai'i for the second largest population of Native Hawaiians on O'ahu, that is for the Ko'olau Poko area. It was only made possible because of the existing teacher positions from OHE, which were designated for kaiapuni by the legislature in the 1990s to early 2000s. At that time, Hawaiian language immersion programs were in jeopardy due to low numbers. Each school was given 2 positions for elementary, one for middle school, and 2 for high school. Since then, the program has nearly doubled in size, however the number of positions has stayed the same. What happens now is that larger kaiapuni schools give up their positions in order to make room for new programs like mine. The increase in 10 positions would ensure that I do not have to take from someone else to exist.

In conclusion, I am testifying in STRONG SUPPORT of HB2074 - Relating to Education.

My name is Ka'iulani Iaea I am a seventeen year old student at Hālau Kū Māna. I am testifying in STRONG SUPPORT of HB 2074. In support of this bill I as a student still know the lack of appropriate funding to support a kaiapuni kula. Although Hālau Kū Māna is not a Kaiapuni School I understand the importance of 'olelo Hawai'i being present in Hawai'i youths Education. Currently the Department of Education only helps fund 35 teaching positions for the whole state for 22 kaiapuni schools. That means there is funding for two teacher positions per each school for 22 schools. With this the growth of kaiapuni schools have grown significantly by almost 1,000 in the past decade. Where are the fundings to help these small schools grow? Why is each of these kaiapuni schools forced to find their own funding to hire their teachers. With the lack of supply these schools need they can only accept a small amount of keiki for each class. The fight for equality on fundings for a kaiapuni school is a constant battle Kanaka face, even though 'olelo Hawai'i is a legal language of the state. People should be able to access the kinds of education they want for their keiki. Without being turned down or waitlisted due to the lack of teachers to teach and classrooms for kids. I got the privilege to attend a Hawaiian Focused Charter school that is highly infused with 'olelo Hawai'i and I can testify that learning and knowing the language is a gateway to our culture . HB 2074 is something that us Hawaiians need for us to further the existence of the Hawaiian language an official language of the State of Hawai'i.

Aloha, 'O Ka'imipono Inofinada ko'u inoa, No Kalihi mai au. He 'umikumāhiku o'u makahiki, he haumāna au o Hālau Kū Māna. My name is Ka'imipono, I am seventeen years old and I have attended Hālau Kū Māna, a Hawaiian-culture focused Public Charter School, since 2019. I am writing this testimony to testify in strong support of HB 2074.

Regarding this bill, I support it due to my experience with Hawaiian based education and the difference it has between DOE schools and schools like Hālau Kū Māna and Ānuenue. While I have some experience attending kaiapuni schools in summer before completely transitioning my education to a Hawaiian-based school in 2019, I have attended past DOE schools also. As from my experience with Hawaiian Studies classes in these schools, I noticed that these kumus and classes were highly disrespected by students from the DOE. Under this education, I learned little about my culture, history and identity. However, after experiencing kaiapuni schools, in less than a year I have learned so much more about myself from a Hawaiian perspective due to the learning environment I was in than I had under DOE schools. Hence, it was only due to my kumus and school that I was able to become who I am now and converse with other students and speakers under 'Ōlelo Hawai'i.

While I am thankful for being enrolled in a Hawaiian-based educational school, I know students who attend kaiapuni schools such as Ānuenue in Palolo who have to wake up in the early morning to drive from Wai'anae everyday to be able to attend such schools. This is unfair to the community, as having to drive 32 miles everyday to learn in a kaiapuni environment. Not to mention, while there is a higher demand for kaiapuni schools, there aren't enough kumus and classroom space to support students, especially since the DOE only funds 35 teacher positions across the state for 22 schools and there are still 6 complex areas including 1 island that the DOE is not providing access to kaiapuni education.

With the passing of HB 2074 in the legislative system, this would potentially change Hawaiian education and properly support kaiapuni schools through the proper funding and resources needed, as due to the increase of 8 kaiapuni schools and an increase of students by nearly 1,000 in the last 10 years, there is an obvious revitalization of Hawaiian culture and identity through education. By funding this revitalization of language, children of the future could change Hawai'i for the better.
