Chair Tarnas and Members of the Committee:

My name is Sheena Choy, and I am the Executive Officer of the Board of Professional Engineers, Architects, Surveyors, and Landscape Architects (Board). The Board appreciates the intent of this bill and offers comments.

The purpose of this bill is to establish a twenty-year statute of repose for land surveyors, after which time a complaint cannot be made.

I would like to bring to the Committee's attention Hawaii Revised Statutes (HRS) section 436B-22, which allows the Board to discipline a licensee regardless of the status of the license. HRS section 436B-22, states:

The forfeiture, nonrenewal, surrender, or voluntary relinquishment of a license by a licensee shall not bar jurisdiction by the licensing authority to proceed with any investigation, action, or proceeding to revoke, suspend, condition, or limit the licensee's license or fine the licensee.

It appears that the proposed change would narrow the Board's ability to protect the health, safety, and welfare of the public.
