# In Support H.B. No. 2430, HD2, Relating to Summer Electronic Benefits Transfer for Children Program

Chair Dela Cruz, Vice Chair Moriwaki, and Members of the Senate Committee on Ways and Means:

The Office of the Governor supports H.B. No. 2430, HD2, Relating to Summer Electronic Benefits Transfer for Children Program. This bill would establish the Summer Electronic Benefits Transfer for Children (Summer EBT) Program in Hawaii. Hawaii has opted into the program beginning this summer, and this bill will help the Department of Human Services develop and implement this new program, including providing DHS with additional funding to meet the federal program's required 50/50 match for administrative funds of roughly \$2 million.

Passed into law by Congress and administered by the U.S. Department of Agriculture (USDA), the Summer EBT program will address food insecurities by providing families with financial support during the summer to buy food at grocery stores, farmers market or other authorized retailers, similar to how SNAP benefits are used. The Summer EBT program is intended to support children who lose access to free and reduced price meals through the National School Lunch Program and School Breakfast Program during the summer when school is not in session.

It was recently announced that beginning in the summer of 2024, Hawaii families will receive \$177 per eligible child through the Summer EBT program in order to provide more equitable resources for island communities compared to the benefit amount of \$120 per eligible children in the U.S. mainland.

According to the USDA, the Summer EBT program would provide nearly 100,000 Hawaii families with increased access to nutritious meals. This program is critical for these families, and helps to advance our Administration's work to address ongoing food insecurity issues in our State—especially through the expansion of local agriculture.

SUBJECT: HB 2430 HD2 – RELATING TO SUMMER ELECTRONIC BENEFITS TRANSFER FOR CHILDREN PROGRAM.

**DEPARTMENT'S POSITION**: The Department of Human Services (DHS) strongly supports this administration measure. The proposal establishes and clarifies the responsibilities of DHS and the Department of Education (DOE) to implement the State's Summer Electronic Benefits Transfer for Children Program (Summer EBT). Once implemented, the program aims to reduce hunger and food insecurity for children during summer breaks when they lose access to free and reduced-price meals through the National School Lunch Program and School Breakfast Program. DHS defers to DOE regarding its resource needs to implement the program.

**PURPOSE:** This bill establishes the Summer Electronic Benefits Transfer for Children Program. Appropriates funds. Effective 7/1/3000. (HD2).

The Committee on Human Services (HD1) amended the measure by:

- (1) Requiring the Department of Human Services to be in compliance, rather than exempt from, the State's procurement codes when contracting with providers;
- (2) Changing the appropriations to unspecified amounts;
- (3) Changing the effective date to July 1, 3000, to encourage further discussion; and

(4) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

The Committee on Finance (HD2) further amended this measure by changing the numbers of full-time equivalent program specialist positions to unspecified numbers.

The Consolidated Appropriations Act, 2023, P.L. 117-328, authorized a permanent, nationwide Summer EBT beginning in 2024. Summer EBT intends to reduce hunger and food insecurity for children who lose access to free and reduced-price meals through the National School Lunch Program and School Breakfast Program during the summer when school is not in session. The U.S. Bureau of Labor Statistics included in its September 2023 report that over the previous 12 months, food prices in Hawaii increased 5.3 percent.

During the height of the COVID-19 pandemic, Congress enacted a similar program, Pandemic Electronic Benefits Transfer (P-EBT), in response to the federal public health emergency that resulted in school closures that prevented students from receiving free and reduced-price meals at school. P-EBT proved to be effective in ensuring families of these students had the resources to address their children's food needs during the federal public health emergency. Through P-EBT, DHS issued \$18,256,166 in P-EBT benefits to 122,334 students just during the 2023 summer break.

For the Summer EBT program, the benefit of \$59 per summer month or \$177.00 for the entire summer period per child will be issued on a card and may be used at vendors that accept Supplemental Nutrition Assistance Program (SNAP) benefits. This amount is significantly higher than other states participating in Summer EBT.

The benefits are 100% federally funded and will have an economic multiplier effect in the community, with values of up to \$2 of economic activity per dollar spent,<sup>1</sup> in addition to meeting students' food needs. For example, if 100,000 students each received the \$177.00 benefit, the \$17,700,000 in federal benefits paid would generate \$35,400,000 in economic activity for the State.

Hawaii's participation in the new federal Summer EBT program requires a 50/50 match of state funds to federal funds for administrative costs. To develop and implement this new and permanent program, the Departments of Education and Human Services will need additional general funds to modify data systems and administrative processes and funds for one additional FTE program specialist position, with an appropriation request of \$50,000 A/\$50,000 N. DHS defers to DOE's human resource needs.

The balance of the Department's \$2,000,000 A/\$2,000,000 N funds request is a cost estimate based on the P-EBT implementation. DHS defers to DOE's administrative and IT resource needs.

For P-EBT, DHS conducted procurement pursuant to the presiding COVID-19 Pandemic emergency proclamations. The Summer EBT is like P-EBT, but there are additional program requirements. DHS requests similar procurement exemption from the competitive process for at least two years so that the Departments can quickly expedite the system modifications; additionally, we anticipate there may be program differences between FFY2024 and FFY2025. As the session continues, the amount requested may change as DHS is currently assessing how to implement the program this fiscal year and is looking for available SFY 2024 general funds.

# Testimony of the Hawai'i Appleseed Center for Law and Economic Justice Support for H.B. 2430 – Relating to the Supplemental Nutrition Assistance Program Senate Committee on Ways and Means Thursday, March 28, 2024, at 9:50AM

Aloha Chair Dela Cruz, Vice Chair Moriwaki, and members of the Committee:

Thank you for the opportunity to submit testimony in strong support for **H.B. 2430**, which would appropriate funds and establish the Summer Electronic Benefits Transfer for Children (Summer EBT) program for the state of Hawai'i.

When the school year ends, children from low income households lose access to the school meals they rely on, causing an alarming annual spike in childhood hunger. While existing summer meal programs play an important role, they reach only a fraction of the children who rely on free and reduced-price school meals during the school year. Summer EBT is a new federal program that bridges this gap, by providing cash benefits on an EBT card–similar to SNAP–for families to purchase food at retail locations.

According to the Food Research and Action Center, Hawai'i is home to approximately 100,000 children who are eligible to receive Summer EBT. *Eligible families would receive \$177 per child for this summer–up to a total of \$17.7 million in federal dollars for the entire state.* This is funding that would support local food businesses and retailers, while also providing significant relief to families who struggle to keep up with grocery bills while their children are not in school.

Summer EBT benefits are entirely federally funded. However, the program requires a 50 percent match in administrative costs, which HB 2430 would provide. Without this modest administrative investment, Hawai'i will lose out not only on the \$17.7 million in federal cash benefits, but also on the economic multiplier that EBT benefits provide. In fact, the USDA estimates that every dollar in EBT benefits can generate \$1.50 in local economic impact. This means that Summer EBT could generate over \$26 million in economic activity during the summer months.

HB 2430 is a small investment that will yield big results. It achieves this by ensuring Hawai'i has the necessary capacity to administer this important federal program, which would provide cash to struggling families during the summer months, and also by bringing in millions of federal dollars that will stimulate Hawai'i's food economy. We highly encourage you to pass this bill, for the good of Hawai'i's children, families, and local businesses. Thank you for your consideration.

The Hawaii Food Industry Association is comprised of two hundred member companies representing retailers, suppliers, producers, manufacturers and distributors of food and beverage related products in the State of Hawaii.

HFIA is in strong support of HB2430, the "Summer Electronic Benefits Transfer for Children Program." This legislation is vital for addressing the pressing issue of childhood hunger, particularly during the summer months when school meal programs are unavailable.

Childhood hunger remains a significant concern in our communities, and the implementation of the Summer Electronic Benefits Transfer for Children Program is a crucial step in combating this issue. This program not only provides families with additional federal funds to purchase nutritious food but also injects vital resources into our local economies, supporting grocers, farmers, and small businesses.

As highlighted in the testimony from the Department of Human Services (DHS), a similar program, the Pandemic Electronic Benefits Transfer (P-EBT), proved to be effective during the COVID-19 pandemic in ensuring families had the resources to address their children's food needs. DHS issued \$18,256,166 in P-EBT benefits to 122,334 students during the 2023 summer break alone. For the Summer EBT program, each child could receive a benefit of \$177 per month, which is significantly higher than other states participating in Summer EBT. These benefits are 100% federally funded and will have an economic multiplier effect while meeting students' food needs.

It is important to note that while the Summer EBT program requires a state match of 50 percent of federal administrative funds, the appropriation request is only \$2,000,050. Using the figures provided by DHS for 2023, the state stands to pull in \$18,256,166 in federal dollars to support hungry children and an additional \$2,000,050 for the administrative match, resulting in a 10 to 1 federal match.

H.B. 2430 represents a modest yet impactful investment that will yield significant results. By supporting struggling families during the summer months and stimulating Hawaii's food economy with millions in federal dollars, this bill aligns with our shared goal of promoting the well-being of our community's children and families.

We urge the committee to pass this measure and we thank you for the opportunity to testify.

AlohaCare appreciates the opportunity to provide testimony in **support** of **HB2430 HD2.** This measure establishes the Summer Electronic Benefits Transfer for Children Program and appropriates funds.

Founded in 1994 by Hawai'i's community health centers, AlohaCare is a communityrooted, non-profit health plan serving over 84,000 Medicaid and dual-eligible health plan members on all islands. Approximately 40 percent of our members are keiki. We are Hawai'i's only health plan exclusively dedicated to serving Medicaid and Medicaid-Medicare dually-eligible beneficiaries. Our mission is to serve individuals and communities in the true spirit of aloha by ensuring and advocating for access to quality, whole-person care for all.

AlohaCare's commitment to whole-person care and health equity includes addressing social determinants of health, including housing, language access and nutrition among other factors. We understand that without access to affordable, healthy food, the health and well-being of our communities is negatively impacted. According to the Hawai'i Foodbank, 1 in 4 keiki in Hawai'i may not know where they will get their next meal, and for more than 81,000 keiki, getting the energy they need to learn and grow can be a daily challenge. Proper nutrition is vital for keiki growth and development and may reduce the risk of health conditions like anemia, asthma, hyperactivity, and anxiety.<sup>1</sup> Given the significant proportion of federal funding available for this program, this is a cost-effective solution to support keiki health. For these reasons, AlohaCare supports this measure.

Aloha Chair Dela Cruz, Vice-Chair Moriwaki, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

**The Hawai'i Farm Bureau supports HB 2430, HD2,** which establishes the Summer Electronic Benefits Transfer for Children Program.

The Hawai'i Department of Education's School Food Services Branch serves over 100,000 nutritionally balanced, affordable meals to Hawai'i's students on any given school day. However, when schools are closed, our keiki lose access to healthy meals and are at higher risk of food and nutrition insecurity. Experiencing food insecurity as a child can have long-term impacts on academic achievement as well as mental and physical health.

The Summer EBT for Children Program will help close the summer hunger gap when keiki are on summer break and not getting nutritious school meals. This program will offer nutrition assistance to eligible, low-income students, increasing their family's food purchasing power and improving their nutrition. It also provides economic benefits to farmers participating at grocery stores, farmers' markets, and other food retailers.

We believe that access to locally grown fresh fruits, vegetables, and protein to low-income individuals and families provides benefits to both Summer EBT students and Hawai'i's farmers and ranchers.

Dear Chair Dela Cruz, Vice Chair Moriwaki, and Committee Members,

On behalf of Hawai'i Children's Action Network Speaks!, I am writing in **SUPPORT of HB 2430 HD2**. This bill establishes the Summer Electronic Benefits Transfer (EBT) for Children Program and makes appropriations.

In the 2022, only 7.6 percent of the low-income students who got free or reduced-price school lunch during the academic year also got free lunch at summer camps, summer schools, or other summer programs through the federal Summer Food Service Program.<sup>1</sup> While they weren't getting free or reduced-price meals during the summer, those low-income children and youth still needed to eat, stressing their families' budgets.

That's where Summer EBT comes in. This new federal program provides grocery-buying benefits to lowincome families with school-aged children when schools are closed for the summer.<sup>2</sup> For the summer of 2024, eligible Hawai'i families could receive \$177 per child in Summer EBT benefits,<sup>3</sup> which goes a long way towards helping families afford to buy healthy food for their keiki.

According to the Department of Education, 55 percent of Hawai'i's 167,649 public school students are economically disadvantaged,<sup>4</sup> which means that approximately 92,000 keiki could qualify for Summer EBT. If there were all to receive those benefits, that would mean drawing down **more than \$16 million in federal dollars not only helping local families buy food, but also supporting our grocery stores and other food retailers across Hawai'i.** 

However, Summer EBT requires that states match 50 percent of federal administrative funds for the program with non-federal funds.<sup>5</sup> This bill would establish the Summer EBT program in Hawai'i and provide the required matching funds. This seems like a good investment, as **each \$1 in state funds could leverage as much as \$8 in federal funds** for keiki and their family, as well as local supermarkets.

# Testimony of the Hawai'i Good Food Alliance <u>Support</u> for H.B. 2430, Relating to the Supplemental Nutrition Assistance Program House Committee on Human Services Thursday, March 28th, 2024, at 9:50 AM

Aloha Chair Marten, Vice Chair Amato, and members of the Committee:

Mahalo nui loa for the opportunity to offer our testimony in **strong support of H.B. 2430**, which seeks to allocate funds and establish the Summer Electronic Benefits Transfer for Children (Summer EBT) program for the state of Hawai'i.

The Hawai'i Good Food Alliance (HGFA) stands firmly behind this initiative and believes it aligns perfectly with our mission to promote thriving community food systems across the islands. As a coalition of organizations dedicated to enhancing food production, distribution, and accessibility, we are deeply committed to ensuring that all residents of Hawai'i have access to nutritious, locally sourced food.

As the school year draws to a close, many children from low-income households face the harsh reality of losing access to the vital meals provided at school. This results in a concerning surge in childhood hunger during the summer months. While existing summer meal programs serve an essential purpose, they unfortunately reach only a fraction of the children who rely on free and reduced-price school meals throughout the academic year.

The Summer EBT program presents a promising solution to bridge this gap by providing families with cash benefits on an EBT card, akin to the Supplemental Nutrition Assistance Program (SNAP). This enables them to purchase food at retail locations, thereby ensuring that children have continued access to nourishing meals during the summer break.

H.B. 2430 represents a prudent investment with far-reaching benefits. By providing crucial financial assistance to families in need during the summer hiatus and by injecting millions of federal dollars into Hawai'i's food economy, this legislation has the potential to yield profound positive outcomes for our children, families, and local businesses alike. Thank you for your consideration.

The Hawai'i Good Food Alliance is a diverse hui of individuals and organizations who share in the production, aggregation, and distribution of food, and share in the practice of mālama 'āina to re-build thriving community food systems. Healthy Eating + Active Living (HEAL) Coalition, convened by the Hawai'i Public Health Institute<sup>i</sup> appreciates the opportunity to provide testimony in **Support of HB2430 HD1**, which would provide Hawai'i families with the opportunity to participate in the Summer EBT program.

This measure calls for the collaboration between the Department of Education, which directly provides for the students, and the Department of Human Services, which adminsiters SNAP. It is vital the departments have a strong working relationship and work seamlessly together to provide meals to our youth. Success will be achieved through collaboration.

## School ends and hunger persists.

Students of low-income families are eligible for free or reduced-priced meals during the school year to help with the cost of food. However, these guaranteed meals are no longer available during the summer. This loss leaves many students facing food insecurity. Fortunately, the federal government is offering to provide families with hundreds of dollars per child so they can afford healthy meals, and Hawai'i has the opportunity to provide for its students. By participating in the Summer EBT program and facilitating local families' enrollment, Hawai'i can redirect millions of federal dollars toward groceries for these families and will help end the hunger that plagues 1 in 5 children in Hawai'i.<sup>ii</sup>

### Healthy meals mean healthy keiki.

Adopting the Summer EBT Program is a pivotal step towards enhancing our children's health. Ensuring access to nutritious food during summer, we combat food insecurity and its associated health risks, like stress, depression, and other chronic diseases.<sup>III</sup> This promotes immediate health outcomes for our keiki and creates lifelong healthy eating habits. These students and our state will feel the benefits of this program long after the summer ends.

## Economic boost to Hawai'i.

Implementing this program is simply the right thing to do and a strategic economic investment. By providing families with additional federal funds to purchase nutritious food, we directly inject millions of dollars into our local economies, supporting grocers, farmers, and businesses. In total, Hawai'i families are eligible to receive up to \$18 million in funding for Summer EBT. Studies have shown that every dollar in SNAP benefits generates up to \$1.50 in economic activity.<sup>iv</sup> The effect would be similar in Hawai'i.

Mahalo to the committee for taking up such an important measure. It is imperative we work together to end childhood hunger throughout Hawai'i.

Please consider our testimony in support of HB2430 and passsing this bill.

## American Heart Association Testimony for HB 2430 HD2 "Relating to Summer Electronic Benefits Transfer for Children Program"

The American Heart Association is pleased to testify in <u>strong support</u> of HB 2430 HD2. This bill establishes and clarifies the responsibilities of the State Department of Human Services and the State Department of Education to implement the State's Summer Electronic Benefits Transfer for Children Program ("Summer EBT Program") and appropriates funds. This program provides access to free and reduced-price means to children during their summer breaks when they lose access to free and reduced-price meals through the National School Lunch Program and School Breakfast Program.

It is important to ensure children have access to nutritious meals year-round. Research shows that rates of food insecurity among children are higher in the summer—a time when children do not have access to National School Lunch Program and School Breakfast Program, which are only available during the academic year.<sup>i</sup>

Beginning this summer, eligible Hawaii families can receive \$177 per child through the Summer EBT program. The USDA has also indicated that this program would provide nearly 100,000 Hawaii families with increased access to nutritious meals.

In addition to ensuring that eligible keiki are able to purchase nutritious food during the summer months, this program will also result in an injection of millions of dollars into Hawaii's economy, thereby supporting local farmers and businesses.

The American Heart Association urges you to pass HB 2430 HD2 to help reduce food insecurity and childhood hunger in Hawaii. Sincerely,

On behalf of Hawai'i Foodbank, **I support HB 2430**, which would ensure that Hawai'i can participate in the federal summer electronic benefits transfer for children program. This federally funded program will provide up to \$177 per child in cash benefits while school is out for the summer to help ensure our keiki have enough to eat.

Food security is a critical issue in Hawai'i, where one in six residents lacks comprehensive access to healthy, nutritious food. Keiki hunger is even more severe, with an estimated one in four keiki in Hawai'i experiencing food insecurity—the second highest rate of childhood food insecurity in the country. For many children, school might be the only place where they can reliably receive a healthy meal; school breaks mean a loss of access to those primary meals. Through the USDA S-EBT program, Hawai'i families with keiki will receive up to \$177 per child over the summer, which will both ensure they have enough to eat through the school break as well as bring millions of federal dollars to our State to be spent in local stores.

HB 2430 would support the State infrastructure needed to ensure Hawai'i can participate in this important program, and we strongly support this measure.

Hawai'i Foodbank is Hawai'i's largest hunger relief organization, fiercely dedicated to our mission of nourishing our 'ohana today while working to end hunger tomorrow. We work with a network of 200 partner agencies across O'ahu and Kaua'i to provide food assistance to an average of more than 150,000 people each month. Last year, we distributed food for more than 16.2 million meals across the islands we directly serve, including 5 million pounds of fresh produce. Together with the Maui Food Bank, serving Maui County, and The Food Basket, serving Hawai'i Island, our network of food banks and partner agencies provide food assistance to all those facing hunger across the State.

Parents and Children Together (PACT) <u>supports HB 2430 HD2</u> Relating to the Summer Electronic Benefits Transfer for Children Program, which appropriates funds to maximize participation in the federal summer electronic benefits transfer for children program. The measure leverages state funds to bring in federal funds that will go to the critical purpose of providing food to families during the months children are typically not in school.

Founded in 1968, PACT is a statewide community-based organization providing a wide array of innovative and educational social services to families in need. Assisting more than 15,000 people across the state annually, we help identify, address, and successfully resolve challenges through our 20 programs. Among our services are early education programs, domestic violence prevention and intervention programs, child abuse prevention and intervention programs, child hood sexual abuse supportive group services, child and adolescent behavioral health programs, sex trafficking intervention, poverty prevention and community building programs.

Through our programs, we are seeing the rise in food insecurity that our local families face. Even working families who have not previously needed help with food have started to request and accept it. We saw this increase start during the early days of the COVID-19 pandemic and increase through the rise of inflation and the 2023 Maui wildfire crisis. In response, we have increased direct food and financial assistance to program participants in the Kalihi and Maui communities. Additionally, we support survivors of domestic violence through the financial impact of keeping their families safe, which often includes leaving their abusive financial provider partner. Many of the survivors we serve struggle through houselessness and loss of income. Increased access to SNAP benefits would help these families achieve and/or maintain basic stability.

Subject: Testimony in Strong Support of HB2430

I am in strong support of bill HB2430 that appropriates funds to the State Department of Agriculture (DOA) for the implementation of Act 153, SLH 2019. This law authorizes DOA as the administering agency of the Hawai'i Healthy Food Incentive Program (HHFIP), otherwise known as DA BUX Double Up Food Bucks, or DA BUX.

DA BUX benefits many aspects of the state's food system. By offering a 50% discount on Hawai'i grown fruits and vegetables for low-income SNAP-EBT shoppers, DA BUX helps farmers increase their customer base and compete with imported produce, while also supporting the local economy, generating increased revenue for 59 participating food retailers across 100+ statewide locations. Additionally, DA BUX is stretching the food budgets of low-income households and increasing their consumption of Hawai'i grown fruits and vegetables.

DA BUX is also providing critical support for Maui's economic recovery from the Maui wildfires. DA BUX has already proven it can increase sales and profits for Maui County farmers. Three Maui County food hubs report an average 114% increase in local produce sales to SNAP shoppers over the past two years. Statewide, a \$2 million State investment has the potential to generate \$12.8 million in economic activity.

A government-funded program that supports families on SNAP-EBT (Supplemental Nutrition Assistance Program) is crucial for several reasons:

Alleviating Hunger and Poverty: SNAP-EBT provides low-income families with the means to purchase food, reducing hunger and ensuring basic nutrition. This is particularly important for vulnerable populations, including children, elderly individuals, and individuals with disabilities, who may otherwise struggle to afford an adequate diet.

Improving Health Outcomes: Access to nutritious food through SNAP-EBT can lead to improved health outcomes. Adequate nutrition is essential for physical and cognitive development in children, and it can help prevent or manage chronic health conditions such as obesity, diabetes, and heart disease. Economic Stimulus: SNAP benefits are spent quickly, injecting funds directly into local economies. When families use SNAP-EBT to purchase food, it supports grocery stores, farmers' markets, and food producers, thereby bolstering the agricultural and retail sectors. This, in turn, can create jobs and stimulate economic activity.

Social Stability: By reducing food insecurity and poverty, SNAP-EBT contributes to social stability. When families can afford basic necessities like food, they are better able to focus on other aspects of their lives, such as education, employment, and personal well-being. This stability can have positive ripple effects throughout communities.

Supporting Working Families: Many SNAP recipients are employed, but their wages may not be sufficient to cover all their expenses, including food. SNAP EBT helps fill this gap, enabling working families to make ends meet and providing a safety net during times of financial hardship, such as job loss or unexpected expenses.

Nutritional Education and Support: SNAP often includes educational components aimed at promoting healthy eating habits and budgeting skills. These resources can empower families to make healthier food choices, stretch their food dollars further, and improve their overall well-being.

Disaster Response and Resilience: In times of natural disasters, economic downturns, or other emergencies, SNAP-EBT can provide critical assistance to affected families. It helps ensure that individuals and communities can access food even when faced with unforeseen challenges.

In essence, a government-funded program that supports families on SNAP-EBT is essential for addressing food insecurity, promoting public health, stimulating economic activity, and fostering social stability and resilience. It serves as a vital lifeline for millions of individuals and families across the United States, helping them meet their basic needs and build brighter futures.

Furthermore, a \$2M per year recurring State investment will ensure the survival of the DA BUX program, which is currently set to expire on August 31, 2024. State funding will be leveraged to request matching federal funds from the USDA Gus Schumacher Nutrition Incentive Program (GusNIP) in the 2024 funding cycle. State funding has the potential to unlock these federal GusNIP dollars, as the GusNIP requires funding requests to include documentation of 100% non-federal match as well as a "sustainable funding plan." State investment is critical to the long-term sustainability of DA BUX and its ability to provide a positive, lasting impact economically, for farmers, and for the well-being of individuals across the state.
