Chair Yamashita, Vice Chair Kitagawa, and members of the Committee:

The Department of Law Enforcement (DLE) **strongly supports**, House Bill 2459, House Draft 1.

This administration bill is a housekeeping measure that transfers the responsibility and management of certain private security contracts from the DLE to the Departments of Defense, Health, and Human Services for their respective facilities.

Act 278, Session Laws of Hawaii 2022, gave DLE the responsibility for after-hours security contracts for the Departments of Defense, Health, and Human Services. These departments have traditionally managed these contracts and are in a better position to continue this practice. The proposed amendment to section 26-14.6, Hawaii Revised Statutes, returns the private security contracts to these departments managing the private security contracts for their respective facilities which will continue to increase efficiencies of the security for these departments and their respective facilities by ensuring the departments retain greater control of these contracts, based on their direct access to on-the-ground information.
