In consideration of HOUSE BILL 2563, HOUSE DRAFT 1 RELATING TO THE HAWAII TOURISM AUTHORITY

House Bill 2563, House Draft 1 proposes to require the Hawai'i Tourism Authority to develop and publish, through a contract with a third party, a mobile application that includes all online application processes, including the collection of any applicable reservation fees, to acquire a reservation to conduct recreational and commercial activities in the state that are regulated by or under the jurisdiction of a State or county agency. This bill requires the Hawai'i Tourism Authority to issue a request for proposals and contract for the development and publishing of the mobile application. This bill establishes a tourism enterprise fund and appropriates funds for the development and publication of the mobile application, including the hiring of a mobile manager. **The Department of Land and Natural Resources** (**Department**) offers comments to this measure.

The Department is responsible for managing various public resources requiring users to secure a permit or license to access or utilize. Act 182, Session Laws of Hawai'i 2023, requires the Department to develop and publish a website that includes the application processes for a permit, license, or reservation needed to conduct recreational and commercial activities in the State regulated by or under the jurisdiction of the Department. Consolidating forms and application processes for outdoor recreational and commercial activities will entail intuitive navigation, visual presence, and content that offers consistent user interfaces for computer interaction. The user experience will enable residents, visitors, and businesses to quickly search, locate, learn, and secure reservations, permits, and outdoor activities. The requirements of Act 182 are a multi-phased, multi-fiscal-year project that will develop a consolidated website to help residents, visitors, and commercial operators find and apply for permits, licenses, and reservations to fulfill Act 182. Therefore, the Department recommends providing a website link to the proposed House Bill 2563, House Draft 1 online application.

As an example, the Division of State Parks (DSP) has 4 park units currently subject to an advance reservation system that collects fees for parking and entry. One park unit is managed by a community nonprofit partner who collects parking and entry fees through a reservation portal they manage. The parking fees are retained by the nonprofit for their staff and management and the entry fees are paid to State Parks. The goal is to transition the nonprofit from a revocable permit to a concession lease for an extended term. The other 3 park units are heavily patronized by out of state visitors with advance reservations that are subject to a service contract with Tyler Tech (aka NIC) who collects all parking and entry fees and manages the current park reservation systems. NIC collects a service fee and manages the online payment portal. DSP is examining the need and feasibility at the 6 other park units subject to parking and entrance fees in consultation with NIC and the contracted parking managers. Any new digital platform should only link to the existing NIC and nonprofit reservation sites and not collect any fees due to these preexisting contractual relationships.

RELATING TO THE HAWAII TOURISM AUTHORITY

The Department of Budget and Finance (B&F) offers comments on this bill.

House Bill (H.B.) No. 2563, H.D. 1, adds two new sections to Chapter 201B, HRS, to require the Hawai'i Tourism Authority (HTA) to develop and publish a mobile application, through contract with a third party, that includes all online application processes to require a permit, license, or reservation needed to conduct recreational and commercial activities in the State that are regulated by or under the jurisdiction of a State or county agency; and to establish outside the treasury the Tourism Enterprise Fund (TEF) to provide a mechanism to collect fees on behalf of State and county agencies and to disburse them to the appropriate agency on a quarterly basis. This bill also appropriates an unspecified amount of general funds for FY 25 to establish 1.00 manager position to manage the mobile application and to contract for the development and publication of the mobile application.


As a matter of general policy, B&F does not support the creation of any special fund which does not meet the requirements of Section 37-52.3, HRS. Special funds should:

1) serve a need as demonstrated by the purpose, scope of work and an explanation why the program cannot be implemented successfully under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries or a clear link between the program and the sources of revenue; 3) provide an appropriate means of financing for the program or activity; and 4) demonstrate the capacity to be financially self-sustaining. Regarding H.B. No. 2563, H.D. 1, it is difficult to determine whether the proposed special fund would be self-sustaining.

In addition, B&F has concerns with the TEF being established outside of the State treasury as having funds within the State treasury will allow for better investment and fund management.

Lastly, any operating expenses relating to the administration of this mobile application process should be paid for by fees collected for the program in the TEF before distribution to each State or county agency.
