Title of Bill: HB 0500, HD1 RELATING TO EDUCATION.

Purpose of Bill: Appropriates funds to DOE to promote surfing as an interscholastic sport. Effective 6/30/3000. (HD1)

Department's Position:

The Hawaii State Department of Education (Department) respectfully offers comments and concerns.

Since 2005, the Department has developed regulations to implement surfing as a high school sport. In 2016, the Hawaii State Board of Education approved Board Policy 101-11, Surfing, which established surfing as a high school sport.

While the Department appreciates the appropriations to support surfing in high school athletic programs, this would not address the larger risk factors that make surfing difficult for high schools to sanction. These risks include concerns around accessible and safe surfing areas to conduct practices and the inability to control the practice environment. On Oahu, surfing has not been proposed by any Department high school principal, and providing funding, while appreciated, would not alleviate these concerns.

Aloha,

My name is Joslyn Sato and I am a parent of a high school surf team rider and also the parent volunteer surf team manager at Leilehua High School. This year, was our team's first year having a surf team. As the team mom, I have seen the positive impact that a high school surf team has done for the students and their families. There really was no place for my daughter. So with her passion, I assisted her in starting and running the Leilehua High School Mules Surf Team this year. The team has given her and the other team riders an opportunitiy to connect their passion of surfing (shortboard, longboard, bodyboard) to their school and their community. These students do not have other "sports" interest, and when not at school they are surfing. Not only are the students excited to be part of something representing their school, but their parents have been thankful that their children have an opportunitiy to be student-athletes. The surf team is not only about the contest, it's instilling ocean stewardship through service projects and educational opportunities about our 'aina, building ocean safety through the Jr Lifeguard program, and connecting with local and national industry businesses for exposure to post-high school career opportunities.

Despite all the challeges of the process and requirements to get a team started and participate in the High School Surf Challenges, the hardest challenge has been finding and convering our season fees. While it is a sactioned sport, there really is no resources behind it leaving the teams to do it all on their own. And since we are not official "athletic sports" we get zero resources from the school and must find funding all through club donations and fundraisers. This season, I have "donated" several hundred dollars to ensure I have 3 coaches lifeguard trained and to ensure we have items needed for any "practices". As smaller teams, we do not have the reach for high-volumne fundraisers. We try to minimize the cost paid by students to ensure financial requirements do not prevent participation and be equitable. Any fundraisers and community donations we get go towards our required season fees. With the lack of funding, not only does it limit opportunities but can also impact safety and success of a program. Safety is #1. If we could have funding committed to the high school surfing program it could ensure safety requirements are funded and met equally across the teams and at the challenges, provide some committed resources towards the sanctioned sport, and also help in offsetting expenses required by each school's team.

By passing HB500 HD1, it helps us to take a huge step forward by showing committment and support in High School Surfing, which aligns with the DOE's 2023-2029 Vision and Core

Values. By offsetting critical expenses, it allows our teams to build up our high school surf programs. In addition, passing HB500 HD1 is an investment in sufing - our culture, history, lifestyle, and industry. It embraces diversity, equity, and inclusion as surfing fosters both an individual and team aspect that includes boys and girls, and shortboard, longboard, and bodyboard surf styles. It's paying it forward to our future by creating a pipeline of potential future lifeguards and other ocean-realted opportunities that support our Hawai'i community. In addition, it's supporting an active lifestyle, supports well-being, and connects to our 'aina now and into the future. The opportunity builds relationships across the schools because if you surf, chances are you will be in the water with students from other schools when not at a competition.

By passing HB500 HD1, you're investing in sustaining the Hawaiian cutlure, the history & achievements of surfing, a pipeline to ocean realted careers critical to our comunity, a program for ocean stewardship and safety, and a sport that keeps our students active now and for a lifetime. Of all high school sports, Surfing is deeply rooted and connected to our Hawai'i and provides so much benefits for students and our communities that will last a lifetime!

Senator Kidani and Member of the Senator Education Committee,

Thank you for the opportunity to support this measure. Having been involved in ocean sports and Ocean Safety for more than 6 decades I would like to share my perspective on why this measure is so valuable to our community.

There are many things we all learn in school. The most important are the skills that we will need to carry us thru our lives. Reading, writing, and math skills are at the top of the list academically. As we all know it's not just academic skills that are important. How to work with others, overcoming challenges, being a good winner (and a good loser) are also important life skills that we all need. Developing these skills is as important as developing academic skill.

In his book "Sports in America" James Michener identified and celebrated the role that sports plays in so many people's lives. Our educational system routinely provides these sports opportunities.

The Board of Education recognized that in Hawai'i the sport of surfing is interwoven into the cultural and social fabric of our communities. The recognized that thousands of students were participating in surf sports before, during, and after school. They also recognized that surf sports are one of the rare sports that participants can enjoy their entire lives. That a lifetime of benefit would be derived for participants if it was to be incorporated into our High School athletics program.

They passed a measure directing the Department of Education to incorporate surfing into their programs. I was asked to assist DOE in developing the necessary criteria to ensure that coaches and students could engage in surfing sports in a safe and well managed manner. I enlisted the support of Ocean Safety Chief Archie Kalepa from Maui and Chief Kalani Vierra from Kauai. Together with key DOE staff the program was fully developed and implemented. Not initially as a HHSAA sport but as a Club Sport. Within several years the Maui Community was successful in having the Maui Interscholastic League (MIL) accept the sport into its program. This has not been the case on Kauai, Big Island, and on Oahu.

There have been numerous surfing club sports programs developed on the Big Island and Oahu. They have been successful, no student has been injured, and there has not been any litigation filed (to the best of my knowledge) against the State or DOE because of injury. The major impediment to the continuation and growth of the program has been the costs associated with delivering the program. These costs, in both time and money, were being borne by the volunteer coaches. The Outrigger Duke Kahanamoku Foundation was one of several organizations that provided funding support to cover the cost of training and education of the surf coaches via the University of Hawai'i Community College Office of Continuing Education and Training.

Thank you for opportunity to present this testimony today. The request before you is to support the effort to move surfing from a club sport to a Interscholastic Sport. An effort that will bring great benefit to our community and one I fully support.

I am in firm support of HB500 to appropriate funds to the DOE to promote surfing as an interscholastic sport.

As a former Hawaiian Swimming club and HHSAA ILH swimmer, recent HHSAA ILH assistant swim coach, and current Hawaiian Swimming club swim coach, I firmly believe that introducing surfing to Hawai'i's interscholastic athletics can aid in reinforcing significant water and ocean safety skills among Hawai'i's youth. According to the State of Hawai'i Department of Health's Hawai'i Injury Prevention Plan 2018-2023, "Drownings are the 5th leading cause of fatal injuries among Hawai'i residents . . . Hawai'i had the 2nd highest resident drowning fatality rate among all 50 States from 2013 to 2017 . . . Most (84%) of the fatal drownings in Hawai'i were in the ocean" (HIPP 13). Therefore, introducing surfing as an interscholastic sport can help to combat and address this issue by providing schools with a space to educate Hawai'i's youth on how to stay safe and be aware while in the water.

Furthermore, surfing shares a significant role in the Hawaiian culture. As a prominent traditional practice in Hawai'i for years, establishing surfing as an interscholastic sport can help to perpetuate this significant part of Hawai'i's culture for and within the upcoming generations of Hawai'i students.

Besides, the Hawai'i Surfing Association (HSA) already currently hosts interscholastic surfing competitions and championships for O'ahu-based high schools. Thus, formally recognizing surfing as an HHSAA sport could provide students beyond O'ahu with the opportunity to compete for their school, as well, and vie for a spot at the National Scholastic Surfing Association (NSSA) Championships (as the HSA currently supports).

For the aforementioned reasons, surfing should receive the same resources that many other Hawai'i DOE sports (e.g., football, baseball, air riflery, and bowling) currently receive.
