SUBJECT: COMMENTS FOR HCR 117 HD1, URGING THE COUNTY OF

MAUI TO ADOPT A FINANCIALLY PRUDENT BUDGET FOR FISCAL YEAR 2025-2026 THAT MAINTAINS CURRENT

OPERATIONAL LEVELS EXCEPT FOR CERTAIN MANDATORY

OR CRITICAL INCREASES

We respectfully offer our comments on House Concurrent Resolution 117, HD 1 for your consideration.

The impact of the Maui wildfires has placed an inordinate amount of demand on the County for both human and financial resources, including rescue operations, recovery, housing, provisioning, debris removal, and infrastructure replacement and repair. These efforts continue into FY 2025, as we start the process of healing our community, while continuing everyday County operations on Maui, Moloka'i and Lāna'i.

The County of Maui FY 2025 budget proposal represents a nearly flat budget for our departments carrying out normal County operations. Excluding any wildfire expenses, there is only a $\underline{1.2\%}$ increase (approximately \$5.4 million) in our operating budget.

This year, primarily in response to wildfire recovery efforts, we are facing a \$429.2 million increase to the FY 2025 budget. This is a 33.9% increase from last years' Council-adopted budget of \$1.268 billion, due in large part to new revenue streams addressing our emergency recovery needs.

Including the general fund, revolving and special funds, transfers among funds within the County, anticipated grant revenue, and other revenue from sources outside Maui County, my balanced budget proposal for FY 2025 totals \$1.697 billion.

While a 33.9% increase in FY 2025 is indeed significant, this is based on an increase due to wildfire-related revenue and expenses within our existing departments that we're required to balance within the budget.

Some of these expenses include the Office of Recovery that provides staffing and a framework to lead the implementation of best practices for recovery efforts in six focus areas: community planning, housing, infrastructure, natural, historical and cultural resources, economic resiliency and health, and social service systems.

It also includes \$75 million in funding for housing relief efforts to assist in keeping our West Maui residents' home in Lahaina and to assist the State in decreasing its financial obligations in Non-Congregate Shelter (NCS).

Other Maui wildfires departmental expenses include: communication system improvements for our Police Department, and additional personnel for our Fire and Public Safety Department, and MEMA.

Another change in FY 2025 is the establishment of the Department of 'Ōiwi Resources and the East Maui Water Authority budgeted at \$1.8 million and the bifurcation of the Department of Housing and Human Concerns budgeted with no significant increase, which were adopted by the council and voted into approval by our residents in 2022 under the mandatory guidelines of the Maui County Charter.

My budget reflects approximately a \$153 million increase in FY 2025 operating funds. And just over \$146 million, or 95.3% of that increase is attributable to wildfire-related departmental expenses.

We have requested approximately \$150 million from the State, and a bridge loan from Hawai'i Community Foundation for \$54.5 million to directly support recovery efforts, including housing and infrastructure. We are also pursuing federal grant opportunities and public assistance reimbursements. These new revenue sources are absolutely critical to ensuring anticipated revenue streams can continue to serve ongoing operations for ALL of Maui County, and must be reflected in a balance budget.

We recognize and embrace the cumbersome fiduciary responsibility we have to our residents, and to our State, Federal and private partners. As such, I have asked all departments to maintain level budgets to the prior fiscal year, except for wildfire recovery related costs. This is an incredibly significant fiduciary sacrifice considering our departments are carrying out their normal operations, while additionally managing critical disaster recovery efforts that are essential to the needs of Lahaina and Kula survivors, as well as our community.

I realize that the impact of the financial implications of the Lahaina wildfires are being felt statewide; however, none have felt it more than our 12,000 survivors who have lost everything. Never has Maui County been presented with a more critical and justified need. And while our County and State are faced with many priorities, none are of a higher priority than the needs of the people and town of Lahaina.

This budget was constructed to address Maui County's recovery efforts, primarily towards critical housing and infrastructure challenges. It also ensures that ongoing projects and current services continue to be provided, and addresses preparedness and mitigation efforts for future disasters.

Rightfully noted, it is our understanding that our proposed budget indeed reflects maintaining current operational levels, except for certain mandatory or critical increases and is consistent with the intention of proposed HCR 117, HD1.

Above all, I believe it is all of our kuleana to keep the people of Maui Nui safe. My administration and I look forward to continued collaboration with the State of Hawaii in serving our community.

The County's current Fiscal Year 2023-2024 budget exceeded \$1 billion for the first time, and it was based on pre-wildfire economic projections that included significant revenue from real property, transient accommodations and general excise taxes, all of which will be notably decreased for the second half of this fiscal year and next fiscal year, and probably beyond.
