Department's Position:

The Hawaii State Department of Education (Department) is providing comments on HCR 191.

The school bus driver shortage has been widely publicized, and is part of a greater nationwide driver shortage that is only expected to increase in scope over the coming years. As the reasons for the driver shortage are varied and complex, the solutions to ensuring safe, reliable transportation for the Department's students are likewise varied, and not limited to school buses.

The Department accordingly proposes that the comprehensive plan proposed by HCR 191 take a broader approach beyond the reinstatement of canceled school bus routes. Accordingly, the comprehensive plan could encompass the consideration of alternative transportation options such as carpooling and public transit in addition to school bus transportation, and could also include the examination of efficiency strategies such as centralized bus stops.

Aloha, Chair Woodson, Vice Chair La Chica and Committee members. I am Larry Veray, Chairman for the Pearl City Neighborhood Board No. 21. I am submitting this testimony representing our board as a whole and families that live in Pearl City that require bus service for their children. Thank you for allowing me the opportunity to provide testimony in strong support of HCR 191 / HR 171.

The members of the Pearl City Neighborhood Board in their individual capacities strongly support this measure that would establish comprehensive standards for the department of education related to school bus services to ensure reasonable accommodation, equitable access, timely communication, and accountability. The need for this bill was demonstrated by the elimination, on just weeks' notice at the start of the 2023 – 2024 school year, of school bus routes serving Pearl City High School and Highlands Intermediate School without community consultation.

In particular, we note the bill's requirements for consultation with community representatives on the details in a timely manner and decisions to be made on data, equity and alternative options with an appeal process. Given reasonable planning there might have been, for example, minor adjustments to city's TheBus schedules and routes to have provided better service options. In addition, community consultation could have sooner provided school bus service by shared by different levels of school as happens throughout rural America, including Hawaii and Oahu.

The nine comprehensive standards will ensure, as the bill states, school bus service "... decisions are made with the utmost consideration for reasonable accommodation, equity, and prioritization of student who live beyond a certain distance from school."

We most strongly urge you to pass HRC 191 / HR 171.Our keiki in Pearl City should not be forgotten and forced to walk long distances especially up a hill to their school. Mahalo!

I strongly encourage the legislators to pass HCR 191/HR 171.

As a parent of an 8th grader at Mililani Middle school. We were one of lucky families that still have bus service this school year. However, for many other families statewide there was no option to catch the bus and only being notified weeks before the school year started.

We all know that the cost of living in Hawaii isn't ideal. Multi generational homes have become the new norm. Residents have to work multiple jobs or pick-up extra shifts to make ends meet. Most households both parents have jobs. Therefore, having a school bus service would ensure students can get to school on time, while also ensuring parents are able to go to work. Especially in the rural areas of the state where there's only one school for miles.

My family and I live at home with my parents and brother. The cost to purchase our own property just isn't feasible. But we still pay to live there. My husband and I both have full time- jobs that have rotating shifts (shifts vary week to week). My husband and I sometimes work as early as 3am. So when they announced the cancellation of bus service due to a shortage of drivers weeks before the start of school I panicked. Yes, my parents are retired, but they're also getting older in age and I can't always rely on having someone drive my son to school. Having school bus service helped to ensure my son always has a way to get to school on time and a way home from school. Having school bus service also allowed my husband and I to continue to work. It also allowed me to get a promotion at work. We're one of the lucky ones. Some households where they don't have any support. Therefore, if there's no bus service they're left with no choice to physically drive their child/children to school and hopefully their work schedule will accomodate it.

Having bus service will also help to alleviate traffic congestion in the school zones. Mililani Mauka has 2 elementary schools and a middle school. Mililani Mauka also only has one way in and out from that community. Therefore, restoring bus service would alleviate traffic congestion going in and out of Mililani Mauka. Currently, students within Mililani Mauka lost bus service to the middle school and Mililani High has no bus service. Therefore, the traffic going into and coming out of Mililani Mauka is a lot heavier. In rare cases when I drop my son off it takes me almost 30-45 minutes round trip due to the increased amount of traffic going to and from the schools.
