They have no librarian to teach them how to find factual information and how to deal with the dangers of misinformation. Their teachers don't have the services of a librarian who can provide them with the latest exciting curriculum-related resources and technologies. At a time when we need to raise students who can successfully compete in the digital age, we are shortchanging them by not providing them with an indispensable resource. I strongly urge that you support this resolution to give our young learners the benefits of a well-equipped library that is managed by a licensed school librarian.
