#### RELATING TO STATE HOLIDAYS

The Department of Budget and Finance (B&F) offers comments on this bill.

Senate Bill No. 2037 amends Section 8-1, HRS, to establish Lunar New Year, the day of the second new moon after the winter solstice, as a State holiday.

B&F notes that this bill would add an additional State holiday to the 13 (14 in even-numbered election years) State holidays currently recognized in the HRS. This additional holiday would cause the State to lose a day of State labor and productivity valued at approximately \$16,900,000 in payroll expenses, including social security, Medicare, and pension accumulation.

Furthermore, B&F would like to highlight that the Department of Human Resources Development and the Hawai'i Government Employees Association have testified on similar bills in the past, noting State holidays are a matter that needs to be negotiated and included in the collective bargaining master contract.

In consideration of SB 2037, Relating to State Holidays

Chair Lee, Vice-Chair Inouye and the members of the committee:

The Office of Collective Bargaining (OCB) appreciates the intent of SB 2037, which designates the second new moon after the winter solstice of every year as the Lunar New Year and establishes the Lunar New Year as a state holiday. However, OCB offers the following comments on this measure:

- 1. While the Legislature is the governing body to both establish and remove official state holidays, the potential impact on public employees is a negotiable matter, subject to collective bargaining pursuant to Hawai'i Revised Statutes (HRS), §89-9.
- 2. This was evident when, as early as the mid-1970s, the exclusive representatives and the employers mutually agreed to remove references to HRS, §8-1 from the holiday provisions of the respective collective bargaining agreements. This action reflected the parties' agreement that holidays are a negotiable matter and cannot be solely legislated.
- 3. Also, the establishment of Lunar New Year, as an official state holiday would have no effect on public workers unless it is negotated and mutually agreed to.
- 4. Should this measure pass prompting the exlusive representatives to initiate negotiations for inclusion of Lunar New Year as another observed holiday for public employees, the employer would have serious concerns regarding the operational and financial impact to the State.
