Aloha Chair Rhoads, Vice Chair Gabbard, and Committee Members:

The Hawai'i State Ethics Commission ("Commission") **supports** the proposed SD1 of SB 2219, which makes pivotal updates to Hawaii's lobbyist law. This bill expands the definition of lobbying to include procurement matters outside of those communications already allowed for under Haw. Rev. Stat. chapters 103D or 103F. This proposal is informed by other jurisdictions and is principally focused on "pre-procurement" communications where someone is actively communicating with high-level government officials to induce or shape the procurement process. This expansion increases transparency and oversight over state procurements, which directly reduces the potential for corruption, waste, and fraud.

This bill also creates two new presumptions to simplify regulatory oversight. First, this measure creates a new standard where if a person is paid to submit testimony ten or more times during a calendar year, they trigger the definition of a lobbyist. This establishes an easy-to-administer, bright-line standard that can be used by both lobbyists and the Commission to determine when registration is necessary.

Second, this measure also presumes that a lobbyist submitting testimony relevant to an employer is doing so on behalf of an employer, versus submitting that testimony in an unemployed or personal capacity. This addresses situations where an employee claims they are not paid to lobby but are transparently advocating in their employer's interests. To this end, the Commission proposes an amendment to address concerns it has heard from stakeholders. Page 2, lines 1-6 should be amended to say:

Any individual with a substantial ownership interest in or a paid employee, officer, or director of an organization, who actively participates in lobbying activities that directly benefit that organization, shall be presumed to be receiving compensation from the organization for their lobbying efforts.

This removes some of the ambiguity in the language originally proposed in SD1.

This measure reflects a thoughtful and iterative approach to expanding Hawaii's lobbying law that ensures greater transparency, accountability, and fair competition in government contracts. This proposal strengthens the regulatory framework, preventing undue influence and promoting a level playing field that benefits both taxpayers and businesses alike.

Aloha Chair Rhoads, Vice-Chair Gabbard and other members of the Committee,

The Grassroot Institute of Hawaii would like to offer its comments on the portion of the <u>proposed SD1</u> for <u>SB2219</u> that would amend the current definition of lobbyist to include an individual who, "for pay or other consideration, on behalf of another person ... submits testimony ten or more times during any calendar year."

We applaud the bill's aim of cleaning up government and stopping corruption, but we are concerned that the current wording of this provision might unintentionally sweep civically active citizens into the lobbying category.

Because the term "consideration" can be interpreted as any benefit — financial or otherwise — and the term "person" includes organizations and businesses, it could be broadly applied to people who would not generally be considered lobbyists.

For example, this phrasing could arguably apply to a business owner testifying about the impact of proposed tax increases on his business, a translator submitting comments for a marginalized group, or the head of a parents organization testifying about changes to schools.

Under the current law, the time commitment involved in the lobbyist definition is five hours in one reporting period or 10 hours in a calendar year. This is a relatively small amount of time, but because it is focused on activities that are defined by communications with specific public officials, it is clearly intended to exclude those who are simply deeply involved in a specific issue. However, by expanding the law to make a lobbyist out of a mere 10 testimonies, the bill significantly expands the definition of lobbying.

Consider that a single bill in the state Legislature may occasion six separate opportunities for testimony. If there is a companion bill, an individual may exceed the 10-testimonies limit without ever speaking on more than one proposal.

Broadening the definition of lobbyist in this way could discourage citizen participation in the legislative process.

It also could increase the administrative burden on the departments that oversee lobbyist registration and run lobbyist training.

The time-based measures focused on communications in the current law make a simpler distinction between professional lobbyists and active citizens. However, if the Committee wishes to address the issue of lobbyists who evade registration requirements but are highly active in submitting testimony, we suggest a substantial increase in the testimony count.

Alternatively, the Committee could adjust the language to reflect a testimony threshold based on the number of different proposals — such as bills or resolutions — testified on.

Otherwise, given that testimony is a direct expression of free speech in its purest form, using testimony limits to define lobbying appears unnecessary and undemocratic.

I am concerned about the <u>proposed amendment</u> to Section 97-1, Hawaii Revised Statutes: to amend the current definition of lobbyist to include an individual who, "for pay <u>or other</u> <u>consideration</u>, on behalf of another person ... submits testimony ten or more times during any calendar year."

Furthermore, <u>changing the definition</u> of "lobbyist" to mean <u>any individual</u> who engages in lobbying in excess of five hours in any month; engages in excess of ten hours during any calendar year; and submits testimony ten or more times during any calendar year, is a direct violation of our first amendment rights under the U.S. Constitution.

May I respectfully remind you that The First Amendment provides that Congress makes no law respecting an establishment of religion or prohibiting its free exercise. It protects freedom of speech, the press, assembly, and the right to petition the Government for redress of grievances.

Please vote NO on SB2219.

Dear Chairman Rhoads, Vice Chairman Gabbard, and members of the Judiciary Committee:

I am a God, and I am the official President of the United States of America, because I officially impeached Joe Biden on November 18, 2022, using the Constitution of the United States of America to execute this order. Today, on behalf of the non-profit organization Godwits Mercy Inc., I would like to object to SB 2219, which amends the definition of "lobbying" to include certain communications with administrative agencies, among other changes.

Nonprofit organization Godwits Mercy Inc. is an industry-wide professional association of nonprofit organizations. Our mission is to reform, unite, and strengthen the nonprofit sector worldwide, help the homeless, sick, and poor, fix the government's system, preserve world peace and bring peace to the world, and change the world to become a good place. As a collective force to improve the quality of life in Hawaii, throughout the United States, and around the world. Our member organizations provide essential services to every community across the states and around the world.

We are concerned about the potential negative impacts of this bill on collaboration and communication between the nonprofit sector and law enforcement and government agencies in addressing common goals. Our mission is to strengthen communities across the state and fix the government's system.

Typically, such collaboration will result in a written report or policy statement. For example, nonprofits will participate in task forces, submit reports to relevant agencies, develop strategic plans issued by the Department of Health or Human Services, or submit proposal letters to universities, other related organizations, such as scientific, educational, church, or other related organizations, to request implementation and review to create a report.

Nonprofits strive to collaborate with departments to identify community needs and the strategies and resources needed to address these needs. While some other non-profit organizations will only focus on policy advocacy, our non-profit organization will only focus on providing direct services to people in need, improving the lives and understanding of people, and helping homeless and mental health patients come back to a normal life, whether through state contracts or through private donations and grants.

We are focusing on solving problems in people's social lives and issues related to government operations and reshaping government to ensure fairness and safety for all, which our nonprofit is working to improve.

I am concerned that this bill may be aimed at silencing lawful public communications that facilitate interagency cooperation and free speech.

Broadening the definition of lobbyist in this way could discourage citizen participation in the legislative process.

Otherwise, given that testimony is a direct expression of free speech in its purest form, using testimony limits to define lobbying appears unnecessary, undemocratic, and unconstitutional.

Aloha Chair Nakashima, Vice Chair Sayama, and Members of the Committee,

My name is Rachel Morgan and I STRONGLY OPPOSE SB2219.

SB2219 defines myself, the everyday citizen, as a lobbyist if I submit 10 or more testimonies per legislative session. For example if im following only 5 bills, and each bill has 2 hearings, and I submit a testimony for each hearing, then Im a lobbyist.

The vague language of "other consideration" in this bill, for example, could arguably apply to a business owner testifying about the impact of proposed tax increases on his business, a translator submitting comments for a marginalized group, or the head of a parents organization testifying about changes to schools.

Broadening the definition of lobbyist in this way could discourage citizen participation in the legislative process. It also could increase the administrative burden on the departments that oversee lobbyist registration and run lobbyist training.

The time-based measures focused on communications rather than testimonies that can be found in the current law make a simpler distinction between professional lobbyists and active citizens. However, if the Committee wishes to address the issue of lobbyists who evade registration requirements but are highly active in submitting testimony, we suggest a substantial increase in the testimony count, or adjusting the language to reflect a testimony threshold based on the number of different proposals — such as bills or resolutions — testified on.

Otherwise, given that testimony is a direct expression of free speech in its purest form, using testimony limits to define lobbying appears unnecessary and undemocratic. I respectfully but strongly urge the Committee to OPPOSE SB2219 as this impacts our freedom of speech.
