## **RELATING TO ELECTIONS**

March 15, 2024

Chair Tarnas and members of the House Committee on Judiciary and Hawaiian Affairs, thank you for the opportunity to testify in support of Senate Bill No. 2240, SD 2. This bill requires the Office of Elections to file an application with Electronic Registration Information Center, Inc. (ERIC), by June 30, 2025, for the State to be admitted as a member of the organization; requires the Office of Elections to share with each county the information and services made available by ERIC pursuant to the State's membership agreement with the organization; requires the Office of Elections and each county office that administers elections to use information and services made available by ERIC to verify their respective voter registration rolls; and makes an appropriation.

Joining ERIC would provide another tool for election officials to maintain the accuracy and integrity of the voter registration rolls by allowing us to compare our voter registration file and driver license/identification card file with other member states. This will permit election officials to determine if a voter has moved out of state, as they register to vote or obtain a driver license in another jurisdiction. Additionally, ERIC membership requires all driver license/identification card holders who are eligible to register to vote, but are not currently registered, to be sent a mailer encouraging them to register.

Since our previous testimony on measures related to joining ERIC, we have received updated information on costs. We estimate that it will cost \$149,000 in FY 2024-25 to join ERIC based on the \$25,000 application fee, \$42,500 annual membership fee, and approximately \$81,500 to conduct the initial mailing to driver license and state identification card holders who are not

registered to vote as required for membership in ERIC, along with mailings to address in-state movers and cross-state movers. The recurring costs, which we would submit as part of our annual budget request starting with FY 2025-26, would be approximately \$45,000 for the annual membership fee, which is recalculated each year by ERIC.

Honorable Chair Tarnas, Vice Chair Takayama, and Committee Members,

INTRODUCTION: Electronic Registration Information Center (ERIC), Incorporated is a private, non-profit, non-partisan organization. ERIC is used to manipulate and inflate voter rolls.

I oppose HB2240 for the following reasons:

- <u>Privacy issues</u>: Violation of federal statutes such as the Help America Vote Act, National Voter Registration Act, and Driver's Privacy Protection Act. The first statute provides states the authority and obligation to create and maintain electronic voter registration files but includes no provision that authorizes any state to outsource these obligations to a third party like ERIC. The outsourcing of voter registration list maintenance to ERIC may also violate the National Voter Registration Act, which protects from disclosure the identities of individuals who decline to register to vote. Finally, the Driver's Privacy Protection Act specifically shields from disclosure the kind of data provided to ERIC by member states to conduct list maintenance. Additionally, personal identifiers such as name, birth date, and last 4 of SSN are shared with this private third-party organization.
- Funding: the burden to fund the program is on the taxpayers. Per ERIC website, states who choose to participate are required to pay a fee. Some states are paying \$175,000 or more in annual dues. The Hawaii State Elections Office could use that money to improve the integrity of their election process such as cleaning the voter rolls, conducting hand counted paper ballot audits, and improved chain of custody procedures.
- 3. <u>Does not prevent illegal voting</u>: Per ERIC's website, it is a tool available to help election officials maintain more accurate voter rolls and detect possible illegal voting. There are no public records showing ERIC detected illegal voting. Furthermore, there is currently no citizen verification check. According to the City Clerk, individuals registering to vote sign a self-attestation statement that they are eligible voters even though it is not verified by an official election employee.

Please do not pass SB2240\_SD2. Please vote NO.

# Holly Plackett, Legislative Committee, League of Women Voters

The League of Women Voters of Hawaii **strongly supports SB2240 SD2** which requires the Office of Elections to join the Electronic Registration Information Center (ERIC) and share information with counties to encourage voter participation and ensure integrity of voter registration rolls.**SB2240 SD2** further requires the Office of Elections and each county office that administers elections to use information and services made available by ERIC to verify their respective voter registration rolls as well as makes a more accurate appropriation to fund this measure. The League of Women Voters of Hawaii strongly supports these measures as well.

The League of Women Voters understands that the Electronic Registration Information Center, Inc., or ERIC, is a nonprofit organization that was formed in 2012 to help states improve the accuracy of voter registration rolls by using secure data-matching tools. Twenty-Four (24) states and the District of Columbia participate in ERIC. As a member of this organization, Hawaii will receive reports that show voters who have moved within the respective states, voters who have moved out of the state, voters with duplicate registrations with the state, voters who have passed away, and individuals who are potentially eligible to vote and have not registered to vote. Being a part of ERIC, the state of Hawaii will further ensure the integrity of voter registration rolls in the State my modernizing the State's voting system of verifying voter registration data.

We agree with your committee in that providing another tool for election officials to maintain the accuracy of voter registration rolls is necessary to protect democracy in the State. ERIC may help to resolve unintentional errors in a voter's Hawaii registration while preventing voter registration in more than one State. This is important for Hawaii, since we regularly have many people moving into and out of the State. We know registration officials are diligent in trying to maintain the integrity of our registration rolls; this modest investment with ERIC would be helpful.

Aloha House Judiciary Committee Chair Tarnas and Committee Members,

I oppose SB2240 SD2.

The Electronic Registration Info Center (ERIC) is problematic, so much so that in recent years nine states have terminated their ERIC contracts.

The current ERIC state membership count is 24 states plus Washington DC.

The Missouri Secretary of State cited one of the reasons for leaving ERIC as, "ERIC's benefits to Missouri are limited as only three of the eight states that boarder [sic] Missouri are members".

The Office of Elections written testimony from the January 30, 2024 Senate Judiciary Committee hearing on SB2240 reads that joining ERIC

"would provide yet another tool for election officials to maintain the accuracy of the voter registration rolls by allowing us to compare our voter registration file and driver license/identification card file with other member states".

The <u>2022 State of Hawaii Databook</u>, which is the most current population data available, shows the states to which Hawai'i residents are moving (out-migration) and the states where people are leaving to move to Hawai'i (in-migration).

Which are the top out-migration states and are they members of ERIC? **The top 3 out-migration states are Texas, California, and Florida, none of which are ERIC member states.** Total Hawai'i population out-migration to ERIC non-member states is 65%.

### Voter Registration Duplications:

In a voter registration comparative analysis of ERIC-member states to nonmember states, data analysis in 27 states revealed nearly 700,000 duplicate registrations.

Jeffrey Young, Certified Analytics Professional (CAP<sup>®</sup>) with a master's degree in business analytics, assessed the permanent address changes in the National Change of Address

database, (NCOA) against 27 states' voter registration databases over a four-month period prior to the 2022 General Election.

Using the NCOA database, Young flagged all the voters who filed permanent mailing address changes between September 2022 and December 2022, which uncovered a staggering number of duplications.

Specifically, 693,686 duplications were discovered among voter registrations across 27 states analyzed, which represents only approximately 28% of the total possible combinations of the states.

An in-depth comparison of ERIC member states and non-member states showed that the **ERIC member states had approximately 50% higher rate per capita of duplicate registrants**. In other words, states that pay to belong to the ERIC system, which promises to help state election officials maintain clean voter rolls by cross- checking duplicate registrations, have significantly more duplications than states that are not ERIC members (full study available upon request).

### **Privacy Concerns:**

Hawai'i residents' data, including name, address, DOB, drivers license number, last 4 digits of SSN, phone and email address when available, will be shared across state lines. ERIC provides each member state a targeted list of people that are not registered to vote. The membership bylaws require the state to contact at least 95% of these people within 90 days, soliciting them to register.

Instead of spending taxpayer's money on contracting with ERIC, a better use of resources would be to have the county clerks run the NCOA data more frequently, i.e., every 4-6 months, and crosscheck the data against the voter rolls to identify movers, as opposed to utilizing NCOA only in election years. When someone files a NCOA form it is only active for 6 months.

The Honolulu City Clerk's office only uses NCOA data to cross check the voter rolls before bulk mailings before elections. This means that the majority of people who moved away from Hawai'i and filed a NCOA form would never have received the election mailer to verify their address, and the counties would not receive the NCOA bounce back indicating that the voter has moved.

Despite claiming otherwise, ERIC's priority focus is identifying and contacting unregistered voters.

ERIC recently provided a list of unregistered voters to the Colorado Secretary of State, who then mailed out voter registration applications to 31,000 people. The problem is that these applicants were sent to noncitizens.

Hawai'i does not verify citizenship upon voter registration, it is merely a self-attestation.

Hawai'i makes it very easy for people to register to vote.

There is an online voter registration portal. We have preregistration for teenagers, automatic voter registration through the DMV, and same day registration.

# On February 20, 2024 the Hawai'i Elections Commission passed a motion to OPPOSE the state of Hawai'i joining ERIC.

Considering all the issues explained above, and the Election Commission's motion to oppose Hawai'i joining ERIC, I strongly urge you to oppose this bill.

## VIRGINIA BLOCKED 'NON-CITIZENS, DECEASED, FELONS' FROM ERIC'S 'ELIGIBLE BUT UNREGISTERED' VOTER OUTREACH

### ERIC Claimed at Least 168K Deceased, Relocated, Ineligible People as 'Eligible' for Taxpayer-Funded Outreach in Virginia

MARCH 2024 – During Virginia's membership period with the Electronic Registration Information Center (ERIC), commonwealth officials had to block ineligible persons selected by ERIC from receiving voter registration instructions. Records disclosed to PILF demonstrated efforts to stop foreign nationals, felons, deceased, and others from receiving taxpayer-funded voter education materials. Public records reviewed in other ERIC member states show similar efforts – or none.

### Virginia's Exit & Potential Re-Entry into ERIC

When Virginia exited the interstate nonprofit in May 2023, Elections Commissioner Susan Beals wrote that ERIC "expanded beyond that of its initial intent – to improve the accuracy of voter rolls."<sup>1</sup> Documents disclosed in response to a records request from the Public Interest Legal Foundation show some of the sophisticated lengths Virginia had to go to address that alleged overreach.

The Virginia Legislature advanced a bill to Governor Glenn Youngkin's desk which would ultimately require the Commonwealth's re-entry into ERIC.<sup>2 3</sup>

#### Crash Course: ERIC's Mandatory 'Eligible But Unregistered' Process

To be a member in good standing with ERIC, a state must submit its voter registration and driver's license customer data to ERIC for comparison. ERIC's goal is to find a licensed driver who is not registered to vote. ERIC would consider that person Eligible But Unregistered or "EBU." Often, someone who meets those criteria either *do not want* to be registered or *cannot legally register*. Remember, the National Voter Registration Act of 1993 (NVRA), aka "Motor Voter," mandates that states like Virginia offer voter registration at DMVs. Meaning, every EBU fed back to Virginia has already said "NO" to a voter registration offer. Everyone meeting these EBU criteria was



submitted to Virginia officials for taxpayer-funded postcard outreach explaining how to register to vote.

#### Inside Virginia's EBU Filter

Records disclosed to PILF show that months before the 2020 General Election, then-Virginia Elections Commissioner Christopher Piper opted to engage in two rounds of EBU outreach. In June 2020, ERIC supplied a list of "approximately 360,000" for EBU postcards. Meeting notes between Virginia, ERIC, and the Center for Election Innovation and Research (CEIR) dated July 29, 2020, detailed plans for a second round of EBU mailings, dubbed a "refresh," which would target "about 1.9 million" around Labor Day weekend. The notes also described and illustrated filtration protocols before the 1.9 million names and addresses were printed on postcards designed by CEIR. After the "refresh" mailing and Election Day, Virginia agreed to turn over voter registration and turnout data related to the EBUs to CEIR for its own research purposes and an "outreach study."

Below is a flowchart shared between Virginia officials, ERIC, and CEIR outlining filtration and labor division.



The records disclosed to PILF show that of ERIC's 1.9 million "Eligible But Unregistered" listing in Virginia, the following would not receive mail:

# "Approximately 100,000 deceased"

# "Approximately 68,000 no longer in [Virginia]"

# > Other "Ineligible" (e.g., "felony, already registered")

#### How Did Virginia Spot Foreign Nationals in the ERIC Data?

After ERIC handed off names and addresses, Virginia used its previous voter registration list maintenance work to inform who received EBU outreach postcards. This meant that Virginia had to fact-check the EBU prospect list for people known by the Commonwealth to already be deceased, convicted of a felony, or removed from the voter roll for other reasons. Because of a relatively unique Old Dominion law, Virginia could also use the same concept for "declared" foreign nationals.

When a DMV customer in Virginia claims in their paperwork to be a foreign national, their information is required to be shared with Commonwealth election officials so they can see if the person was already registered to vote. In the event of a match, the registrant is set on a pathway to removal from the voter roll if they do not affirm their citizenship status in a timely manner.<sup>4</sup> The Virginia Department

of Elections publishes annual totals of citizenship-related cancellations.<sup>5</sup> The records disclosed to PILF do not show how many "non-citizens" were spotted in ERIC's EBU list, but other public data do give a sense of scale for how many could have been prevented from receiving postcards, based on prior removals from the voter roll. Since 2014, Virginia reportedly removed **more than 11,000** registrants from the voter roll as "declared non-citizen[s]." However, some of those individuals may have subsequently naturalized and re-registered.

### Addressing ERIC's EBU Data Quality in Other States

PILF surveyed a collection of states for records indicating how they may perform similar EBU data filtration functions.

**Colorado.** Weeks before the 2022 Midterms, Colorado made national news after admitting a "data analytic error" resulted in more than 31,000 foreign nationals receiving postcards with instructions on how to register to vote. The ERIC Eligible But Unregistered program was ultimately determined to be the catalyst. PILF dug into the records of the case and saw where state officials were vague with county colleagues about the specific "error." <sup>6</sup> Colorado quickly built a system to block any foreign nationals who received the EBU cards from completing voter registration before the 2022 midterms. If they had a blocking mechanism for foreign residents, it malfunctioned in 2022.

Illinois. Communication records disclosed to PILF from the Illinois State Board of Elections show internal conversations about how ERIC data needed to be vetted to prevent foreign nationals and adolescent drivers from receiving EBU postcards. Emails dated throughout 2022 show how green card/legal permanent residents and other visa holders were being flagged within the ERIC lists.

**New Mexico.** The New Mexico Secretary of State takes a very different approach. Its website offers a frequently asked questions webpage about the EBU process. To the question, "*I am a non-citizen, why did I receive a voter registration outreach postcard?*, the State is blunt: "*If you are a non-citizen and you are in the motor vehicle database, it is likely you have received a voter registration outreach postcard.* However, given your non-citizen status, you are not eligible to vote and should not register. Registering to vote if you are not eligible is a felony."<sup>7</sup> [emphasis added].

**Maryland**. The Maryland State Board of Elections confirmed to PILF in 2023 that it had no documents demonstrating any kind of effort describing the process to filter EBU lists for known ineligible persons.

### What to Do About the EBU?

The ERIC Eligible But Unregistered concept pushes member states into risky territory. In principle, encouraging others to register to vote is a noble act; but too easily aliens, felons, and others who are not eligible to vote receive these targeted mailings can wrongly conclude that they are, in fact, eligible. If states are wise, they perform additional work to be good stewards of public resources while simultaneously shielding immigrants and others who are not eligible from receiving instructions about voter registration.

It does not have to be this way.

Prior to Ohio's exit from ERIC in 2023, Secretary of State Frank LaRose floated a reform: make the EBU and other ERIC programs optional or "a la carte."<sup>8</sup> PILF and even some leading left-leaning voices<sup>9</sup> lauded the concept as opposed to abandoning the project altogether. Hardliners in ERIC leadership did not budge, and Alabama, Florida, Iowa, Louisiana, Missouri, Ohio, Texas, Virginia,

and West Virginia ultimately made their exits. This meant that ERIC remainers like Michigan and Wisconsin could not easily catch when their former voters moved to Texas and Florida. Election officials around the Mid-Atlantic region have blind spots with Virginia gone. ERIC's return on investment rests on a diverse member portfolio.

# If ERIC leaders were serious about rebuilding their coalition, they would return to discussions about these reasonable reforms.
