PURPOSE OF BILL: Authorizes the Board of Education to consider qualified individuals with at least an associate's degree or high school diploma with comparable education and coursework, industry experience, and content expertise to teach career and technical education courses.

POSITION: Supports with suggested amendments

Chair Michelle Kidani, and Members of the Committee;

The Hawai'i Teacher Standards Board (HTSB) offers comments on SB2252, relating to the board of education. First of all, we hope that this bill could be amended to identify the Hawai'i Teacher Standards Board as the authority charged with licensing, as this bill lists our board policies in this bill. Currently it lists the Board of Education as the licensing authority. We hope this can be remedied.

We need to support our Career and technical education (CTE) pipeline of educators along with our students who require CTE credits to complete their studies. Many students decide not to attend college, and instead choose a viable career in CTE, sometimes referred to as the "trades" that do not require a degree to enter into a career and make a very good living. This bill will help support the highly qualified educators they need. Part of understanding the needs of our students, is understanding that they may learn very well from professionals that have worked for many years in their field, despite not having a college degree. They may have attended a technical school, or have gone through an apprenticeship to learn their trade. It is not always college in CTE fields. Although the Hawaii Teacher Standards Board does believe, and will continue to require, they learn pedagogy of teaching etc., as it is very different to teach someone on the job with one or maybe two apprentices, but having a classroom of 30 is very different. However, to support our CTE educators and those who want to become CTE educators, to help our students in their endeavors, we support this bill.

CTE programs allow students the opportunity to explore and learn through practical application of academic and technical skills. Many of the job openings today are for positions that do not require a college degree. By improving the CTE pipeline, we can expand educational and career options for our students while supporting our local economy. We want to support better options toward graduation for students who are in CTE programs, and this means we need qualified CTE educators.

The Hawai'i Teacher Standards Board asks your committee to support this bill, with suggested amendments.

SB2252 – RELATING TO THE BOARD OF EDUCATION

Chair Kidani, Vice Chair Kim and Members of the Committee:

Thank you for the opportunity to testify on SB2252 relating to amending Section 302A-803, Hawai'i Revised Statutes,

Hawai'i P-20 Partnerships for Education (Hawai'i P-20) supports SB2252, which amends Section 302A-803, Hawai'i Revised Statutes, to include "or high school diploma with comparable education" related to CTE teacher qualifications and licensing. This amendment allows the Hawai'i Teacher Standards Board (HTSB), as the agency that determines teacher qualification standards, to consider alternate qualifications for teachers. For example, an Executive Chef with more than 20 years of experience in the culinary industry who has operated and opened numerous fine-dining restaurants but does not have an associate's degree might be permitted to teach high school CTE courses in Culinary if this amendment is passed. This change to the statute has the potential to remove barriers to teacher licensing for career and technical education professionals who have extensive industry experience but lack the minimum associate's degree currently required in statute.
