TESTIMONY OF THE

CHIEF ELECTION OFFICER, OFFICE OF ELECTIONS

TO THE SENATE COMMITTEE ON JUDICIARY

ON SENATE BILL NO. 2333

RELATING TO ELECTION AUDITS

February 1, 2024

Chair Rhoads and members of the Senate Committee on Judiciary, thank you for the opportunity to testify in support of Senate Bill No. 2333. This bill allows the Chief Election Officer to use accurate copies of paper ballots, rather than the originals, when conducting a precinct audit of an electronic voting system's tally.

The Office of Elections supports this bill as it clarifies and updates the conduct of the audit used with modernized voting equipment and technology for elections by mail. The post-election audits are conducted to confirm the results and ensure the accuracy and integrity of the election rather than conducting a hand tally recount. Pursuant to HRS §16-42, we audit 10% of precincts randomly selected by Official Observers. The Official Observers then select a contest for each audited precinct.

Ballots are scanned and counted through the electronic voting equipment and since we have transitioned to elections by mail, ballots are processed and counted in the order they are received, in contrast to a polling place model where the ballots are isolated to the assigned district/precinct only. Using the voting equipment, the counted ballots can be filtered to the selected precinct and viewed to create a hand tally of expected results. Further, we are still able to track and go back to the individual source paper ballot and do a physical review as necessary.

The method of using the voting equipment to view the ballot and create a hand tally of expected results was used for the mail ballots in the 2022 Elections. We found it beneficial as we were able to check and confirm how the voting equipment counted a particular mark. We also compared and matched batches of the scanned ballots with the same batch of the physical ballots. For the voter service center ballots, as the voting equipment counting these ballots is different, we created the hand tally of expected results based on the physical ballot. We found more human errors were created in the audit process since the ballots had to be first manually sorted by district/precinct.

No evidence of issues affecting the outcome of the election has been found to question the validity of the results. However, if an issue were to arise during the conduct of the post-election audit impacting the results of the election, the audit may be expanded to include first additional contests and further additional precincts. Further, we would also like to mention that there are additional safeguards of checks and balances including logic and accuracy tests of the voting equipment before and after counting voted ballots, and the comparison of ballots received and accepted by the County Elections Division to voted ballots counted (i.e., turnout) by district/precinct reported in the election results.

The Office of Elections has repeatedly failed to demonstrate validity of it current audit procedures that are in violation of existing law. There is no mechanism here to validate any copies of ballot, electronic or paper, to be accurate. How is this any more valid printing more ballots at a copy center, when not even the electronic recordkeeping has been validated.

I have included a link below of the questionable electronic recordkeeping of our 2022 General Elections that has been presented to the Office of Elections and the Elections Commission without action or investigation. Open questions still remain unanswered. Why are half ballots in Maui not accounted for? Why are there so many duplicate ballot batch numbers? Why are ballots sequence numbers missing within individual batches? Further reliance on electronic systems continue to compromise the integrity and security of our election.

Aloha Committee Chair Rhoads and JDC Members,

Do you buy lottery tickets when you travel to the mainland? If you won, would it be okay to present a digital copy of your ticket to claim your winnings, without presenting the original paper ticket?

You can attest that it's a true and accurate copy, and the original is safely stored and retrievable.

Would you make payments for your largest purchases in digital copies of real money?

Would the bank accept that if you told them that your copies are the exact same as the originals and thus can be used interchangeably?

A ballot image is not the same as the original physical paper ballot.

The computer scanner does not "read" a name and a filled in circle and assign it a vote like a human would from looking at a paper ballot or a ballot image on a computer screen. Computer programmed ballot definition files (BDF) for each ballot style (there are lots, every district has a different ballot) are loaded into the computers hooked up to the ballot scanners, and complex computer source code (this can be several thousands of lines long) analyzes ballot race positions and corresponding circles using timing marks on the physical ballot. This information is transferred to a flash drive and then analyzed by the Elections Management System (EMS) computer source code to create the vote tally.

We are not allowed to review the source code or the BDFs to verify that the ballot positions of candidates names are interpreted correctly, we are not even allowed to review the Hart Intercivic election systems user manuals when requested through public records requests. This source code and BDFs are considered proprietary information by Hart Intercivic, the company who runs our elections. Ballot images themselves can be hacked, as proven by nonpartisan computer experts.

Only physical paper ballots should be used for the election audits. This is considered postelection audit best practices and just plain common sense. I implore you to vote NO on SB2333.

I submit this testimony in opposition to SB 2333.

As you know, in SB 2333 the legislature has acknowledged that the "existing law requires the chief election officer to conduct the audit of the randomly selected precincts by comparing electronic tally amounts against the original paper ballots" and that this is an audit requirement performed to ensure the validity of the state election results.

This lawful statutory requirement has been the subject of much controversy over the past two years, wherein multiple observer reports and several complaints resulted in at least four lawsuits in state courts challenging the Chief Elections Officers lack of compliance with the statutory post-election pre-certification audit procedure.

During a case that was presented in the 1st Circuit Court, the Chief Election Officer openly admitted to not following the statutory procedure, and the Deputy Attorney General defended the Chief Election Officers violations of that statute in two cases in the Hawai'i Supreme Court. (REFERENCE: 22-SCEC-0000515, 22-SCEC-0000703, 22-SCEC-0000711 and 1CCV-22-0001499)

Following the 2022 election, a Petition for the Redress of Grievances was filed by the People in the House of Representatives querying why the House was not interested in enforcing their own statute (Senator Luke sponsored HB 1740 in 2005 which resulted in HRS 16-42) - and the petition went unanswered.

Instead, during the 2023 Legislature, Speaker Saiki introduced HB 132 and Speaker Kouchi introduced SB 180 (both by the request of another party) to similarly rewrite HRS 16-42 then - just as SB 2333 attempts to do today.

Every effort by the People to ensure the accuracy of elections pursuant to statute has been thwarted by the Office of Elections, and the Attorney General - despite their charter "to be vigilant and active in detecting offenders against the laws of the State" (see HRS 28-2), and the legislature seems determined to rewrite the law to accommodate this maladministration.

The rewrite of this statute negates and dilutes audit requirements in their entirety and runs counter to the audit requirements specified in the Help America Vote Act of 2002 and the Voluntary Voting System Guidelines published by the U.S. Elections Assistance Commission (EAC).

I call to the attention of the Committee on the Judiciary that the post-election pre-certification audit procedures currently used by the Chief Election Officer violate the statutory procedure that are acknowledged in SB 2333, and do not in any way verify that the votes cast by the voter on the paper ballot are correctly tallied by the electronic voting system.

Without a valid and verifiable audit, there is no way to determine any level of accuracy in the election, and our state elections remain indeterminate.

I oppose this legislation.

Chairman Rhoads and members of the Senate Committee on Judiciary:

I am testifying AGAINST S.B. 2333

A dictionary definition of "audit" is:

a methodical examination and review

This bill would reduce the ability to methodically examine election processes in an audit. The bill states:

"accurate copies of the paper ballots, including accurate electronic copies, may be used in place of the paper ballots"

It should be self-evident that the condition of "accurate" copy can only be determined by an audit; this is the whole purpose of the audit. Allowing the Office of Elections or County Clerks to self-declare copies to be "accurate" defeats the whole purpose of the audit.

Instead, the statute could be amended to require the Office of Elections and County Clerks to segregate all hand-marked ballots, originating at mail-in or at voting service centers, by voting precinct at time of receipt to facilitate the audit of random precincts. This is the only way to ensure that voter intent has been correctly maintained throughout the scanning and tabulating process. Where electronically prepared ballots are used with a paper copy back up, these paper backups should also be precinctseparated.

As a citizen and voter since 1972, this is the minimum that should be done to ensure that my vote is fairly counted. The real solution is hand-marked, hand-counted ballots cast in person.
