TESTIMONY OF THE

CHIEF ELECTION OFFICER, OFFICE OF ELECTIONS

TO THE HOUSE COMMITTEE ON JUDICIARY AND HAWAIIAN AFFAIRS

ON SENATE BILL NO. 2334, SD 1

RELATING TO ELECTION AUDITS

March 15, 2024

Chair Tarnas and members of the House Committee on Judiciary and Hawaiian Affairs, thank you for the opportunity to provide comments on Senate Bill No. 2334, SD 1. This bill reduces the number of randomly selected precincts employing an electronic voting system that the Chief Election Officer is required to conduct a post-election, pre-certification audit from 10% to 5%, and clarifies that the Chief Election Officer must audit all elections in the randomly selected precincts as a condition of using an electronic voting system to create an electronic tally of ballots.

The post-election audits are conducted to confirm the results and ensure the accuracy and integrity of the election. Post-election audits are conducted on a sample of ballots and contests and are not a hand tally recount. Pursuant to HRS §16-42, we audit 10% of precincts randomly selected by Official Observers. The Official Observers then select a contest from each randomly selected precinct. We would also note that if a discrepancy is detected as an outcome of the audit, the Chief Election Officer may expand the audit to include additional contests and/or precincts. It takes approximately 6 days after each election to conduct the statewide audit in this manner and must be completed before the results are certified.

Our testimony on this measure focuses on the increased time required to audit all contests on the ballots associated with 5% of the precincts. Specifically, each election between 2014 and 2022 has had an average of 249 ballot types, which generally correspond with individual precincts. Each precinct has had an

average of 12 contests of which 1 would be selected for the audit. The current law's requirement of auditing 10% of precincts thus results in approximately 25 district/precincts being selected for the audit. As previously noted, an audit of this scope takes approximately 6 days to complete.

To the extent the present bill reduces the requirement from 10% of precincts to 5% of precincts but increases the number of contests from 1 per precinct to all contests, which is 12 on average, we estimate the amount of time necessary to complete such an audit will be approximately 36 days, unless there is a significant increase in staffing and funding to support such an audit.¹

Against this backdrop, we would recommend if the law were to be amended, that any change in the auditing process not result in more than 6 days being reasonably necessary to complete it. For example, with the required percentage of 5% of precincts to audit, at least 3 contests per precinct of which there would be at least 1 statewide contest and 1 countywide contest audited, along with ensuring that these contests would involve at least 1 contest on each side of the ballot. Based on the 2024 General Election, this would work out to approximately 45 contests. (i.e. 9 contests Hawaii, 6 Maui, 6 Kauai, and 24 Honolulu). While this would increase the number of contests audited, we envision that we could still be able to complete it within 6 days. We would also note that the number of days required is of concern because of the requirements related to the signature curing deadline 5 business days after the election and the contest for cause deadline 13 days after the primary election.

¹ Specifically, while going from 10% to 5% would reduce the audit time in half if only 1 contest continued to be audited per precinct, thus resulting in 3 days (i.e. 6 days/2), the increase from 1 contest to 12 results in a significant increase (i.e. [6 days / 2] * 12 = 36 days).

Dear Chair and Committee members,

Thank you for the opportunity to provide comments on behalf of Common Cause Hawaii.

We strongly recommend that you take a different tack with the changes proposed for Section 16-42, Hawaii Revised Statutes, regarding provisions for post-election audits. We agree with Chief Election Officer Scott Nago's concerns, in his previous testimony on SB2334, about the burden and complexity of extending the current audit method to all races on all the different ballots in various precincts – particularly before certification.

We recommend that Hawaii's post-election audit focus on random *batches* of ballots, rather than precincts. We recommend that the audit check two races – one statewide, one countywide – rather than all the races on all the audited ballots. If the batches are randomly selected, then auditing 50 batches – rather than 10% of precincts – could provide a post-election audit that is more robust, and easier to administer, than Hawaii's current practice.

Specifically, we recommend that Section 2 of SB2334 be changed to read as follows:

SECTION 2. Section 16-42, Hawaii Revised Statutes, is amended by amending subsection (b) to read as follows:

"(b) The chief election officer may rely on electronic tallies created directly by electronic voting systems, in lieu of counting the paper ballots by hand or with a mechanical tabulation system if:

(1) The electronic voting system is subject to inspection, audit, and experimental testing, by qualified observers, before and after the election, pursuant to administrative rules adopted by the chief election officer under chapter 91;

(2) No upgrades, patches, fixes, or alterations shall be applied to the system through thirty days after the election;

(3) The chief election officer conducts a post-election, pre-certification audit of a random sample of not less than [ten] five per cent of the precincts 50 randomly selected batches tabulated by employing the electronic voting system, to verify that the electronic tallies generated by the system for all elections in those precincts equal hand tallies of the paper ballots generated by the system for at least one statewide contest and one countywide contest for all elections in those precincts; and

(4) If discrepancies appear in the pre-certification audits in paragraph (3), the chief election officer, pursuant to administrative rules, shall immediately conduct an expanded audit to determine the extent of misreporting in the system."

We also urge the Committee to authorize risk-limiting audit pilots, to be held during 2025, as part of a process to begin using risk-limiting audits to verify election results in Hawaii. Risk-limiting audits, also discussed in CEO Nago's testimony on SB 2334, provide strong evidence that an initial election outcome is correct – or, if the outcome initially announced is not correct, they provide a path to correcting it.

Risk-limiting audits are widely considered "the gold standard" of post-election tabulation audits, and have been recommended by federal agencies and advocacy groups from across the political spectrum. Endorsers include the U.S. Senate Select Intelligence Committee; the Presidential Commission on Election Administration; the National Academies of Sciences, Engineering and Medicine; the Cybersecurity and Infrastructure Security Agency (CISA); the American Statistical Association; the League of Women Voters of the United States; the Brennan Center for Justice; the Center for Democracy and Technology; National Election Defense Coalition; Protect Democracy; Public Citizen; Verified Voting Foundation; Americans for Tax Reform; R Street Institute; Liberty Coalition; FreedomWorks; Business for America; and, of course, Common Cause.

Colorado, Georgia, Rhode Island, Pennsylvania and Virginia are currently using risk-limiting audits to check their election outcomes, and Texas is planning full statewide use beginning in August 2026. We urge this Committee to authorize pilot risk-limiting audits as a way of familiarizing elections officials with the audits' process and procedures, as sort of a "dress rehearsal" before implementing them in Hawaii.

We also urge the Committee to allow SB2333 to die in Committee. Election security experts recommend using original voter-verified paper ballots for post-election audits rather than copies – and if SB2334 is changed as recommended above, SB2333 will not be needed.

Informational Testimony on Hawaii SB 2333 and SB2334 Mark Lindeman, Ph.D. House Committee on Judiciary & Hawaiian Affairs March 15, 2024

I am the Policy & Strategy Director of Verified Voting, a non-partisan nonprofit organization whose mission is to strengthen democracy for all voters by promoting the responsible use of technology in elections. My own special expertise is in designing and implementing postelection audits to confirm that ballots have been counted accurately. Drawing on that experience, I offer these high-level recommendations for post-election audits in Hawaii.

Audit ballots, not ballot images. To serve their full value, audits should rely on the actual paper ballots that voters could verify, not on digital images that voters cannot authenticate. From a technical perspective, the only way to know whether a ballot image accurately represents the ballot is to refer back to the ballot itself.

Audit batches, not precincts. Because Hawaii is a vote-by-mail state, ballots are scanned in batches of, typically, about 200 ballots at a time. One precinct may be scattered across many scan batches. This challenge is why Hawaii used ballot images in its 2022 audit. However, the voting system can produce vote totals for each scan batch as well as for each precinct. Sampling and hand-counting scan batches is far more efficient and effective than auditing precincts. It is more *efficient* because each batch contains a relatively small number of ballots that already are stored together. It is more *effective* because it provides more comparison points, and it is likely to include ballots from practically all precincts. Auditing 50 scan batches is more informative than auditing 25-30 precincts, and also is less burdensome and more observable.

Audit a few contests, not all contests (for now). Hand-counting more than two or three contests at a time—even for relatively few ballots—becomes substantially more complex and more error-prone. This tends to defeat the purpose of the audit.

Move toward auditing individual ballots—and all contests thereupon—but not yet. Hawaii's vote by mail system makes it possible for the state to follow Colorado's example of randomly sampling and auditing *individual ballots*. For each ballot, an audit team records the votes they see, and then their finding is compared to how the voting system interpreted the ballot. (This is not possible in states where most people vote in person, because the voting systems shuffle the digital records to protect voter privacy.) This highly efficient approach makes it possible for Colorado to conduct risk-limiting audits of selected statewide and local contests in every county, as well as spot-check audits of every contest on every ballot in the audit sample. Risklimiting audits can provide strong assurance that reported winners really got more votes.

However, these ballot-level audits do involve larger procedural changes than batch audits. Election officials deserve time to design, test, and refine ballot-level audits thoughtfully and carefully in the best interests of Hawaii's voters. In the meantime, batch audits of paper ballots can provide a solid measure of assurance in vote counts.

I am grateful for the opportunity to share these thoughts with you. I and my colleagues would be delighted to work with Hawaii legislators and election officials on implementation specifics.
