## S.B. NO. 2403 RELATING TO GOVERNMENT ACCOUNTABILITY.

Hearing: Tuesday, February 6, 2024, 3:10 p.m.

The Office of the Auditor strongly supports S.B. No. 2403, Section 2, specifically, the procedures for consideration of performance audit reports issued by the Office of the Auditor as set forth on page 4 at lines 8-20. Section 2 of the bill will require a public hearing or informational briefing within one year after issuance of the report for each performance audit issued by the Office of the Auditor.

Our work primarily involves conducting performance audits, and the majority of that work is at the direction or request of the Legislature. Certain audits are performed on a recurring cycle, including the Office of Hawaiian Affairs at least every four years (Section 10-14.55, Hawai'i Revised Statutes) and the Hawai'i Tourism Authority at least every five years (Section 23-13, Hawai'i Revised Statutes).

Performance audits provide transparency into an agency's operations as well as an independent, objective, and unbiased assessment as to whether the agency is performing its work effectively, efficiently, and in accordance with its statutory requirements. The audit findings allow the Legislature to understand how a program that it created and funds is performing and to hold the agency accountable; the audit recommendations provide suggestions to the agency about how to address the findings and improve its performance. Performance audits also provide the public with information about the agency's work, most often funded through public funds.

We strongly agree that a public hearing or informational briefing is an invaluable means to inform the subject matter committees, the audited agencies, and the public about our performance audit findings.

Comments:

Requires any report of a study or an audit enacted with a legislative appropriation or adopted by concurrent resolution to be submitted to the President of the Senate, Speaker of the House of Representatives, the chairs of the appropriate subject matter committee of each house, and the Legislative Reference Bureau library. Requires a public hearing or informational briefing within one year of receipt of the report, except under certain circumstances. Requires a public hearing or informational briefing within one year of the publication of the performance audit reports. Exempts financial and other regularly occurring audits. Requires state departments and agencies to submit a report to the Legislature containing certain information regarding new, funded state programs within one year of the date on which the program's enabling Act became law
