SUBJECT: SB2688 RELATING TO INFORMATION ACCESSIBILITY

The Hawaii State Council on Developmental Disabilities **SUPPORTS SB2688**, which establishes the Access Hawai'i Advisory Committee to advise the Access Hawai'i Committee on how to improve accessibility to government information for people with diminished access to government information arising from disabilities. Requires the Access Hawai'i Committee to review the recommendations of the Access Hawai'i Advisory Committee, implement appropriate action to improve access to the government, and include in its annual report the Access Hawai'i Advisory Committee's recommendations and the Access Hawai'i Committee's actions relative to the Access Hawai'i Advisory Committee's recommendations.

This legislation is essential for ensuring that all residents of Hawaii, including those with inadequate access to government information due to disabilities, can fully participate in civic life and access the resources and services provided by the government. Establishing the Access Hawai'i Advisory Committee will provide a platform for individuals with disabilities to voice their concerns and recommendations regarding information accessibility, thus ensuring that their needs are adequately addressed and accommodated.¹

In Hawaii, like many other places, individuals with disabilities often face significant barriers when trying to access government information. This can include challenges related to physical

accessibility, such as navigating government websites that are not designed with accessibility features for individuals with visual impairments or other disabilities. Additionally, individuals with cognitive or developmental disabilities may encounter difficulties understanding complex government documents or forms. By establishing the Access Hawai'i Advisory Committee, we can work towards identifying and addressing these barriers, thus ensuring that individuals with disabilities have equal access to government information and services.²

The Access Hawai'i Advisory Committee will play a crucial role in advising the Access Hawai'i Committee on strategies to improve information accessibility and in monitoring the implementation of these strategies. By reviewing the recommendations of the Advisory Committee and taking appropriate actions to enhance access to government information, the Access Hawai'i Committee can ensure that Hawaii remains at the forefront of efforts to promote accessibility and inclusion for individuals with disabilities. This commitment to accessibility aligns with the values of equity and social justice that are fundamental to our state's identity.

The Hawai'i Civil Rights Commission (HCRC) supports the intent of S.B. 2688 and offers these

comments, which establishes an advisory committee to advise the Access Hawaii Committee on how to

improve accessibility to government information for people with disabilities.

The HCRC has enforcement jurisdiction over Hawai'i's laws prohibiting discrimination in

employment (Chapter 378, Part I, HRS), housing (Chapter 515, HRS), public accommodations (Chapter

489, HRS), and access to state and state-funded services (section 368-1.5, HRS). The HCRC carries out

the Hawai'i constitutional mandate that no person shall be discriminated against in the exercise of their

civil rights. Art. I, Sec. 5.

Access to government information is essential in our society, however, even with technological advances and sunshine laws, barriers still exist for individuals with disabilities attempting to access information released by government agencies. Barriers may include an unreasonable amount of time needed to access governmental information and time needed to sort through relevant and irrelevant information. This bill would work to address these issues for individuals with disabilities by establishing an advisory committee to improve accessibility to government information with diminished access due to and/or resulting from disabilities. The advisory committee would be made up of individuals who have experience with diminished access to government information arising from disabilities and the executive director of the Disability and Communications Access Board and a designee from the Department of Health and Human Services.

The HCRC supports the intent of S.B. 2688 in that it seeks to improve accessibility to government information and recognizes the challenges that individuals with disabilities may have in accessing information.

SENATE BILL 2688 RELATING TO INFORMATION ACCESSIBILITY

Dear Chairs McKelvey and San Buenaventura, and Vice Chairs Gabbard and Aquino, and members of the committees:

The Office of Enterprise Technology Services (ETS) supports the intent of SB2688 to improve accessibility to government information for people with diminished access to government information arising from disabilities. ETS offers a few comments on the bill.

ETS believes that we do not need to create another committee, the Access Hawaii Advisory Committee, to advise the existing Access Hawaii Committee regarding compliance and accessibility goals which can be driven by AHC itself by adopting and passing any needed standards. ETS and the Access Hawaii Committee have been very responsive to requests regarding accessibility of websites.

Accessibility of official State of Hawaii websites is of paramount importance to serving all citizens and enhancing that level of service in an increasing online environment. ETS strives to conform with Federal Section 508 and the Web Content Accessibility Guidelines (WCAG) 2.0 Level AA standard to measure accessibility and functionality of on-line content.

We suggest adding the Chairperson of the Disability and Communications Access Board under the Department of Health as a member of the Access Hawaii Committee to provide guidance on further accessibility.

Good afternoon chairs, vice chairs, and members. I am James Gashel, representing National Federation of the Blind (NFB) of Hawaii, testifying to support SB2688. Thank you for scheduling this hearing.

The purposes of this bill are to establish the access Hawaii advisory committee to advise the access Hawaii committee on how to improve accessibility to government information for people with diminished access to government information arising from disabilities; and require the access Hawaii committee to review the recommendations of the access Hawaii advisory committee, implement appropriate action to improve access to the government, and include in its annual report the access Hawaii advisory committee's recommendations and the access Hawaii committee's recommendations.

I am blind and use a screen reader to access the E-Hawaii web portal and all other websites. I also represent the National Federation of the Blind of Hawaii to present our collective lived experience.

If SB2688 is passed, the advisory committee will give us a way to raise concerns relating to lack of accessibility as they arise. Nothing like this exists at present, but it should.

I am also a member, appointed by the governor, to serve on the Statewide Voters with Accessibility Needs Advisory Committee. This advisory committee helps to make the Office of Elections aware of improvements needed to make the election processes more accessible to persons with disabilities. The law creating this election advisory committee was passed in 2021, and the committee was formed in 2022. As a result, it's now clear that Hawaii ranks among the top states in responding to disability access needs of voters in our state. The same can be true with access to other state services and information if SB2688 is passed.

One thought you may consider is to give the advisory committee a name to more clearly express its mission. My suggestion is: "Disability Access Advisory Committee," or "Advisory Committee on Disability Access." Either title will help to explain what this committee does relative to the Access Hawaii Committee.

SB2688 says disability access counts. We, members of the NFB of Hawaii agree and urge approval of this bill. Mahalo for your consideration.

Dear Chairs, Vice Chairs and Members of the Committees and all:

My name is Peter Fritz. I am an attorney, an individual with a disability and an advocate for individuals with disabilities who has filed several accessibility complaints against the State. I am testifying **in OPPOSITION** to SB 2688 because the Act 172 Workgroup is already working on development of statewide standards for accessibility. Another committee not necessary.

This bill would establish an advisory committee to advise the Access Hawaii Committee on how to improve accessibility to government information for people with disabilities.

The recommendations of the committee created under this bill would be limited because the duties of the Access Hawaii Committee (AHC) are to oversee the activities of the State of Hawaii's official Internet Portal Manager. This means that the proposed advisory committee's recommendations would be limited to activities and operation of the State of Hawaii's official Internet Portal.

A new advisory group is not necessary because a workgroup was created by Act 172 in 2022 to develop statewide accessibility standards. The Workgroup is chaired by Enterprise Technology Services (ETS). The Workgroup's purpose is to develop statewide electronic information technology accessibility standards for all state entities which would include the State's official Internet Portal. The formation of another committee proposing accessibility standards would delay the Act 172 standards because any standards proposed by the new committee created under this bill would require a review by the Act 172 Workgroup. While the Act 172 Workgroup has developed draft standards, the committee proposed in this bill has yet to start its work.

It has been said that too many cooks spoil the broth. Too many committees involved in proposing standards can ruin the development of uniform statewide standards and can result in a hodgepodge of conflicting standards and proposals that make compliance

impossible for State agencies. ETS has the knowledge and experience to develop the standards and ETS should continue to lead and the Act 172 Workgroup to develop a single and uniform accessibility standard for all state entities.

I respectfully request that this bill be held.
