## in consideration of SENATE BILL 2789 RELATING TO LAND USE.

Chairs Inouye and DeCoite, Vice Chairs Elefante and Wakai, and Members of the Senate Committees on Water and Land and Energy, Economic Development, and Tourism:

The Office of Planning and Sustainable Development (OPSD) **supports the intent** of SB2789, which would amend § 205-6 (a), Hawaii Revised Statutes (HRS), to allow film production in the State Agricultural District by special permit and add a new part to Chapter 201, HRS, to provide guidelines for film production on Agricultural lands and establish an oversight committee to monitor and enforce compliance with regulations on film permit activities on Agricultural District lands. OPSD offers **comments and amendments**.

The film industry is an important component of the State's efforts to diversify its economy. In addition, responsible film production in agricultural areas can showcase the cultural and historical significance of agricultural zoned lands. Furthermore, allowing film production can augment farmers' income to enhance the agricultural use of the land.

However, film production on agricultural land should not undermine the purpose of the State Agricultural District or hinder active agricultural crop production. Also, film set pieces or temporary structures transferred from the film production company to the agricultural land owner, once film production is completed, should not be used for non-agricultural or non-farm-related uses.

Therefore, OPSD **recommends amendments** to the proposed §201-D:

"(a) Film production on agricultural zoned lands is permitted pursuant to this part; <u>provided the land is not designated as Important Agricultural Lands under Chapter 205</u>, Part III, HRS, is not classified by the Land Study Bureau's classification system as productivity class A or B, and is not used for active agricultural crop production; provided that the film production company...

"(d) Upon the request of the owner of the agricultural zoned land, the ownership and maintenance responsibilities of any film set piece and temporary structure may be transferred from the film production company to the owner of the agricultural zoned lands; provided that the terms of the transfer require that the set piece and temporary structure only be used for agricultural or accessory uses to the farm and that the terms of the transfer are mutually agreed upon between both parties."

For proposed section 201-E, OPSD recommends that this section be deleted in its entirety. On page 2, lines, 14, 15, and 16, delete the definition of "Oversight committee" and on page 4 and 5, delete proposed section 201-E.

An Oversight Committee in DBEDT's Creative Media Division is unnecessary, time-consuming, and burdensome. The functions of the proposed Oversight Committee can be accomplished without codification. The county special use permit authority will provide the oversight envisioned in this measure.

> SENATE BILL NO. 2789 RELATING TO LAND USE

Chairs Inouye and DeCoite, Vice Chairs Elefante and Wakai and Members of the Committees:

Thank you for the opportunity to testify on Senate Bill 2789 that seeks to permit film production on lands that are zoned for agricultural use. The bill establishes with Chapter 201 (Department of Business, Economic Development, and Tourism) the Agricultural Film Production Land Use Oversight Committee to monitor and enforce compliance with regulations on film permit activities on agricultural lands as zoned by the counties and separate from the provisions of sections 205-2 and -4.5. The Department offers comments and an amendment.

This bill creates a law affecting land use within DBEDT (Chapter 201), with its own permit and regulatory function applicable only to agricultural zoned lands. This



appears to set a precedent that affects Chapter 205 (Land Use Law) and the implications, if any, should be made known.

This bill makes no specific provisions to address direct impacts of film production on agricultural operations on agricultural zoned lands. A "temporary" film production area in an active agricultural setting may be exposed to nuisances (dust, odors, noise from machinery and vehicles, vibration, etc.), especially from intensive agricultural cropping. Film producers need to work around the harvesting of row crops that cannot be put on hold for days or longer.

The proposed "Agriculture Film Production Land Use Oversight Committee" (page 4, line 3 to page 5, line 6) that is to be established within DBEDT's Creative Industries Division should have agricultural production/land use experts as this new regulatory function only affects agricultural zoned lands. The Committee should also ensure that agricultural operators on the agricultural zoned land for which a film permit is sought are consulted and compensated.

The bill needs to consider language limiting the number of these "temporary" uses on agricultural zoned lands and the frequency in which these uses are allowed (page 3, line 17 to page 4, line 2 and similar on page 5, lines 3-6). There also may be need for an acreage restriction for the "film production area" (page 2, lines 9-10).

The Department proposes the following amendment meant to protect agricultural lands and activities.

(page 2, lines 1-2; deletions are brackets, new language is underscored)

""Agricultural zoned land" means land designated for agricultural purposes under county zoning regulations[.] and is not designated as important agricultural lands, not where the soil is classified by the land study bureau's detailed land classification as overall (master) productivity class A or B, and not where there is active agricultural crop production."

## In consideration of SB2789 RELATING TO LAND USE

Chairs Inouye and DeCoite, Vice Chairs Elefante and Wakai and members of the Committee. The Department of Business, Economic Development and Tourism (DBEDT) supports the intent of the bill which; 1) provides an exemption for film production activites on lands that are zoned for agricultural use and 2) seeks to establish the Agricultural Film Production Land Use Oversight Committee to monitor and enforce compliance with regulations on film permit activities on agricultural zoned lands.

We defer to the Department of Agriculture (DoA), Office of Planning and Sustainable Development (OPSD) and Land Use Commission (LUC) to respond to the substantive sections of this measure which relate to their respective jurisdictional oversight.

The department supports the intent of SB2789 as there have been numerous instances where productions have had impediments when attempting to permit for filming on agricultural zoned lands.

The lengthy timeframe to obtain film permits on agricultural lands has prevented some productions going forward, particularly on the neighbor islands. This often results

in loss of business and jobs for our neighbor island communities looking to diversify their local economy through film production activity.

Showcasing Hawai'i's beauty also can be a direct benefit to ranch and farm owners, providing additional revenue streams for the temporary use, which can support their primary livelihood of their agricultural businesses.

We understand the need for an "Agricultural Film Production Land Use Oversight Committee" and recommend that the County Special Use Permitting process already in place should aso be fully explored.

Noting the duties of "enforcing compliance and regulations" are not in the department's statutory authority, this is best aligned with DoA, and other agencies to handle and execute these duties with recommendations by the oversight committee.

DBEDT will work with the introducers of this measure, the DoA, OPSD, LUC, the counties and communities to explore a mechanism to offer a more streamlined, effective film permitting process while maintaining protections for natural resources and culturally sensitive sites.

#### Providing comments in opposition

Dear Chairs Inouye and DeCoite, Vice-chairs Elefante and Wakai, and members of the committees:

This measure which seeks to allow film production on agricultural lands is well intended but as written does not account for the temporary nature of film production, and the fast pace of the industry. As such, the measure would not be effective in carrying out its intended purpose.

In addition, this measure could have unintended consequences, potentially conflicting with the City and County of Honolulu Revised Ordinances allows for Temporary Uses under section ROH 21-1.60. https://codelibrary.amlegal.com/codes/honolulu/latest/honolulu/0-0-0-18826

#### § 21-1.60 Temporary uses.

Uses and structures of a temporary nature shall not be governed by this chapter, unless the director determines that significant impacts upon the surrounding area warrant review and, when necessary, the imposition of conditions on the use or structure. Conditions shall be based on impacts upon the surrounding area, and may cover hours of operation, duration of the activity, and general manner of operation.

We humbly recommend a more streamlined approach, similar to other state statutes and the above be considered in which an exemption for the film industry is included in the appropriate chapter of HRS 205 that clarifies it is an allowable use and requires a permit from the appropriate state and or county film office. The film permitting process would be able to address the appropriate outreach and conditions based on the scope and scale of a project, and in a timely manner.

Aloha Chairs Inouye and DeCoite, Vice-Chairs Elefante and Wakai, and Members of the Committees:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau provides comments on SB 2789, which permits film production on lands that are zoned for agricultural use and establishes the Agricultural Film Production Land Use Oversight Committee to monitor and enforce compliance with regulations on film permit activities on agricultural zoned lands.

We strongly support revenue enhancement opportunities for farmers and ranchers. Fostering the profitability of farmers and ranchers will significantly contribute to the State's goal of increased self-sufficiency. However, we believe the primary purpose of the Agricultural District is production agriculture. Accessory activities should be subordinate to bona fide agricultural operations. We believe that other loosely related activities that merely use agriculture as a justification belong in the rural district. Counties should be encouraged to move in this direction, thereby protecting agricultural lands.

Film production within agricultural lands, if allowed, needs to be accessory and secondary to the principal agricultural use should not interfere with surrounding farm operations, and should apply only to a county that has adopted ordinances regulating film production on agriculturally zoned lands. We need to ensure that there is a clear process for allowing film production within agricultural lands and strong regulations and enforcement to prevent abuse.
