Aloha Chair Lee, Vice Chair Inouye, and members of the committee,

On behalf of Hawai'i Children's Action Network (HCAN) Speaks!, mahalo for the opportunity to testify in **STRONG SUPPORT of Senate Bill 2841** relating to Water Safety Day. I strongly support this bill to establish May 15 of each year as Water Safety Day to spread awareness of the drowning pandemic and to educate Hawai'i's youth about becoming safer in and around the water.

Drowning is the <u>leading cause of death</u> in Hawai'i for keiki ages 1-14, and Hawai'i ranks second in the nation for the rate of drowning among residents. No statewide education program in schools exists to teach children this essential life skill. Community organizations such as the International Water Safety Foundation and the American Red Cross know that water safety can be taught as a life skill. When children learn water safety skills and education, it could lessen the number of child drowning fatalities. Swimming proficiency in multiple aquatic skills is a way to stay safe in the water and also a requirement of personal aquatic safety competency by the <u>American Red Cross</u>.

All children who grow up in Hawai'i need access to life-saving aquatic safety skills. Creating more awareness of the importance of learning these skills is a step in the right direction toward healthier and safer keiki who live on our islands. This initiative is a vital step towards preventing drownings, saving lives, and protecting the well-being of our keiki. Mahalo for your support of this bill.

Re: SB 2841 - relating to Water Safety Day

Dear Chair Lee, Vice Chair Inouye and Senate Committee on Transportation and Culture and the Arts members,

I write to you today in **support** of Senate Bill 2841. This bill will designate May 15 of each year as Water Safety Day.

Through education and awareness of water safety, aquatic venues, natural and manmade, can be places of entertainment, exercise and relaxation. As the world's oldest and largest association representing the swimming pool, hot tub and spa industry, the Pool and Hot Tub Alliance considers swim safety and drowning prevention an utmost priority. In addition to the drowning statistics mentioned in the bill, nationwide, fatal drowning is the leading cause of death for children ages 1-4 and the second leading cause of unintentional injury death for children ages 5-14, behind motor vehicle crashes according to the Centers for Disease Control and Prevention (CDC).

With the passage of this bill, and in turn, the development and implementation of water safety education and awareness campaigns, children will have greater opportunity to equip themselves for when they interact in water environments. One study found that children ages 1-4 who learn to swim from a qualified instructor have a reduced risk of drowning by 88%. For every child under age 18 who dies from drowning, another 7 receive emergency department care for nonfatal drowning.

PHTA fully supports Hawai'i in the passage of this bill and taking steps towards educating children and families of the importance of water safety. We urge the committee for a favorable report.
