MEASURE: S.B. No. 2842 SD2

TITLE: RELATING TO WILDFIRE SAFETY AND PREVENTION.

DESCRIPTION: Establishes the Wildfire Mitigation Working Group within the Department of Land and Natural Resources to advise and make recommendations to state agencies concerning the State's wildfire safety and prevention efforts. Makes an appropriation. Declares that the appropriation exceeds the general fund expenditure ceiling for 2024-2025. Effective 7/1/2050. (SD2)

POSITION:

The Public Utilities Commission ("Commission") offers the following comments for consideration.

COMMENTS:

The Commission appreciates the intent of this measure to establish a Wildfire Safety Mitigation Working Group ("Working Group") that would advise and make recommendations to state agencies on issues concerning the State's wildfire safety and prevention efforts. The Commission appreciates the Senate Committee on Ways and Means' inclusion of the Commission's proposed amendments reflected in the SD2 of this measure.

The Working Group's advice and recommendations on the role of electric utilities in wildfire safety and mitigation will significantly enhance the Commission's ability to develop and review wildfire mitigation plans, assuming legislation that would require the

Commission to review and approve such plans is adopted (referenced in the SD2 as §269-).

Regarding Working Group membership as contemplated in the SD2 of this measure, the Commission further recommends members also include industry experts, academics, and persons with labor and workforce safety experience or other relevant qualifications and who represent a cross-section of relevant expertise including, members experienced in the safe operation, design, and engineering of electrical infrastructure.

The Commission suggests removal of the 2050 effective date and believes this bill should become effective on passage.

Senate Bill 2842 Senate Draft 2 establishes the Wildfire Safety Advisory Board within the Department of Land and Natural Resources (Department) to advise and make recommendations to state agencies concerning the State's wildfire safety and prevention efforts. **The Department provides comments on the bill, recommending the bill be merged with Senate Bill 2142 as written in the attached draft. The Department is supportive of the attached merged draft so long as it does not replace or adversely impact priorities indicated in the Executive FY 2025 Supplemental Budget Request.**

A BILL FOR AN ACT

RELATING TO WILDFIRE SAFETY AND PREVENTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the State recognizes
2 the increasing threat of wildfires to our communities, natural
3 resources, and economy, and that the State is committed to
4 proactively addressing this growing challenge through a
5 comprehensive and collaborative approach. Understanding the need
6 for a multifaceted strategy, the legislature further finds that
7 a working group comprised of government agencies, fire experts,
8 landowners, and stakeholders is required to find solutions that
9 address the State's wildfire preparedness and mitigation
10 challenges and increase the State's wildfire preparedness and
11 mitigation practices.

12 Accordingly, the purpose of this Act is to establish a
13 wildfire mitigation working group.

14 SECTION 2. (a) There is established a wildfire mitigation
15 working group to develop a state wildfire mitigation plan and to
16 advise and make recommendations to state agencies concerning the
17 state's wildfire safety and prevention efforts.

18 (b) The working group shall consist of the following

2 (1) The chairperson of the board of land and natural
3 resources, or the chairperson's designee, who shall
4 serve as co-chair of the working group.

5 (2) The chairperson of the state fire council, or the
6 chairperson's designee, who shall serve as co-chair of

8 (3) The director of the Hawaii emergency management
9 agency or the director's designee;

10 (4) The director of the office of planning and
11 sustainable development or the director's designee;

12 (5) The director of transportation or their designee;

13 (6) The director of taxation or their designee;

14 (7) A representative of the ranching industry, to be
15 invited by the chairperson of the state fire council;

16 (8) One member who shall be appointed by the president of
17 the senate;

18 (9) One member who shall be appointed by the speaker of
19 the house of representatives; and

20 (10) A representative of a Hawaii wildfire management
21 organization, to be invited by the chairperson of the
22 State fire council.

- 2 (1) Identify and map wildfire susceptibility and

1 SECTION 3. In accordance with section 9 of article VII of
2 the Hawaii State Constitution and sections 37-91 and 37-93,
3 Hawaii Revised Statutes, the legislature has determined that the
4 appropriations contained in Act 164, Regular Session of 2023,
5 and this Act will cause the state general fund expenditure
6 ceiling for fiscal year 2024-2025 to be exceeded by
7 \$ or per cent. This current declaration takes
8 into account general fund appropriations authorized for fiscal
9 year 2024-2025 in Act 164, Regular Session of 2023, and this Act
10 only. The reasons for exceeding the general fund expenditure
11 ceiling are that:

- 12 (1) The appropriation made in this Act is necessary to
13 serve the public interest; and
- 14 (2) The appropriation made in this Act meets the needs

Subject: Senate Bill (SB) 2842, Senate Draft (SD) 2, Relating to Wildfire Safety and Prevention

I am Kazuo Todd, Chair of the Hawaii State Fire Council (SFC). The SFC supports SB 2842, SD2, which establishes the Wildfire Safety Advisory Board within the Department of Land and Natural Resources to advise and make recommendations to state agencies concerning the State's wildfire safety and prevention efforts.

Wildfires are a serious threat to Hawaii's native ecosystems and wildland urban interface areas. Due to climate change and associated droughts, the annual area burned in Hawaii has grown in past decades. In fact, the percentage of land area burned annually in Hawaii exceeds the national average and, in some years, it surpasses the 12 most fire-prone western states.

The SFC recommends that the SFC Chair be allowed to designate a representative in their place as co-chair of the proposed advisory board, as fire chief duties are already extensive and may not permit full attention by the SFC Chair. The SFC supports SB 2842, SD2, to help assess and mitigate Hawaii's wildfire risks.

TESTIMONY FROM THE DEMOCRATIC PARTY OF HAWAII

POSITION: SUPPORT

The Democratic Party of Hawai'i **supports** SB 2842, SD2, relating to wildfire safety and prevention. Pursuant to the “Public Safety and Disaster and Emergency Preparedness” section of the Democratic Party of Hawai'i platform, the party supports “policy that protects the people of Hawai'i and their property against natural and man-made disasters,” and “believes that climate change is real, affirms human activity as its primary cause and main driver, and supports emergency preparedness and planning efforts to mitigate its impacts.”

Last year, we witnessed the impact of the climate emergency on our shores. On August 8, 2023, wildfires swept across Maui and killed at least 100 people, making it one of the nation's deadliest natural disasters. The spread of the fires has been attributed to climate change conditions, such as unusually dry landscapes and the confluence of a strong high-pressure system to the north and Hurricane Dora to the south.

The wildfires destroyed over 2,200 structures, including numerous residential buildings, historic landmarks, and school facilities. In September 2023, a report from the United States Department of Commerce estimated

the total economic damage of the wildfires to be roughly \$5.5 billion. According to a report issued by the University of Hawaii Economic Research Organization on September 22, 2023, the unemployment rate on Maui was expected to soar above 11 percent by the end of 2023 and remain above 4 percent through 2026. A total of 10,448 new claims for unemployment in Maui County were filed in the four weeks following the wildfires, about 9,900 more than the preceding four weeks. Displaced families and workers who lost their jobs are still attempting to recover from the disaster, with a full recovery expected to take many years to achieve.

Accordingly, we must do all we can to prevent tragedies like this from occurring again on our shores, including by investing in long-term planning and interagency coordination to mitigate future emergencies. The Hawai'i Emergency Management Agency released an updated State Hazard Mitigation Plan last November, in which the state's wildfire risk level soared 74 percent to 6.6 from its previous level of 3.8 in the 2018 draft of the report.

The updated hazard mitigation plan contains statistics on how many people by county are at risk from wildfire hazards. For Honolulu, 427,293 people could potentially be affected by wildfires, which was listed as the highest risk with a risk factor of 5.7. Maui County also has wildfires as its highest emergency risk with a score of 5.8 and 81,424 people at risk. On Kaua'i, wildfires carry a 5.6 risk level and threaten 27,604 people. Hawai'i Island has a wildfire risk score of 4.6 and 32,080 people at risk.

Wildfires are now designated as the top hazard in the state according to the updated HIEMA report. It is incumbent upon policymakers to respond with urgency to keep our communities safe.

In conclusion, Lahaina Strong **supports SB2842 SD2**, recognizing it as a vital initiative to enhance our state's wildfire preparedness and ensure the safety and well-being of our residents. Let us honor the memory of those affected by the Lahaina wildfire by taking decisive action to prevent such tragedies from occurring again.

The Maui Chamber of Commerce **SUPPORTS SB2842 SD2.**

The Chamber supports the intent of this bill and, coming from Maui, we truly appreciate all of the efforts to help our island and the rest of our state given the lessons learned from the August 8 wildfires. However, we see a lot of overlap in proposed bills (bills on funding equipment and creating numerous boards and workgroups (SB2808, SB2356, SB2842, SB2143, etc.). There are many ideas addressing the same/similar solutions. Some appear to overlap in personnel and equipment and other ideas may just need to be integrated into a comprehensive program. While we appreciate the intent of all wildfire-related bills, we are hoping they can be integrated into a more cohesive and comprehensive plan to avoid duplication and overspending and get the best return on our investment, given that taxpayers will be expected to pay more for these new investments.

Senate Bill 2356 (Establishes within the Department of Defense the position and duties of State Wildfire Marshal, the position and duties of State Wildfire Chief, the State Wildfire Corps, and the State Wildfire Fuel Reduction Task Force) is a bill that could encompass the cohesive and comprehensive plan. We believe elements of SB2842 could be included in the State Wildfire Fuel Reduction Task Force, like having 3 economists in the group. Additionally, we would like to see each islands' major Chamber of Commerce included in the group as well as 2 members from the business sector.

For these reasons we **support SB2842 SD2**, but **request that the House consider our comments on consolidation of bills into a comprehensive and coordinated plan.**

Aloha Chair Ichiyama, Vice Chair PoePoe, and Members of the Committee on Water and Land,

My name is Jackie Keefe and I am a Lahaina resident. I am writing in support of SB2842 with comments. Kala mai for my late testimony; as you know, it can be difficult to follow each of the bills that we care so deeply about.

Our State's preparedness for wildfire disasters is nowhere near where it needs to be. While I support the idea of this bill, it could use some work.

Back in November when the House Working Groups met to discuss various issues after the fire, my mentor Lieutenant George Purdy testified with some significant suggestions. He works for the Airport Fire Crew on Lana'i, and will not fight fires without his drones. They have not had a serious fire since he began implementation of this practice, and he has even been able to catch arsonists because of them. Drones are unmanned aircraft, meaning that they can fly in winds that our helicopters cannot. I hope someone revisits Lt. Purdy's November testimony and conversations that emerged from the working group. He has also been encouraging HIEMA to implement unified command protocols since back in September.

I also believe that the proposed Board needs more fire professionals. I would love to see leadership from our fire services on each island be included in this working group. They have the ability to see things in a way that the proposed Board simply would not.
