Aloha Chair Rhoads, Vice-Chair Gabbard, and Members of the Committee:

Thank you for the opportunity to submit testimony to **SUPPORT** SB2908 SD1.

The Hawai'i Emergency Management Agency is expressing its support for Senate Bill 2908 SD1, which aims to provide better guidance and protection for individuals impacted by emergencies such as wildfires. HI-EMA acknowledges that many people who still have housing available to them are facing predatory rental rate increases, while those who have lost necessities of life may also face unfair pricing for essential goods and services.

Under this legislation, predatory pricing in any form, including the sale of commodities at retail or wholesale levels, will not be tolerated during emergencies. Landlords will also not be allowed to terminate rental agreements unless there is a breach of a material term of the agreement or if the unit is unfit for occupancy. Additionally, landlords are prohibited from increasing rent for residential units in the affected area unless the increase was agreed upon in writing prior to the declaration of the emergency.

HI-EMA supports this legislation as it aims to reduce stress for individuals facing unforeseen emergencies and ensures that predatory pricing is not allowed. It also helps property owners and suppliers understand that unfair pricing practices will not be tolerated.

Aloha Chair Rhoads, Vice Chair Gabbard, and Members of the Committee:

My name is Lyndsey Garcia, Director of Advocacy, testifying on behalf of the Hawai'i Association of REALTORS[®] ("HAR"), the voice of real estate in Hawai'i and its over 11,000 members. HAR provides **comments** on Senate Bill 2908 SD1, which prohibits residential rent increases in affected areas for an unspecified period after a severe storm warning or issuance of an emergency proclamation. Takes effect 1/1/2042.

Under Hawai'i Revised Statutes §127A-30, whenever the Governor or a Mayor for their respective county declares a state of emergency, it automatically triggers a prohibition on "any increase in the selling price of any commodity, whether at the retail or wholesale level, in the area that is the subject of the proclamation or the severe weather warning." This provision also applies to rental housing.

However, the use of Emergency Proclamations has expanded in recent years and there is almost always an active Emergency Proclamation at any given time. Both consumers and businesses are often confused on whether price freezing needs to happen in a given situation and on what products.

HAR appreciates the intent of this measure to help address this issue with regard to rental housing; however, we prefer the original language in Senate Bill 2843 as it would help to address the wider business community's concerns surrounding the need to update the Emergency Powers statutes.

My name is Jackie Keefe and I am a resident of Lahaina. I am writing in support of SB2908 SD1 with request.

Thank you for choosing to make a decision on this bill. My request is that this act shall take effect upon signing.

Since the August 2023 wildfires, I have seen our housing reach a crisis point that I didn't know was possible.

We've had a housing crisis on Maui for years which has only been exacerbated by the loss of thousands of residential structures. I have been horrified at the loophole that landlords have been able to use to evict tenants, and we have seen and heard nothing from the Attorney General regarding enforcement. I have to hope that investigations take a while and these people will ultimately get held acountable! Unfortunately, that does nothing in the stress of the moment, when people don't know what recourse they have to fight illegal evictions.

We have seen landlords evict a tenant, say that they are going to be housing family, then simply that it "fell through" and charge a new tenant significantly more. If someone can pay it? Well, that's just too bad for those who can't! West Maui housing was already unaffordable.

Now you have places like Sunset Terrace in Honokowai charging over \$2100 for a studio apartment, but that doesn't include electric! The cost of electric has sky-rocketed, and that can be upwards of \$600/month for just a studio. This is one specific example, but that's how they all are. I list Sunset Terrace specifically because I know that they do not offer pest control services, so there are always cockroach infestations. This is especially true when someone moves out - they will treat that apartment, then the closeby apartments suffer. They continually raise prices without making upgrades like solar or efficient washing machines.

It is unacceptable that these private companies and corporations make huge profits from squeezing our working class. It is important that measures like this bill are put in place to place some form of controls on unbridled capitalism.

Testimony in Support of Senate Bill 2908: A Native Hawaiian Farmer's Perspective

As a proud native Hawaiian farmer, I am writing this testimony in strong support of Senate Bill 2908. This bill proposes important amendments to the Emergency Management Act, specifically regarding the duration and provisions of a state of emergency and local state of emergency declarations. I believe these amendments will greatly benefit our community, particularly in times of crisis and severe weather events.

Firstly, I would like to express my appreciation for the proposed amendment to Section 127A-14(d) of the Hawaii Revised Statutes. This amendment requires that any proclamation issued under the Emergency Management Act state the time at which it will take effect. This clarity is crucial for our community, as it ensures that we are fully aware of when a state of emergency or local state of emergency commences. By clearly defining the effective time, we can better prepare ourselves and take necessary actions to protect our families, properties, and livelihoods.

Furthermore, I wholeheartedly support the provision that automatically terminates a state of emergency and a local state of emergency sixty days after their issuance. This amendment, as outlined in Section 127A-14(d), ensures that emergency declarations do not unnecessarily persist beyond a reasonable timeframe. By implementing this automatic termination, we can strike a balance between addressing emergencies promptly and preventing any potential misuse of emergency powers. This provision safeguards against prolonged states of emergency, allowing our community to return to normalcy and begin the process of recovery and rebuilding.

Additionally, I commend the proposed amendments to Section 127A-30(a) of the Hawaii Revised Statutes. These amendments focus on protecting our community during emergencies, specifically in terms of pricing and tenancy. Prohibiting any increase in the selling price of commodities during a state of emergency is crucial in preventing price gouging and ensuring that essential goods remain accessible and affordable for all. This provision is especially significant for farmers like myself, as it ensures fair pricing practices and protects consumers from exploitation.

Moreover, the provisions outlined in Section 127A-30(a)(2) regarding tenancy during emergencies are essential for safeguarding the rights of tenants. By prohibiting landlords from terminating tenancy, except for valid breaches of rental agreements or when a dwelling unit is unfit for occupancy, this amendment offers crucial protection and stability for individuals and

I suggest this amendment because while Lahaina was devasted by the wildfire, prohibiting rent increases should apply to the island of Maui, not only the area subject to the proclamation (Lahaina). This way, regardless of how the governor declares the proclamation, the prohibition of rent increases will apply to the areas where victims may be searching for housing.
