Chairs Gates and Ichiyama, Vice Chairs Kahaloa and Poepoe, and Members of the joint Committees:

The Department of the Attorney General provides the following comments.

The purpose and intent of this bill is to: (1) require lessees and purchasers of farm lots and ranch lots to use that land for farming and producing food; and (2) authorize agricultural cooperatives to apply for farm lands. See S. Stand. Comm. Rep. No. 2260 (February 12, 2024).

Section 171-68, Hawaii Revised Statutes (HRS), enumerates, among other things, who may be considered a "bona fide farmer" to be eligible to apply to lease public state agricultural land. Although the intent of the bill appears to allow agricultural cooperatives to also be considered "bona fide farmers," the qualification in the proposed section 171-68(a)(2)(I) on page 8, lines 14-19, is ambiguous as currently drafted and requires clarification.

There are different ways to rephrase the provision. If the Legislature's intent is to allow agricultural cooperative associations formed under chapter 421 to be considered "bona fide farmers" if at least 51% ownership interest is owned by one or more members who qualify as bona fide farmers under section 171-68(a)(2)(A) through (H), HRS, the Department suggests deleting section 171-68(a)(2)(I) on page 8, line 14-19, and creating a new subsection (c) to read as follows:

(c) If the person is an association formed under chapter 421, the association shall have at least fifty-one per cent ownership by one or more members who satisfy the qualifications under subsection (a)(1) through (3) and who are not disqualified under subsection (b); and

(redesignate the current section 171-68(c) as section 171-68(d)).

If, alternatively, the Legislature's intent is to allow not only agriculture cooperative associations, but also any partnership, corporation, or association to be considered "bona fide farmers" if at least 51% ownership interest is owned by one or more members who qualify as bona fide farmers under section 171-68(a)(2)(I) on page 8, lines 14-19, then the Department suggests deleting section 171-68(a)(2)(I) on page 8, line 14-19 and creating a new subsection (c) to read as follows:

(c) If the person is a partnership, corporation, association, or agricultural cooperative association formed under chapter 421, the entity shall have at least fifty-one per cent ownership by one or more partners, shareholders, or members who satisfy the qualifications under subsection (a)(1) through (3) and who are not disqualified under subsection (b); and

(redesignate the current section 171-68(c) as section 171-68(d)).

The Department acknowledges the mandate in article XI, section 3 of the Hawaii State Constitution to "conserve and protect agricultural lands, promote diversified agriculture, increase agricultural self-sufficiency and assure the availability of agriculturally suitable lands." The Department's actions to implement article XI, section 3 of the Hawaii State Constitution include inspections of our agriculture and nonagriculture park lessees twice a year for compliance with lease terms that the lands are in agricultural production.

Aloha Chairs Gates and Ichiyama, Vice-Chairs Kahaloa and Poepoe, and Members of the Committees:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports SB 2960, SD1, which requires that lessees and purchasers of farm lots and ranch lots use that land for farming and producing food and authorizes agricultural cooperatives to apply for farmlands.

HFB advocates for public policies and incentives that provide for viable farming and ranching activities on agricultural lands, thereby retaining agricultural lands for future generations. Lands capable of supporting viable agricultural activities should be protected and kept in agriculture for agricultural production.

We support the retention of agricultural lands in blocks of contiguous, intact, and functional land units large enough to allow **flexibility** in agricultural production and management and discourage the fragmentation of agricultural lands to non-agricultural uses. Lands zoned for agriculture should be used primarily for productive agricultural purposes, including family farming.

The Hawaii Farm Bureau was part of the Stakeholders Group convened by the Office of Planning in response to Act 278, Session Laws of Hawaii 2019. The stakeholder group established the following goals: 1) Keep suitable agricultural lands for agriculture; 2) Support farmers and farming; 3) Keep agricultural lands affordable for farming; 4) Enable long-term access to agricultural lands for farmers, and 5) Minimize subdivision and CPR of productive agricultural lands except for bona fide agricultural reasons.

The Hawaii Farm Bureau supports policies that ensure agricultural lands are used primarily for productive agricultural purposes.

The Hawaii Farmers Union is a 501(c)(5) agricultural advocacy nonprofit representing a network of over 2,500 family farmers and their supporters across the Hawaiian Islands. **HFUU supports the intent and provides comments SB2960.**

We support SB2960 Farmers as it is crucial to ensure that farmland in Hawaii is utilized for farming and producing food. By requiring lessees and purchasers to use the land for agricultural purposes, we can help preserve valuable farmland and promote local food production. Additionally, authorizing agricultural cooperatives to apply for farmland will help strengthen the farming community and support collaboration among farmers.

However, we have concerns about the potential expansion of corporate personhood to programs that are meant to benefit bona fide farmers. This could potentially disadvantage small-scale and family farmers in favor of larger corporations. We also urge for flexibility in the income demonstration threshold, as unforeseen circumstances such as catastrophic crop failures could prevent farmers from meeting the required income levels. Including a force majeure clause related to natural disasters would help address this issue and provide necessary support to farmers during difficult times.

Aloha Chairs Gates and Ichiyama, Vice Chairs Kahaloa and Poepoe, and Members of the Committees,

I support SB2960 SD1 which requires that lessees and purchasers of farm lots and ranch lots use that land for agricultural production. This bill also authorizes agricultural cooperatives to apply for farmlands. It is important to ensure that all restrictions in this bill are feasible for farmers and ranchers to still allow for flexibility and innovation in their agricultural operations.

Keeping agricultural lands in agricultural production is essential to meet the state's goal of doubling food production by 2030 (Aloha +). Honolulu Civil Beat has reported that 2017 Federal data shows that only 8% of the state's agricultural lands were used for growing crops, 18.5% for grazing animals, 8% was woodlands and another 8% was categorized as "other," which includes farmsteads, homes, buildings and livestock facilities. Other land uses (tourism, residential, solar, etc) also hinder agricultural production in Hawaii. We have the opportunity to keep agricultural lands in agricultural production and it should be a priority for climate-smart goals to do so, but also for the environmental services they can provide.
