Currently, it is February toward the ending of the winter season. Our days were short and are getting longer. Currently, 6pm is still bright enough for residents to be working in their yard, and can do so till about 7pm. In the Summer months, the amount of sun available allows us to work in our yards till 8pm.

The one amendment I would suggest is amending the time that one can use their weed wacker to 7:00pm. I think that allows for enough time throughout the year to use our weed wackers, and yet ends early enough for their to be quiet time in residential areas.
