Chair Wakai and Members of the Committee:

The Department of the Attorney General (Department) strongly supports this bill and offers the following comments.

This bill amends section 134-9.6, Hawaii Revised Statutes (HRS), relating to annual reporting requirements on licenses to carry firearms concealed. The bill, among other things, deletes the reporting of demographic information of conceal carry license applicants including age, gender, and race; the reasons for revocation and denial; the analysis of denials based upon an applicants' failure to meet standards; recommendations to remedy any disparities in denial rates by age, gender, or race; and the number of violations of section 134-9.1, HRS.

To comply with the current statute, a statewide database would be needed to manage and maintain records related to the conceal carry application, review, and revocation process. The data needed for the annual report under the current statute must be collected at different points in the process—for example, when the application is submitted; when the application is subsequently granted, denied, or vacated; and, if applicable, when it is revoked during the four-year license duration. Because there are no resources to create a statewide database, the current statute creates an overly burdensome data-collection requirement for the county police, and an unattainable sixty-day deadline for the Department to vet the data submitted by the county police for

completeness and accuracy and to publish a report. Without a statewide database, the county police would need to manually enter the data collected twice, initially for their respective county police department purposes and a second time for submittal to the Department.

In addition to the problems associated with collecting the data, the Department does not have the resources to review case-specific narrative information to provide the analysis required under section 134-9.6 (a)(3), HRS. Under the current statute, the Department will be unable to provide an annual report with data that is vetted and complete.

The amendments in the bill will give county police departments more time to provide reportable data without time-consuming analysis of case-level records and will give the Department sufficient time to complete the annual report with its existing resources. An additional advantage to the amendments in the bill is that deleting some of the demographic information from the data to be reported will allow the report to provide data without attaching any unintended stigma to a particular age, gender, or racial group.

The bill also extends the date that the county police departments provide the data to the Attorney General from February 1 to March 31 of each year for the prior calendar year, allowing the county police departments additional time to provide the data to the Department.

Further, the bill deletes the reporting regarding the number of violations of section 134-9.1, HRS, Carrying or Possessing a Firearm in Certain Locations and Premises Prohibited. The report of these violations may require analysis of case-level records because violations of this section may be embedded in the narrative section of the police report. The analysis of case-level records will be overly time-consuming and place additional time and resource constraints on county police departments to complete the report.

We respectfully ask your Committee to pass this bill. Thank you for the opportunity to provide testimony.

Attention all legislative members,

You must oppose SB3349, SB3040, and SB3042 as these bills add unnecessary actions and expenses to existing agencies while also approaching and crossing over into violations of privacy of American citizens.

I would like to also point out that this is not the first time, or first SB bill, that I have written you about advising of the Constitutional violations and illegalities being proposed. I wrote you all, the Governor, Lieutenant Governor, and Attorney General back at the end of 2022, and a few times in early 2023, about the Constitutional violations contained within SB1230. I also advised you that if you did not opposed the bill, and instead voted it into law, there would be lawsuits which would cost the state and Hawaii tax payers money to fight. You all still ultimately voted and approved SB1230. I, along with another Hawaii couple, then proceeded to file suite against the State of Hawaii for constitutional violations contained within SB1230. A federal judge here in Hawaii agreed with me and issued a preliminary injunction on major portions of SB1230.

I am a law abiding American citizen, born and raised here in Hawaii. I do not like to continuously, each year, have to write testimony and fight legal battles to preserve my constitutional rights here in Hawaii. # NEW YORK STATE RIFLE & PISTOL ASSOCIATION, INC., ET AL. v. BRUEN, SUPERINTENDENT OF NEW YORK STATE POLICE, ET AL.

This legislature suggests that there is neither a need, or justifiable purpose, for ordinary law-abiding citizens to own semi-automatic rifles or ammunition magazines. This is fundamentally ridiculous. Our newspapers are filled with headlines of violent crimes, murders, and attacks. Waiting for Police to respond hasn't prevented victims from dying, yet armed citizens, do indeed, defend their own lives everyday in Hawai'i and across the Country.

Our State Constitution and National Constitution enshrine the people as the ultimate source of power, not the representatives of the people. That constitutions exist is proof enough that legislatures were never entrusted to be the sole arbiter of individual freedoms.

## Hawai'i State Constitution

## Article 1

Section 2. All persons are free by nature and are equal in their inherent and inalienable rights. Among these rights are the enjoyment of life, liberty and the pursuit of happiness, and the acquiring and possessing of property. These rights cannot endure unless the people recognize their corresponding obligations and responsibilities. [Am Const Con 1978 and election Nov 7, 1978]

Section 17. A well regulated militia being necessary to the security of a free state, the right of the people to keep and bear arms shall not be infringed. [Ren Const Con 1978 and election Nov 7, 1978]

In fact, there was a provision that was rejected for the Hawai'i constitution that "Declares right of the people to keep and bear arms for common defense and that the military shall be subordinate to civil authority." and so they abandoned a declared collective right in favor of the stated individual right that mirrors the Second Amendment of the United States Constitution. Also worth noting is the the individual right of the Constitution enshrined for "the people" in the Second Amendment is the same "people" proclaimed in the First Amendment, and the Fourth Amendment.

So fundamental is the right to keep and bear arms in defense of life, that most state constitutions also enshrined that right for their people.

## ~Other State Constitutions~

Pennsylvania - 1776 - That the people have a right to bear arms for the defence of themselves and the state; and as standing armies in the time of peace are dangerous to liberty, they ought not to be kept up

Vermont - 1786 - That the people have a right to bear arms for the defence of themselves and the State

Kentucky - 1792 - That the right of the citizens to bear arms in defense of themselves and the State shall not be questioned.

Ohio - 1802 - That the people have a right to bear arms for the defence of themselves and the State; and as standing armies, in time of peace, are dangerous to liberty, they shall not be kept up, and that the military shall be kept under strict subordination to the civil power.

Indiana - 1816 - That the people have a right to bear arms for the defense of themselves and the State, and that the military shall be kept in strict subordination to the civil power.

Mississippi - 1817 - Every citizen has a right to bear arms, in defence of himself and the State.

Missouri - 1820 - .. that their right to bear arms in defence of themselves and of the State cannot be questioned.

Connecticut - 1818 - Every citizen has a right to bear arms in defense of himself and the state.

Alabama - 1819 - That every citizen has a right to bear arms in defense of himself and the state.

Michigan - 1835 - Every person has a right to bear arms for the defence of himself and the State.

Texas - 1836 - Every citizen shall have the right to bear arms in defence of himself and the republic.

Oregon - 1857 - The people shall have the right to bear arms for the defence of themselves, and the State, but the Military shall be kept in strict subordination to the civil power.

Kansas -1859 - The people have the right to bear arms for their defense and security; but standing armies, in time of peace, are dangerous to liberty, and shall not be tolerated, and the military shall be in strict subordination to the civil power.

Florida - 1868 - The people shall have the right to bear arms in defence of themselves and of the lawful authority of the State.

Colorado - 1876 - The right of no person to keep and bear arms in defense of his home, person and property, or in aid of the civil power when thereto legally summoned, shall be called in question; but nothing herein contained shall be construed to justify the practice of carrying concealed weapons.

**Idaho - 1889 - The people have the right to bear arms for their security and defense**; but the Legislature shall regulate the exercise of this right by law.

Montana - 1889 - The right of any person to keep or bear arms in defense of his own home, person, and property, or in aid of the civil power when thereto legally summoned, shall not be called in question, but nothing herein contained shall be held to permit the carrying of concealed weapons.

South Dakota - 1889 - The right of the citizens to bear arms in defense of themselves and the state shall not be denied.

Washington - 1889 - The right of the individual citizen to bear arms in defense of himself, or the state, shall not be impaired,

Wyoming - 1889 - The right of citizens to bear arms in defense of themselves and of the state shall not be denied.

Utah - 1896 - The people have the right to bear arms for their security and defense, but the legislature may regulate the exercise of this right by law.

Oklahoma - 1907 - The right of a citizen to keep and bear arms in defense of his home, person, or property, or in aid of the civil power, when thereunto legally summoned, shall never be prohibited; but nothing herein contained shall prevent the Legislature from regulating the carrying of weapons.

Arizona - 1912 - The right of the individual citizen to bear arms in defense of himself or the State shall not be impaired, but nothing in this section shall be construed as authorizing individuals or corporations to organize, maintain, or employ an armed body of men.

New Mexico - 1912 - The people have the right to bear arms for their security and defense, but nothing herein shall be held to permit the carrying of concealed weapons.

Nevada - 1982 - Every citizen has the right to keep and bear arms for security and defense, for lawful hunting and recreational use and for other lawful purposes.

New Hampshire - 1982 - All persons have the right to keep and bear arms in defense of themselves, their families, their property and the state.

North Dakota - 1984 - .. to keep and bear arms for the defense of their person, family, property, and the state, and for lawful hunting, recreational, and other lawful purposes, which shall not be infringed.

West Virginia - 1986 - A person has the right to keep and bear arms for the defense of self, family, home and state, and for lawful hunting and recreational use.

Delaware - 1987 - A person has the right to keep and bear arms for the defense of self, family, home and State, and for hunting and recreational use.

Nebraska - 1998 - .. and the right to keep and bear arms for security or defense of self, family, home, and others, and for lawful common defense, hunting, recreational use, and all other lawful purposes

Wisconsin - 1998 - The people have the right to keep and bear arms for security, defense, hunting, recreation or any other lawful purpose.

In 1857 the United States Supreme Court issued the reprehensible Dred Scott decision. Supreme Court Chief Justice Roger B. Taney ruled that African Americans were not and could not be citizens. Part of his reasoning included that full citizenship "...would give them the full liberty of speech in public and in private upon all subjects upon which its own citizens might speak; to hold public meetings upon political affairs, and **to keep and carry arms wherever they went**. His obstant opinion is notable because it (rightly) assumes an right of an individual citizen to keep and carry arms as they so desire, stated so as a matter of fact that this right is equal to our other enumerated rights.

The reason so few Supreme Court decisions on the Second Amendment exist prior to the 20th century is precisely because it was so universally accepted as an individual human right.

Hawai'i is not the place it was 20 or 30 years ago. Even if there was no right to bear arms, and it could simply be regulated by 'need' as determined by this legislature, that need could not be causally dismissed by the history of our state. Undeniably, there has been a substantial increase in random and violent crimes, and the use of firearms and knives in the perpetration of criminal acts. In most cases weapons whose possession (and use) violate current laws. Simply put, criminals who disregard the current laws will disregard this one as well. If you disarm law abiding citizens you only protect and embolden violent criminals.

Arguments have been made that Hawaii has a special culture that would one damaged by an armed citizenry. There is no evidence for this. We've had an armed citizenery for over 100 years.

Distinctly, there are those who ignore the law and those who follow it. Demanding entire classes of weapons owned by a large population of the islands to become illegal is nothing but the slow repression of our freedom.

Self defense is already perilous in the State of Hawai'i. We already have an obligation to retreat, even in our homes. If our lives are put at risk, we are obligated by law to turn our backs to our attackers and run. Only when escape is impossible may we defend ourselves. Now this legislature, is pursuing an ideology of delay, deny, exclude, and divide to slowly eliminate that right to defend ourselves in even those last moments where self defense is the last option.

There is a element in this legislature that continually searches among kindred spirits in the most punitive and restrictive minority of States and finds no bad idea they wouldn't also like to try.

Hawai'i is destined to lose lawsuit after lawsuit. Bad law, lawsuit, appeal, reversal, followed by a similarly bad law, always at the real cost of it's law abiding and most productive citizens, is no way to govern.

It seems that actually addressing crime is the furthest from this legislatures desire or purpose. The classification 'Assault Rifles" is ridiculous branding and a false attempt to divide arms into meaningless categories then outlaw them one at a time, as cannot be done in a single stroke. The determination that a magazine capacity law will make our society safer is without merit. The cases we've seen on the Mainland (which are the small minority of gun crimes, gang activity being the largest cause of fatalities by far) all demonstrate a determined shooter seeks to commit crimes in areas where law-abiding citizens are restricted from carrying guns. They

usually carry multiple weapons, multiple magazines which this law will not affect. Once again, those intent on breaking the law and causing harm to others simply ignore these laws. You also can't argue that changing magazines gives time to stop a mass shooter, yet it's also not a burden to someone defending themselves.

Responsible and law-abiding citizens will speak here and now because we are not the problem. Yet once again, our freedoms are diminished by a government intent on repressing it's mostly peaceful population ostensibly to regulate the lawless violent few.
