Chair Marten, Vice Chair Amato, and Members of the Committee:

The Department of Corrections and Rehabilitation (DCR) **supports the intent** of Senate Bill (SB) 3094, Senate Draft (SD) 2, which proposes to establish a working group within the Office of Wellness and Resilience to create a statewide framework for peer support specialists.

DCR supports the intent of this measure for the following reasons:

- As the newly redesignated DCR, our focus is to shift from what historically has been a punitive model, to a rehabilitative, restorative, and reentry-focused system. In making this paradigm shift, peer support specialists, especially those with lived experiences, will play an integral role in the delivery of effective mental and behavioral health treatment.
- Research has shown that peer support is effective in reducing, among other things, substance use and depression. Many in our custody could benefit from peer support specialists who have lived through similar social, behavioral, and economic challenges. Creating a safe environment to share similar experiences will help to establish trust in others.

 Studies have also shown that peer support increases social functioning and social support. For those in our facilities, this type of assistance is key to successful reentry into the community. Such success may empower those released from our custody to become productive members of our community, thereby reducing recidivism.

The establishment of a working group to develop and make recommendations for a standardized framework for peer support specialists is a step in the right direction to serve individuals in need. However, this measure should not be allowed to negatively impact the priorities as outlined in the Governor's Executive Budget.

My journey has shown me just how crucial trauma-informed care and peer-to-peer support are, especially for individuals like me with developmental disabilities navigating systems like Child Welfare Services (CWS). I've been through multiple placements in CWS foster homes while trying to cope with overwhelming grief and trauma. It's crystal clear to me now that what's needed most is a compassionate and understanding approach to care.

Trauma-informed care has been a game-changer for me. It's all about recognizing how trauma affects every aspect of our lives and creating spaces that prioritize safety, trust, and empowerment. Given my past, understanding the roots of my trauma and knowing what might trigger it is absolutely vital for providing support that truly helps. Trauma-informed approaches don't just acknowledge what I've been through—they actively work to prevent any further harm by fostering environments of empathy and understanding.

Now, as a Grief and Trauma Facilitator at Kids Hurt Too Hawaii, I get to share my own journey of healing with others who are going through similar struggles. By opening up about my experiences with grief and trauma, I not only validate what others are going through but also

show them that there's hope and resilience on the other side. Peer support creates this incredible space where we can connect on a level that's deeper than words, sharing insights, coping strategies, and endless encouragement.

Bringing trauma-informed care and peer-to-peer support into organizations like Kids Hurt Too Hawaii is not just a nice to have, it is an absolute must. These principles don't just enrich the support we provide to individuals with developmental disabilities; they also create a sense of belonging and understanding that's so desperately needed. My dedication to this cause is fueled by the belief that these approaches can truly make a difference in nurturing healing and resilience, even in the face of the toughest challenges.

The Office of Wellness and Resilience (OWR) in the Governor's Office **STRONGLY SUPPORTS** S.B. No. 3094 SD2, Relating to Peer Support Specialists.

Established through Act 291 (Session Laws of Hawai'i 2022) the overall aim of the OWR is to make Hawai'i a traumainformed state. OWR is focused on breaking down barriers that impact the physical, social and emotional well-being of Hawai'i's people. OWR explores avenues to increase access and availability to mental, behavioral, social, and emotional health services and support.

Peer support specialists are people who have lived experience receiving services from systems of care that assist others experiencing similar situations. Peer support is one of the six guiding principles to a trauma-informed approach; through shared understanding, respect, and mutual empowerment, peer support specialists help people in their healing process. OWR strongly believes that increasing opportunities for peer support specialists to provide assistance in the healing journey of trauma-survivors is *an integral piece* of making Hawai'i a trauma-informed state.

S.B. 3094 SD2 establishes a working group that will develop a framework for peer support specialists in the State. Department of Health (DOH) currently administers the Hawai'i Certified Peer Specialist (HCPS) program that supports the recovery of people with mental illness. If this measure is passed, the State will have an opportunity to create a framework that will expand peer support beyond mental health. The bill proposes to do so by creating a working group consisting of State departments, community partners, and peers to collectively identify what they need to onboard peer support specialists in their departments, including training and certification. The OWR will be honored to assist with the creation of a framework that incorporates the voices of lived experience and expertise, including how the state can support peers support specialists in a trauma-informed, healing-centered way.

4 **Department Testimony:** The Adult Mental Health Division (AMHD) provides the following

5 testimony on behalf of the Department.

6 The Department supports SB3094 SD2, which proposes the creation of a working group 7 that will consist of state department decision-makers, community organizations, and people with lived experience to create a statewide framework for standardizing peer specialist roles, 8 9 ethics, training, and data measurements that demonstrate peer specialists support as an 10 invaluable and proven evidenced-based model of care. In addition, the Department supports 11 this bill's intention to identify supervision standards, develop a state inventory of certified peer specialists, and develop a sustainability plan to ensure current and future peer support 12 expansion and opportunities. 13

The AMHD offers two peer specialist training tracks: Hawai'i Certified Peer Specialist and Hawai'i Certified Forensic Peer Specialist. The training is provided for adults with lived mental health experience. Many also have lived experience with homelessness and forensic involvement, and most have been in long-term recovery from substance abuse issues. There

are 27 newly certified Hawai'i Certified Peer Specialists and 17 Forensic Peer Specialists 1 2 throughout the Islands. AMHD is the only program in Hawai'i that certifies adults with mental Illnesses as peer specialists. The Department of Child and Adolescent Division (CAMHD) trains 3 and certifies youth and parents with lived experience working with children with early serious 4 5 mental illness. The Alcohol and Drug Abuse Division (ADAD) trains and certifies peer specialists with lived experience recovering from drug abuse issues. This unique certification status allows 6 any peer specialist hired by any Medicaid-qualified agency to bill for their services. Until 7 8 recently, the Department was unaware of other peer specialist training programs in 9 communities throughout the State. The proposed working group would assist with ending this disconnect. The Department would be honored to participate and collaborate with the listed 10 11 participants in this measure.

12 The Department recognizes the following key points in SB3094 SD1 that ensure the 13 working group's efficacy:

The working group includes a representative from MedQUEST. Medicaid billing for peer
 specialist services is an enigma that only a few providers have figured out. This working
 group would support the sharing of this knowledge. Being able to bill Medicaid for peer
 support, rather than relying on temporary grants and special project state monies,
 would bring in funding for expanding peer specialist positions, allow for sustainability,

- 19 and save State funds for other needed projects.
- Provides an avenue to discuss and adopt supportive methods for supervision, self-care,
 and continuing education, creating peer specialists.
- Creates peer specialist empowerment, prevents professional fatigue, and encourages
 employment effectiveness and tenure.
- Identifies best practices for expanding and documenting peer support opportunities in
 all state agencies, not just those in mental and behavioral health.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) strongly supports this administration measure. DHS defers to the Office of Wellness & Resilience and the Department of Health.

PURPOSE: This bill establishes a working group to create a statewide framework for peer support specialists. Appropriates funds for hiring an administrative facilitator to provide necessary support for the peer support specialist working group in carrying out its duties and compensation for peer support specialists on the working group for time spent on working group meetings and related work and travel expenses. Declares that the general fund expenditure ceiling is exceeded. Takes effect 7/1/2112. (SD2)

The Committee on Government Operations (SD1) amended the measure by:

- (1) Clarifying that the chairperson may invite as members of the working group, two caregivers with lived experience as the caregiver of a child or youth in behavioral health, child welfare, or the juvenile justice systems;
- (2) Inserting an effective date of July 1, 2112, to encourage further discussion; and

(3) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.

The Committee on Ways and Means (SD2) amended the measure by changing the appropriation to an unspecified amount to facilitate further discussion.

The Department supports strengthening peer support specialists. DHS's Med-QUEST Division (MQD) recognizes the value of peer support specialists for many people whom the Medicaid program serves, including individuals suffering from mental health or substance use disorders, houselessness, or involvement with the justice systems. Peer support specialists can offer a level of acceptance, validation, and hope by sharing their own lived experiences. Thus, MQD welcomes the opportunity to participate in such a workgroup to make recommendations for a framework to expand and sustain peer support specialists in the State.

Chair Marten, Vice-Chair Amato, and Members of the Committee:

Hawaii law, HRS §334-10, established the State Council on Mental Health (SCMH) as a 21-member body to advise on the allocation of resources, statewide needs, and programs affecting more than one county as well as to advocate for adults with serious mental illness, children with serious emotional disturbances, individuals with mental illness or emotional problems, including those with cooccurring substance abuse disorders. Members are residents from diverse backgrounds representing mental health service providers and recipients, students and youth, parents, and family members. Members include representatives of state agencies on mental health, criminal justice, housing, Medicaid, social services, vocational rehabilitation, and education. Members include representatives from the Hawaii advisory commission on drug abuse and controlled substances and county service area boards on mental health and substance abuse.

The Hawai'i State Council on Mental Health continues to strongly support SB3094_SD2. Current reports within the Council and published literature have demonstrated the effectiveness of peer support specialists in improving quality of life and engagement of clients as well as reducing stigma and direct costs. This legislation represents a critical step forward in enhancing mental health services in Hawai'i by establishing a working group tasked with creating a comprehensive framework for peer support specialists.

We particularly commend the bill's focus on developing a framework that includes clear definitions, ethical guidelines, standardized training, and effective

EPIC 'Ohana is a non profit organization serving families and children in the child welfare system, and youth experiencing social and emotional challenges. We employ Parent Partners and Makua Allies. These are birth parents with lived experience in the child welfare system, and/or with perinatal substance use disorder. We also employ Youth Partners who work with the young people served by the Child and Adolescent Mental Health Division of the Department of Health, with foster youth served by Child Welfare Services, and youth served at the Youth Outreach Center for Homeless youth. What we have learned in the last few years is incredible power of lived experience to engage peers in services, and provide hope in ways that no one else can. The impact is tremendous. We also support the efforts of the Pū'ā Foundation to establish a culturally based certification and training program for peer support specialists in many arenas including justice involved men and women, and parents. And we partnered with the Early Childhood Action Strategy network and the Association for Infant Mental Health, Hawai'i, and Zero to Three Court to find ways to collaborate and integrate the services of peer support specialists into these services.

Peer support is an anchor in the articulated guiding principles of trauma-informed care. (Learn more about the benefits of peer support specialists: <u>https://www.samhsa.gov/brss-tacs/recovery-support-tools/peers</u>.) What we realize is that the tremendous impact of this work needs both champions and support. There are obstacles to the utilization of peer support in state agencies and in contracts with the state. There are nationally articulated standards for peer certification and training, that EPIC follows, but should be discussed across agencies. Employers, including state agencies, must have an understanding of how to effectively work with peer support specialists and integrate them into programs in ways that are trauma informed. Community based organizations and state agencies employing peer support specialists need sustainable funding sources. At this time, many of our programs are funded by short one, two, three, or at best six year demonstration or pilot project funding.

This bill proposes to identify best practices to expand peer support opportunities across the continuum of care, creates a framework for the collaborative expansion of peer support, allowing us all to work together to enrich our community with this vital service. This testimony is in support of <u>SB 3094, SD2</u> - RELATING TO PEER SUPPORT SPECIALISTS - which establishes a working group to create a statewide framework for peer support specialists. Appropriates funds for hiring an administrative facilitator to provide necessary support for the peer support specialist working group in carrying out its duties and compensation for peer support specialists on the working group for time spent on working group meetings and related work and travel expenses.

By way of background, the Pū'ā Foundation is a community-based non-profit organization that focuses on trauma, healing and justice work. We were created out of a powerful act of justice - through an apology, redress, reconciliation initiative of the United Church of Christ for their complicity in the 1893 overthrow of the Hawaiian government. We drive, 'Trauma to Transformation' programs for justice-involved women, girls and their families, especially Hawaiians. Our strategy to support women, and girls, especially Native Hawaiians that are dealing with system involvement, recovery issues, and trauma challenges is to start inside the prison or facility pre-transition, then connect resources post-transition - creating a seamless continuum of care. We have established key strategic public/private, faith-based, and community partnerships, and we incorporate peer support as a key trauma-informed care element. We currently lead the Peer Support Kokua Project, which focuses on developing the peer support workforce. The program includes the following components: leadership development, internship, certification, employment placement, continued support, and professional development. We've been working with the Women's Community Correctional Center (WCCC) since 2007; we were on the leadership team for the Trauma Informed Care Initiative at WCCC - 2011 & 2012; we led the Trauma Informed Care Initiative at Family Court, involving Kapolei Juvenile Detention Center, Hawaii Youth Correctional Facility & Home Maluhia Shelter - 2013, and we've been working at the Federal Detention Center since 2016. Through our experience in this area, Peer Support has become a focal point in our efforts to effectively connect resources to need for those exiting system involvement and reentering the community whether it be from prison, the youth facility, the detention center, court ordered programing, etc...

Establishing a working group to study this area would bring much needed attention to our Hawaii community about the effectiveness of peer support, all the while putting resources toward building up this identified area of best practice advocated for by the Substance Abuse Mental Health Services Administration (SAMHSA), as they have identified peer support as one of its six guiding principles of a trauma informed approach.

This bill establishes a working group to create a statewide framework for peer support specialists. It appropriates funds for hiring an administrative facilitator to provide necessary support for the peer support specialist working group in carrying out its duties and compensation for peer support specialists on the working group for time spent on working group meetings and related work and travel expenses. The bill declares that the general fund expenditure ceiling is exceeded, and takes effect on 7/1/2112.

Compensation is also vital to recognize the valuable time and expertise the team members will contribute to this important initiative.

On behalf of Hawai'i Children's Action Network (HCAN) Speaks!, mahalo for the opportunity to testify in **SUPPORT of Senate Bill 3094 SD2** relating to Relating to Peer Support Specialists.

SB3094 SD2 proposes the creation of a working group that will consist of state department decision-makers, community organizations, and people with lived experience to create a statewide framework to expand the role of peer support specialists within our state systems. The bill proposes to identify best practices to expand peer support opportunities in all state agencies, not just in the field of mental and behavioral health.

Peer support is one of the six guiding principles of trauma-informed care that has numerous positive behavioral outcomes. The Substance Abuse and Mental Health Services Administration (SAMHSA) cites peer support as effective workers who provide non-clinical, strengths-based support in non-judgmental practices that advance recovery for those in similar situations. This would also create a framework to expand peer support in a collaborative manner, allowing state departments, community partners, and peers to identify collectively what they need to onboard peer support specialists in their departments, including training and certification.

Establishing a working group within the Office of Wellness and Resilience would elevate the voices of those experts with lived experience in the child welfare system to lend their voices to the state in a trauma-informed, healing-centered way. I am a Hawaii Certified Peer Specialist. I have lived experience with a mental health condition and have gone through focused training to provide support to others who have similar challenges. I use my own experience to offer hope to others that it is possible to overcome labels tied to mental-health issues.

Since I am on Kauai, I went through peer specialist training online that was provided by the state Department of Health, Adult Mental Health Division. I also set up an internship at the Kauai Community Mental Health Center Branch.

While at the center, I was held to the same confidentiality standards as everyone else, and I passed the mandatory Health Department HIPAA training.

I am trained to inspire individuals to regain control of his or her own life, while at the same time I realize that I am not a replacement for case managers, social workers and psychiatrists. Instead, I collaborate with mental health professionals to see the person and not the diagnosis.

I would like the working group to explore Medicaid reimbursement rates for peer support services. That way, grants or other state monies could be used for other projects and programs.

Additionally, I would like the working group to explore how to best get peers paid for the work that they do. For example, should peers be onboarded as employees, or should they be vendors?

I have also served in previous healthcare administrative and social service roles gaining knowledge ranging from medical billing, medical office management, working for a health plan (Medicaid MCO), and also on the frontline as a MedQuest Kokua for the state assisting individuals and their families in accessing care. I have seen firsthand the efficacy of Peer Support Specialists in our community. I have also experienced how individuals being served have a natural gravitation and are more receptive to accepting assistance and information from someone who has once been in their shoes. I have also witnessed how much effort and funds have been invested into our communities from multiple government agencies and then witness how a Peer Specialist's lived expertise in navigating these systems alleviate financial burden leading to multi-system cost avoidance.
