The volunteer Task Force is directed to advise the State Health Planning and

attempt to describe the most promising, culturally acceptable, and achievable future of health

care in Hawai'i, which must also include long-term care. Clarity in these regards is sorely

14 needed.

The nation is adrift in terms of effectively addressing numerous problems in health care. These include how to deal with the gaps in access to care for millions of Americans, the unacceptable variation in quality of care from state to state and within states, glaring inequities in care for too many, a failure to effectively prevent disease and its progression, and an alarming rate of rising costs from an estimated national annual health care expenditure of 4.6 trillion dollars in 2023 to an estimated seven trillion dollars annually by 2030.

Hawai'i has a tradition of national leadership in health system innovation and reform, dating from the Monarchy's provision of health care to waves of immigrant agricultural workers, to the passage of the one-and-only state employer mandate guaranteeing health care for workers and their families in the Prepaid Health Care Act. We also have an advanced Med-Quest program, and many other innovations, dedicated providers, and community volunteers. That said, Hawai'i faces daunting workforce shortages; unacceptable gaps in access to primary and specialty care, particularly in rural areas and neighbor islands; inequities among our Native Hawaiian, Pacific Islander, and low-income kupuna and keiki populations; unnecessary administrative complexity; and rapidly rising costs. All of that must be addressed expeditiously.

While a short-term Task Force cannot be expected to solve all those problems, it can describe the current experience, thinking, priorities, and vision of both those charged with providing care here and those who receive it. This can inform our policy makers and suggest means to seek consensus around potential solutions that reflect the diverse communities and cultural values of our state.

To accelerate the deliberations of the Hui Ho'omana, SHPDA has already formed 4 new Advisory Councils that have been gathering information and expert, community-based, and neighbor island inputs around Keiki Care, Kupuna Care (and the future of long-term care),

- 1 Health Data, and achieving Universal Access. The more than 50 diverse advisors of these
- 2 councils formed in 2023 report to the Plan Development Committee of SHPDA's Statewide
- 3 Health Coordinating Council to organize background material around priorities they are
- 4 identifying for the Task Force and the state to consider. Many national private sector, federal,
- 5 and state health policy leaders have also expressed interest in offering virtual and in-kind
- 6 assistance to the process if desired.
- We believe the Hui Ho'omana Task Force will offer the Governor, the Legislature, state
- 8 agencies, and Hawaii's health sector valuable insights to accelerate our ability to realize the
- 9 Governor's "Hawai'i the Health State" vision, and so to become the first state to achieve
- universal access to high-quality, equitable, affordable health care for ALL.

AARP respectfully requests that our organization's name "American Association of Retired Persons" be amended to "AARP" under Section 2, Listing of the voting members (no. 13) on page 5.

Having access to quality, timely healthcare services and a robust healthcare workforce is critical to keeping all Hawai'i residents healthy and well. While there are approximately 279,000 Medicare beneficiaries in the Hawai'i, there are still many residents under age 65 who may be at risk of becoming uninsured should they quit their jobs prematurely to become family caregivers, become seriously ill or lose their jobs for other reasons which result in the loss of their health benefits. This is one example of the different gap groups that would benefit if Hawaii can improve its health care coverage for all. The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA <u>SUPPORTS</u> Senate Bill No. 3129, RELATING TO HEALTH.

By way of background, the HPCA represents Hawaii's Federally Qualified Health Centers (FQHCs). FQHCs provide desperately needed medical services at the frontlines to over 150,000 patients each year who live in rural and underserved communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of healthcare.

This bill, as received by your Committee, would establish the Hui Hoomana Task Force (Task Force) within the State Health Planning and Development Agency (SHPDA) to make recommendations that further the goal of state residents achieving universal access and equity to quality healthcare at an affordable cost. 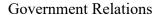

Kaiser Permanente Hawai'i provides the following COMMENTS on SB 3129.

Kaiser Permanente Hawai'i is one of the nation's largest not-for-profit health plans, serving 12.6 million members nationwide, and more than 274,000 members in Hawai'i. In Hawai'i, more than 4,200 dedicated employees and more than 650 Hawai'i Permanente Medical Group physicians and advance practice providers work in our integrated health system to provide our members coordinated care and coverage. Kaiser Permanente Hawai'i has more than 19 medical facilities, including our award-winning Moanalua Medical Center. We continue to provide high-quality coordinated care for our members and deliver on our commitment to improve the health of our members and the 1.4 million people living in the communities we serve.

The State of Hawai'i has been a pioneer among the states in healthcare for decades. Notably, the Legislature's passage of the Hawai'i Prepaid Health Act (PHCA) in 1974 was the first in the nation to set minimum standards of healthcare coverage for workers. Under the PHCA, Hawaii has long boasted low uninsured rates. With the enactment of the ACA in 2010, many more residents obtained affordable health insurance. As part of one of the nation's largest nonprofit integrated health care systems, Kaiser Permanente Hawai'i seeks to make healthcare more affordable and available to everyone.
