Measure: SB3207 SD1 Relating to Education

Aloha Chair Dela Cruz, Vice Chair Moriwaki, and Members of the Committee:

The Board of Education ("Board") is in <u>strong support</u> of Senate Bill 3207 SD1, which makes permanent the superintendent's annual performance evaluation requirements and makes permanent the changes made by Act 90, Session Laws of Hawaii (SLH) 2014.

Ten years ago, Act 90, SLH 2014, increased the salary cap of the superintendent of education and required that the superintendent be subject to an annual performance evaluation, based on outcomes determined by the Board, and which are in alignment with other employee evaluations within the Department of Education.

However, these changes are scheduled to be repealed. As a result, beginning July 1, 2024, if statute is not amended, the current \$250,000 cap will revert to the previously set amount of \$150,000, and the statutory requirement for an evaluation of the superintendent will be eliminated.

The Board respectfully offers the following:

- If current statutory language is not made permanent, there will be impacts on future contracts with the superintendent and hindrances to future recruitment.
- If current statutory language is not made permanent, there will be impacts on the salaries of the deputy superintendents, assistant superintendents, and complex area superintendents, which cannot exceed that of the superintendent, pursuant to statute.

• The Board has utilized an annual evaluation process to review the superintendent's performance against a set of approved targeted goals and would like to continue with this process.

Testimony in Opposition of Hawaii Senate Bill SB3207

Statement of Position: This testimony is written to express strong opposition to **Senate Bill SB3207**, which pertains to increasing the superintendent of education's salary cap to not more than \$300,000, exceeding that of the Hawaii governor's salary of \$165,048. This bill is unreasonable, unnecessary, and unjustified.

Background Information: SB3207 aims to amend the Hawaii Revised Statutes to allow the board of education to set the superintendent of education's salary at a level not to exceed \$300,000 per year, effective July 1, 2024. The bill claims that this measure is necessary to attract and retain qualified candidates for the position of superintendent of education. However, this bill is unreasonable, as it would create a huge disparity between the superintendent's salary and that of other state officials and employees, including the governor. It is also unnecessary, as the current salary cap of \$240,000 is already sufficient and competitive. It is also unjustified, as there is no evidence that a higher salary would improve the performance or outcomes of the superintendent of education.

Specific Arguments and Evidence:

1. Unreasonableness and Disparity:

- SB3207 would create a huge disparity between the superintendent's salary and that of other state officials and employees, including the governor.
- <u>The governor of Hawaii, who is the chief executive of the state and has many</u> responsibilities and duties, earns \$165,048 per year as of 2021, the 15th highest among the 50 states1.
- The proposed salary cap of \$300,000 for the superintendent of education would be 82% higher than the governor's salary, and would make the superintendent the highest-paid state official in Hawaii by far.
- The proposed salary cap of \$300,000 would also be higher than the salaries of the U.S. president (\$400,000), the U.S. vice president (\$235,100), and the U.S. secretary of education (\$221,400) as of 2021.
- The proposed salary cap of \$300,000 would also be higher than the average salaries of superintendents of education in other states, which range from \$95,000 to \$275,000 as of 20202.

• SB3207 would create an unreasonable and unfair disparity between the superintendent's salary and that of other state officials and employees, who also work hard and contribute to the public good.

2. Unnecessariness and Competitiveness:

- SB3207 is unnecessary, as the current salary cap of \$240,000 is already sufficient and competitive for the position of superintendent of education.
- The current salary cap of \$240,000 is higher than the median household income in Hawaii, which was \$83,102 as of 20193.
- The current salary cap of \$240,000 is also higher than the average salaries of teachers in Hawaii, which ranged from \$49,100 to \$63,500 as of 20204.
- <u>The current salary cap of \$240,000 is also higher than the salaries of most</u> <u>complex area superintendents and assistant superintendents in Hawaii, who earn</u> <u>between \$165,000 and \$205,000 as of 20235</u>.
- The current salary cap of \$240,000 is also competitive with the salaries of superintendents of education in other states, especially considering the cost of living and the size of the student population in Hawaii.
- SB3207 is unnecessary, as the current salary cap of \$240,000 is already sufficient and competitive for the position of superintendent of education, and does not need to be increased.

3. Unjustifiedness and Performance:

- SB3207 is unjustified, as there is no evidence that a higher salary would improve the performance or outcomes of the superintendent of education.
- The superintendent of education is responsible for overseeing the state's public school system, which enrolls about 155,000 students as of 20236.
- The superintendent of education is accountable for the academic achievement, fiscal management, and operational efficiency of the public school system.
- The superintendent of education is expected to implement the board of education's policies and vision, and to collaborate with various stakeholders, such as the governor, the legislature, the department of education, the teachers, the parents, and the community.
- The superintendent of education is evaluated by the board of education based on multiple criteria, such as student learning and growth, organizational effectiveness, leadership, and innovation.
- SB3207 is unjustified, as there is no evidence that a higher salary would improve the performance or outcomes of the superintendent of education, or that the current salary is a barrier to attracting and retaining qualified candidates.

Conclusion: This testimony urges the legislature to reject SB3207. This bill is unreasonable, unnecessary, and unjustified, as it would create a huge disparity between the superintendent's salary and that of other state officials and employees, including the governor. It would also increase the state's spending without any evidence of improved performance or outcomes. The current salary cap of \$240,000 is already sufficient and competitive for the position of superintendent of education, and does not need to be increased.
