Requesting stakeholders to update the East-West Center study titled "Hawai'i as an East-West bridge: a survey of the economic value of non-tourist international activities in Hawai'i".

In consideration of SCR145/SR123 REQUESTING STAKEHOLDERS TO UPDATE THE EAST-WEST CENTER STUDY TITLED "HAWAII AS AN EAST-WEST BRIDGE: A SURVEY OF THE ECONOMIC VALUE OF NON-TOURIST INTERNATIONAL ACTIVITIES IN HAWAII".

Chairs DeCoite and Kim, Vice-Chairs Wakai and Kidani, and members of the Committees. The Department of Business, Economic Development & Tourism (DBEDT) supports SCR 145/ SR 123 that requests stakeholders to update the East-West Center Study titled "Hawaii As An East-West Bridge: A Survey Of The Economic Value Of Non-Tourist International Activities In Hawaii".

Non-tourist international activities play a major role in Hawaii's economy. These activities take the form of educational exchanges, conferences, seminars, sporting events, sister state relations, cultural exchanges, training, defense related events, and other activities.

These activities build upon our existing assets of being a muti-cultural, multiracial community and our strength of location in the Pacific region related to military



affairs, relations with the islands of the Pacific, and Pacific-oriented government and diplomatic activities.

Hawaii is a premiere destination. <u>The East West center was created in 1960 by</u> <u>Congress to grow healthy diplomatic ties with the East & West nations to foster</u> <u>cooperation, training & research.</u> International economic activity draws in income from abroad. The research studies non-tourist international activity in Hawaii such as high technology, filmmaking industry, fashion design, fish & candy imports, aquaculture & agricultural research.

Hawaii is also an international arts & culture destination with racially diverse ethnic minority groups and premiere cultural museums. The strategic goals outlined in the study are similar to the strategic goals in Hawaii Tourism Authority's <u>Destination</u> <u>Management Action Plan</u> which rebuilds, redefines & resets the direction of tourism to focus on cultural resources & sustainable tourism. Although East West Center's focus is non-tourist activity, the study should consider the strategies outlined in HTA's DMAP to enhance cultural diversity & economic activity which will further strengthen foreign markets within the State while providing diversified economic advantages as well as creating strong international ties with other nations. These goals will be advantageous in improving quality of life while improving visitor experience.
