Comments:

We are in strong support. I first became aware of this issue from one of the members of my Board of Directors who has had multiple problems over the years dealing with her daughter who has a mental illness. She has had behavioral issues and at times has severely decompensated. On a specific occasion some years ago her doctor thought to check her thyroid function and remarkably found that when her thyroid medication was adjusted her behavior dramatically improved. It turned out that that had a lot to do with the root causes of her issues and that the psychotropic medication she had been prescribed was not only not the solution, but also part of the problem.

For that reason she and I have been on a bit of a mission to let people know and to encourage all prescribing medical professionals to conduct an initial simple blood test for thyroid function to either rule that in or rule that out as a potential cause or contributing factor before prescribing a psychotropic medication. My hope with this Resolution is that we can educate the public and more specifically encourage the medical profession to incorporate thyroid testing into their protocols prior to prescribing psychotropic medications.

6 MONTHS LATER CASTLE, NEW DR. NEW MEDS LITHIUM/PROZAC 8 DAYS LATER SHE'S A VEGETABLE, NO MOVEMENT AT ALL, FOR 8 MONTHS!

Hello, my name is Kiana Regets and I support this bill. As someone who struggled with mental health issues during her teen years and early twenties I believe testing for thyroid functions and levels is extremely important. During those years with mental healt concerns my thyroids were never tested and during my early twenties I was diagnosed with thyroid cancer, papillary carcinoma specifically and hypothyroidism. Hypothyroidism can have comorbidity with depression and can affect mood which include anxiety or depression. I think that if I had been checked for thryoid issues earlier a lot of stress could have been avoided and preventative care could have been put in place. I strongly believe that having individuals check their thyroid levels before starting medications for mental health concerns can be extremely beneficial. For example: Studies show that if you have both hypothyroidism and depression, thyroid-replacement medications may work better than antidepressants.
