Aloha Chair Ichiyama, Vice-Chair Poepoe, and members of the committee:

I am Frank Pace, Administrator for the Hawai'i Office of Homeland Security. Thank you for the opportunity to submit testimony in **SUPPORT** of HB1035.

This bill would establish protections for critical infrastructure information that is received or maintained by the Office of Homeland Security (OHS) – on behalf of the State of Hawai'i - for use regarding the security of critical infrastructure and protected systems, analysis, warning, interdependency study, recovery, reconstitution, or other informational purposes.

To succeed in the legislated responsibilities of the State regarding protection of critical infrastructure under chapter 128A, Hawai'i Revised Statutes, it is necessary to establish state-based protections for critical infrastructure information.

The protections offered by this bill will enhance sharing of critical infrastructure information between infrastructure owners and operators and the state government. Critical infrastructure information protected under the bill is crucial for OHS for direct support of the security and resilience of the State of Hawaii. The protections will provide homeland security partners reassurance that their proprietary information provided to the State of Hawaii government will be protected.

Thank you for the opportunity to submit testimony on this bill, which would create a confidentiality requirement for "critical infrastructure information" held by the Office of Homeland Security. "Critical infrastructure information" would be defined to include only "information not customarily in the public domain[.]" The Office of Information Practices (OIP) offers comments and an **amendment** of this measure.

Rather than leave open the question of what is and is not customarily in the public domain, OIP recommends that the definition should instead refer to the existing standard set by the Uniform Information Practices Act (UIPA), chapter 92F, HRS, for what government records are considered public. To amend the definition to include only information that is **not publicly available** under the UIPA, bill page 2, lines 13-15 should be amended so that the definition begins:

"Critical infrastructure information" means information not subject to public disclosure under chapter 92F and related to the security of critical infrastructure or protected systems....
