## Testimony in SUPPORT of HB1078 RELATING TO THE WATER POLLUTION CONTROL SPECIAL FUND

1 Fiscal Implications: Filing fees for Clean Water Act Section 402 National Pollutant Discharge

2 Elimination System permits and Clean Water Act Section 401 Water Quality Certifications

3 (WQC) will go to the newly created special fund instead of the general fund.

4 **Department Testimony:** The Department of Health (Department) strongly supports HB1078

5 which will create a supplementary funding source for the Department to implement and enforce

6 NPDES permits, WQCs, and variances. Establishing this special fund will dedicate the

7 approximately \$250,000 of filing fees collected annually through various filing fees to the

8 Department to manage, protect, and restore State water quality.

9 The State of Hawaii is responsible for managing, protecting, and restoring approximately

10 303 miles of recreational shoreline, 3,326 miles of rivers and streams, and 37 square miles of

11 bays and harbors – a total of 565 marine water bodies statewide, only 170 of which were

12 assessed from 2019 to 2021 (30%). Of the 170 assessed water bodies, 157 (92%) do not fully

13 attain water quality standards for one or more parameters.

14 As set forth in section 342D-13, Hawaii Revised Statutes, fees collected are imposed to

15 cover the cost of issuing, implementing, and enforcing permits and variances, but such fees are

16 deposited to the general fund, requiring the Department to incorporate the cost of those

17 responsibilities in its annual budget request. Depositing these fees directly into a fund with a

18 dedicated purpose allows those moneys to be used by the Department to fund more

19 implementation and enforcement activities and generally be more responsive.

- 1 This proposal does not create new or increased filing fees imposed on applicants for
- 2 NPDES permits, WQCs, or variances, therefore, there is no increased financial impact to the
- 3 regulated community.
- 4 The Department strongly supports this bill to benefit the water quality of State waters and
- 5 to better protect public health.
