Requires the department of education and university of Hawaii to assign appropriate staff to coordinate with the public access room for the outreach and engagement program. Appropriates funds for one full-time equivalent (1.0 FTE) position to assist in effectuating this requirement. Effective 6/30/3000. (HD1)

Department's Position:

The Hawaii State Department of Education (Department) respectfully provides comments on HB 1192, HD1, which requires the public access room to establish and maintain an outreach and engagement program for primary, secondary, post-secondary, and community education. This bill requires the Department of Education to assign appropriate staff to coordinate with the Public Access Room with respect to the outreach and engagement program.

The Department supports the focus on civic engagement with an appropriation to fund a full-time position at the Public Access Room; however, the Department has concerns regarding the responsibility for outreach and engagement. Requiring the Department to coordinate with the Public Access Room staff would place a burden on the Department to assign staff and initiate such outreach. Currently, the Department does not have a position dedicated solely to civic education, and the Educational Specialist for Social

Studies has statewide responsibilities related to social studies in all social studies disciplines.

The Department would ask that, if passed, this bill would place the responsibility for outreach on the Public Access Room with any coordination requests due to the position that is being provided to them.

Bill No. and Title: House Bill No. 1192, H.D. 1 Relating to Advancing Civic Engagement

Purpose: Requires the public access room to establish and maintain an outreach and engagement program for primary, secondary, post-secondary, and community education. Requires the Department of Education (DOE) and University of Hawaii (UH) to assign appropriate staff to coordinate with the public access room for the outreach and engagement program. Appropriates funds for one full-time equivalent (1.0 FTE) position to assist in effectuating this requirement.

PACE Commission Position: Support

The PACE Commission supports this bill, which would: (1) revise Hawaii Revised Statutes (HRS) § 21G-2 to add that "[a]s part of its duties, the public access room shall establish and maintain an outreach and engagement program for primary, secondary, post-secondary, and community education"; and (2) appropriate funds to establish a full-time position within the Public Access Room.

With regard to amendments in the H.D.1 version of the bill, requiring the DOE and UH to assign staff to coordinate with the Public Access Room, the PACE Commission appreciates the focus on engagement and coordination between entities, but also recognizes that a lack of resources to support civics is a challenge across the state. For instance, in HB741

(which was passed by the House Committee on Education), there is a proposal to provide funding to the DOE to support civic education and to establish two full-time civic education resource teacher positions. Currently, there is no full-time position in the DOE focused solely on civic education. Rather, an Education Specialist with broad responsibilities in social studies, as one part of those duties, supports civic education state-wide for grades K-12. Similarly, the Commission is not aware of any position in the UH System focused solely on civic education. Thus, the PACE Commission supports enhancing resources for civic education.

With regard to amending HRS § 21G-2, establishing the outreach and engagement program in the Public Access Room, this would have a significant impact in reaching and educating students and citizens across the state about the Legislature. It is also crucially important to have a dedicated position to focus on this important effort, and thus it will be highly beneficial to have funds appropriated to establish the full-time position in the Public Access Room. These crucial steps would create a positive and focused engagement with students, educators and citizens to promote learning about the Legislature, understanding of and participation in the legislative process, and further interaction with Legislators. The more direct contact that students, educators and citizens can have with the Legislature, and the more they can see the process in action, the more they will understand and want to participate in this key part of our democracy. The proposals in House Bill 1192 clearly advance the purpose of the Public Access Room to "ensure improved public participation in the legislative process" set forth in HRS § 21G-1.

Although there are many in our community seeking to advance civics in different ways, having a full-time dedicated position within the Legislature will be a tremendous asset. Such an individual could also collaborate with the Judiciary History Center to bring diverse programming on civic education to students and the community. Moreover, in today's virtual world, having a dedicated position in the Public Access Room would greatly assist students, educators and others with following bills online, watching videoconference hearings, and submitting testimony on issues important to them.

Brief background about the PACE Commission:

The PACE Commission was created pursuant to Rule 23 of the Rules of the Supreme Court of the State of Hawai'i, issued on January 7, 2021, with a purpose to promote and advance civic education for students and citizens throughout Hawai'i. The commission has fourteen members appointed by the following: Chief Justice of the Hawai'i Supreme Court, Governor, President of the Senate, Speaker of the House, Office of Hawaiian Affairs, Superintendent of the Department of Education, Chief Judge of the U.S. District Court for the District of Hawaii, President of the University of Hawai'i, Dean of the William S. Richardson School of Law, Hawaii State Bar Association, Hawai'i Association of Independent Schools, and two members selected by the other appointed members.

The mission statement adopted by the PACE Commission is: "To create, implement and amplify sustainable programs, resources, and practices that improve place-based, constitutionally informed and culturally sensitive civic education and engagement in Hawai'i schools and communities."

The University of Hawaii (UH) supports the intent of this measure as it provides educational outreach and engagement programs through the Public Access Room under the Legislative Reference Bureau and supports efforts to enhance civic engagement throughout the state.

However, the bill in its current draft mandates the Department of Education and the University of Hawai'i assign appropriate staff to coordinate with the Public Access Room with respect to outreach but provides no funding to allocate staffing for this purpose. UH is unsure what the Public Access Room is envisioning with its outreach and engagement program. With this uncertainty, UH has reservations about having this language put into statute to mandate this coordination. Having said this, if it is the desire of the Legislature to pass this measure, UH respectfully requests an appropriation and positions to provide the University the ability to effectuate the requirements of this measure.

Hawaii Youth Services Network supports HB 1192 HD 1 Relating to Advancing Civic Engagement.

"Youth civic engagement leads to reduced risky behavior, increased success in school and leads to greater civic participation later in life.... Civic engagement provides young people with opportunities to gain work experience, acquire new skills, and to learn responsibility and accountability—all while contributing to the good of their communities. "¹

Introducing youth to civic involvement at an early age is important because Hawaii voter turnout has declined in recent years. In the past 5 out of the past 6 presidential elections, Hawaii had the lowest voter turnout of all the states. In 2020, Hawaii was one of the 10 lowest states in voter turnout. Voter participation is at the core of active citizenship and a healthy democracy.

Hawaii Youth Services Network coordinates the annual Hawaii Children and Youth Summit, in which youth are provide recommendations to legislators about what Hawaii needs to be a better place to live, learn, and work. In 2023, youth recommendations about vaping prevention and intervention and sexual abuse and exploitation training for teachers have been incorporated into the Keiki Caucus package of bills.

If the program is funded, HYSN would work in partnership with the Public Access Room and the Department of Education to engage youth in civic affairs. The young people who have participated in the Children and Youth Summit find the experience empowering, and their involvement leads to continued engagement as adults.

I will close with some quotes from Hawaii's youth that have participated in the Hawaii Children and Youth Summit,

"This was my first experience in attending a meeting with other youths where our voices matter. . . . I want to make a difference and attending the Summit gave me the courage to step out and share everything I've learned with my fellow students. I know I will never stop speaking up for what is right."

Community Alliance on Prisons appreciate this opportunity to testify in strong support of HB 1192 HD1 that requires the Public Access Room to establish and maintain an outreach and engagement program for primary, secondary, postsecondary, and community education. And also requires the Department Of Education and University of Hawai'i to assign appropriate staff to coordinate with the Public Access Room for the outreach and engagement program. Appropriates funds for one full-time equivalent (1.0 FTE) position to assist in effectuating this requirement.

The need for civic education cannot be overstated. We are all surrounded by viral mis- and dis-information that is eroding our democracy. The perceptions and knowledge that people have shape their decisions and actions relating to the functioning of our democracy. When faith in the fairness and legitimacy of the foundational pillars of government is eroded, an environment is created that breeds chaos and polarization in our society. This is why it is troubling that a majority of Americans responding to a Gallup poll reported they had *not very much* or *none at all* faith and confidence in the executive, judiciary, and legislative branches of government, with the legislative branch receiving the least favorable rating. Moreover, the Annenberg Public Policy Center reported that less than half of U.S. adults could name all three branches of government, and 25% could not name any of the branches.

By establishing and maintaining an outreach and engagement program in civic engagement for students and citizens, HB 1192 will stem the decline in knowledge and understanding about the legislature. It will encourage participation in the democratic process, activities that better our

community, and interactions that develop acceptance that people of various perspectives can work together for the common good.
