Chair Tarnas and Members of the Committee:

The Department of the Attorney General (Department) supports the intent of this bill and offers the following comments.

The existing bribery statute, section 710-1040, Hawaii Revised Statutes (HRS), is a class B felony offense. This bill seeks to increase the degree of offense for the offense of Bribery to a class A felony if the public servant is an elected or appointed official, the value of the bribe exceeds \$20,000, or the person commits three or more acts of bribery as described in section 710-1040(1), HRS, within a three-year period. In addition, the bill removes the possibility of an offender receiving a deferral under chapter 853.

Section 2 of the bill also amends the Obstruction of Justice offense under section 710-1072.5, HRS, to criminalize efforts to impact the due administration of justice by means of force, threat of force, coercion, fraud, or deception. It increases the degree of offense for Obstruction of Justice from a class C felony offense to a class B felony offense and removes the possibility of an offender receiving a deferral under chapter 853.

Section 2 of the bill, however, may be subject to legal challenge as violating section 14 of article III of the Hawaii State Constitution. Section 14 of article III of the Hawaii State Constitution provides, in relevant part, that "[e]ach law shall embrace but one subject, which shall be expressed in its title." The title of the bill "Public Corruption"

may not reasonably cover the amendments related to the Obstruction of Justice, as the proposed amendments to section 710-1072.5, HRS, apply to offenses unrelated to public corruption. To address this issue, the Committee may wish to consider revising the bill to limit the applicability of the amendments to section 710-1072.5, HRS, only to offenses related to public corruption, or delete section 2 of the bill.

This bill will provide law enforcement with tools to adequately deter and commensurately punish public corruption and those that seek to improperly impact the due administration of justice. We respectfully ask the Committee pass the bill with recommended amendments.

Thank you for the opportunity to testify on this bill. The Campaign Spending Commission ("Commission") supports this bill.

This bill amends Hawaii Revised Statutes ("HRS") §710-1040(4) by making bribery of an elected or appointed public official, under certain circumstances, a class A felony. The bill amends HRS §710-1072.5 by expanding the offense of obstruction of justice to include the circumstance where a person intentionally impedes or obstructs "the due administration of justice by means of force, threat of force, coercion, fraud, or deception." The bill also upgrades the obstruction of justice offense from a class C to a class B felony and makes any person convicted of the offense ineligible for a deferred acceptance of a guilty or *nolo contendere* plea. The Commission supports the enhancement of criminal penalties for offenses involving public corruption. If enforced, the Commission believes that criminal penalties are the most effective remedies to deter public corruption.

The Commission requests that this committee pass this bill.

## **RE: H.B. 126; RELATING TO PUBLIC CORRUPTION.**

Chair Tarnas, Vice-Chair Takayama and members of the House Committee on Judiciary and Hawaiian Affairs, the Department of the Prosecuting Attorney of the City and County of Honolulu ("Department") submits the following testimony in <u>strong support</u> of H.B. 126. This bill is part of the Department's 2023 legislative package, and we thank you for hearing it.

The purpose of H.B. 126 is to increase penalties for bribery from a class B felony to a class A felony, if:

- the offender was an elected or appointed official;
- the aggregate value involved exceeded \$20,000; or
- the offense was comprised of 3 or more occurrences within a 3 year period.

As written, H.B. 126 would also amend the offense of obstruction of justice, to include doing so by force, threat of force, coercion, fraud, or deception. We understand that portion of the bill may have title issues, and would suggest that portion of the bill (Section 2: p.2, lns. 1-20) be moved to another appropriate bill, such as H.B. 710 (Relating to Government).

Given the years of scandal that have shaken the public's trust in Hawaii's state and local government, the Department believes that our state laws should be amended to reflect the egregious nature of certain offenses—such as bribery—that involve a serious abuse of authority, or betray the public's trust to a heightened degree. Every day, thousands of dedicated government workers serve the public diligently and honorably, and their hard work and good reputation should not be marred by those who would selfishly seek their own profits.

While federal prosecutors have largely taken the lead in prosecuting recent incidents of government officials being bribed, this is largely due to the greater effectiveness and severity of federal laws on the matter. To better equip county prosecutors with the tools to prosecute this type

of public corruption, the State also needs more effective laws with serious consequences. We believe H.B. 126 would do so in a reasonable manner.

For all of the foregoing reasons, the Department of the Prosecuting Attorney of the City and County of Honolulu <u>strongly supports</u> the passage of H.B. 126. Thank you for the opportunity to testify on this matter.
