Testimony COMMENTING on HB1356 HD1 SD1 RELATING TO MEDICAID PATIENT CARE

1 Department Testimony:

2 The Department of Health (DOH) offers comments on HB1356 HD1 SD1. HB1356 HD1 SD1 appropriates funds for enhanced payments to providers of state-licensed adult 3 4 residential care homes (ARCH) and developmental disabilities domiciliary homes (DD Dom) to address costs and lost revenue related with the COVID-19 pandemic. The Department of Health, 5 6 Developmental Disabilities Division (DOH-DDD) operates the 1915(c) Waiver for Individuals 7 with Intellectual and Developmental Disabilities on behalf of the Department of Human 8 Services, Med-QUEST Division. 9 During the COVID-19 Pandemic, the DOH-DDD implemented a number of measures to 10 mitigate potential loss of revenue by its programs. This included implementing one-time retainer payments that allowed providers to bill at historic payment levels for three-to-four months, 11 regardless of whether they were able to deliver services, using §9817 of the American Rescue 12 Plan Act (ARPA). On July 1, 2021, using the ARPA authority, rates were increased by one-half 13 of the difference between the existing rates and the DOH-DDD 2020 rate study 14 recommendations. On October 1, 2022, rates were increased to 100 percent of the 2020 rate 15 study recommendations. The service delivered by some ARCH providers and all DD Dom 16 providers are paid through a service called Residential Habilitation in the 1915(c) Waiver. 17 Fortunately, very few DDD participants in these settings were lost during the COVID-19 18 19 pandemic so providers experienced little if any loss in revenue during this period as the service

- 1 utilization remained constant during this time. Additonal costs for items such as personal
- 2 protective equipment (PPE) and cleaning products during the pandemic were mitigated by wide-
- 3 scale distribution by DOH-DDD.
- 4 **Fiscal Implications:** Because the state would not be able to retroactively request enhanced
- 5 payments from CMS as described in this measure, it is likely the state would fully bear costs.

These homes were a key step in the Hawai'i deinstitutionalization movement and allowed individuals with Intellectual/Developmental Disabilities (I/DD) who need care to live in a community-based setting. Any financial support that can be provided to these homes helps keep our I/DD population closer and more integrated into our communities and helps to improve their quality of life.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) comments on

this measure and defers to the Department of Health on relevant parts. DHS respectfully requests that any appropriation not replace or reduce priorities identified in the executive budget and Governor's Messages.

PURPOSE: This bill appropriates funds to provide enhanced payments for coronavirus disease 2019-related costs and lost revenues to adult residential care homes and developmental disabilities domiciliary homes that are caring for residents who receive Medicaid benefits, under certain conditions. Effective 6/30/3000. (SD1)

The HD1 amended the measure by:

- (1) Changing the effective date to June 30, 3000, to encourage further discussion; and
- (2) Making a technical, nonsubstantive amendment for the purposes of clarity, consistency, and style.

The SD1 amended the measure by:

- Clarifying that the appropriated funds shall be for enhanced payments to providers of state-licensed adult residential care homes and developmental disabilities domiciliary homes that are caring for residents, rather than patients, who receive Medicaid benefits;
- (2) Clarifying that either the Department of Human Services or the Developmental Disabilities Division of the Department of Health, whichever is applicable, shall obtain the maximum amount of federal matching funds available for the appropriated funds; and
- (3) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.

DHS does not set the rates nor directly reimburse Developmental Disability Domiciliary Homes. The Department of Health's Developmental Disabilities Division determines those reimbursement rates and payments. If there is an appropriation, it should be directed to the DOH program.

Second, this measure denotes enhanced payments for Adult Residential Care Homes. There are different types of Adult Residential Care Homes, and DHS Med-QUEST programs only reimburse for services provided at Expanded- Adult Residential Care Homes (E-ARCH). Per Act 254, Session Laws of Hawaii 2022 (Act 254), DHS already provided one-time "enhanced" payments to help mitigate some of the impacts of the pandemic to E-ARCHs along with nursing facilities and Community Care Foster Family Homes (CCFFHs).

However, while there may be residents receiving Medicaid benefits in ARCH-Type 1 and Type II care homes, ARCHs do not qualify for Medicaid payments for their residents since, by definition, they do not meet the level of care criteria for professional health services provided in an intermediate care facility or skilled nursing facility. Therefore, DHS cannot meet the proviso (section 1, lines 9-13) to obtain the maximum amount of federal matching funds available for this expenditure as no federal matching funds are available for these expenditures.

We are health care contractors for the State of Hawaii, We care for the impoverished and the Medicaid benefit recipients--who are unable to care for themselves. We provide for their housing, meals and snacks, daily needs, 24/7, 365 days a year supervision, and in some cases, we also bring patients to their doctors' appointments and provide medicine monitoring.

The Type I Adult Residential Care Homes and DD Domiciliary Homes were not awarded any Covid Relief reimbursements--just like Community care foster family homes and Expanded adult residential care homes. Our Type I ARCH has been in operation for over 50 years. Our pay (medicaid) is barely enough and just like all other facilities, we were also affected by the consequences of the Covid pandemic; therefore, we ask that you kindly support/vote approval of this bill.

Licensed home operators/providers give daily care for the most vulnerable population in our State, the medicaid benefit recipient clients. We provide medicaid clients with their essential daily needs, as well as comfort, companionship, and supervision. Licensed home providers have received no significant pay increases for medicaid recipient clients under our care for fourteen years (2008-2022). Many of the medicaid recipient clients would have nowhere else to go except the streets or beaches.

Investment by the State in the improved compensation and fair treatment for our licensed home operators/providers will draw more interest in this profession and result in more new home operators/providers which will relieve some stress on hospital ER usage and reduce homelessness.

The licensed caregivers/home operators are also a good investment for the State as they are a much cheaper and high quality alternative to a skilled nursing facility (nursing home) or hospital. In fact, care for medicaid recipients at licensed home operators saves the State millions of dollars per month.

On behalf of our members, we, the executive board of ILWU Local 1000, ask for your support of the aforementioned Bills that promote fair treatment and compensation for all licensed home operators/providers in Hawaii.

Comments:

My name is Delia Cabingabang, 70 years old, ILWU Local 1000 Trustee, and a licensed care home administrator for 40 years.

I STRONGLY SUPPORT HB1356.

My care home residents have had chromosomal deficiencies, blind, and schizophrenia. They have been with me for the last 44 years. I admitted them when they were teenagers, 2 of them were abandoned, and some have their own family but cannot take care of them because they also had to work for their own growing families.

Ever since they came to my care home, I became the Jane of all trades. I have served them like a mother, cooked and fed them three times a day, have taken them to their doctor's appointment as needed, administered their medications as ordered by their physicians, assist them in their daily activities, housekeeping and all day monitoring.

It is a big responsibility as a caregiver. I also want to retire one day. I am looking for soeone who has the right attitude and passion to take over my facility and care for my residents. This job does not attract the younger generations due to the long hours and commitment necessary to take on this role. The current pay is not enticing either at \$50.50 per patient per day, \$1,515.50 per month.

This is a challenge for all of us. The future of the care home industry is dimishing, considering the high numbers of the elderly population, plus the incoming baby boomers, as well as the existing clients in our facilities. I kindly ask for you support of this bill that will increase compensation for the care of medicaid patients.
