<u>HB 1513</u>

Chair Gates, Vice Chair Kahaloa, and members of the Committee on Agriculture & Food Systems, my name is Alison Ueoka, President of the Hawaii Insurers Council. The Hawaii Insurers Council is a non-profit trade association of property and casualty insurance companies licensed to do business in Hawaii. Member companies underwrite approximately forty percent of all property and casualty insurance premiums in the state.

Hawaii Insurers Council **opposes** this bill. Although the intent of the bill is to protect unattended animals locked in motor vehicles, we believe this legislation will lead to property damage by average citizens based on subjective judgment of whether the animal is in "imminent physical danger of suffering harm." Allowing persons to "use whatever means are reasonably necessary to protect the animal and remove the animal from the motor vehicle" may also cause a confrontation between the operator of the motor vehicle and the person attempting to get at the animal. This confrontation may lead to a physical altercation and could result in unnecessary violence and injury. Costs for example, from broken windows or physical harm will affect certain motor vehicle coverages and those costs will ultimately be borne by the insured public.

Instead, we believe the appropriate response to this situation is to call 911 and report it to the police. We ask that this bill be held.

Memorandum in Support – HB 1513

Limits civil and criminal liability for persons who remove unattended animals from motor vehicles that are in physical danger if the actions are reasonable, in good faith, and in accordance with other requirements.

Dear Chair Gates, Vice Chair Kahaloa, and Members of the House Committee on Agriculture and Food Systems,

The Animal Legal Defense Fund (ALDF) - the nation's preeminent legal advocacy organization for animals – and its members in Hawaii, support the enactment of HB 1513. This bill aims to limit civil and criminal liability to Good Samaritans who rescue domestic animals in distress from motor vehicles under certain circumstances. With so many tragic stories of companion animals dying in the heat, the public is becoming more cognizant of the danger of leaving animals in hot cars. And Hawaii is a state that experiences hotter temperatures than most year-round. By passing this bill, Hawaii would join 14 other states in helping save animals from unnecessary deaths.

People often leave their companion animals locked in their car while they run an errand, not realizing that temperatures inside vehicles can rise dangerously quickly. Even on a cloudy day with the windows cracked, conditions inside a car may turn lethal for any animals trapped inside within a matter of minutes. Dogs and other companion animals are particularly vulnerable to heatstroke because they cannot cool themselves like humans and have a harder time maintaining a comfortable body temperature.

This bill does not prescribe criminal penalties for the owner of the vehicle who leaves an animal in the car in dangerous conditions. It solely removes civil and criminal liability from the Good Samaritan who intervenes. In addition, in order to avoid liability, the Good Samaritan will have had to act in accordance with the commonsense steps outlined in the bill to ensure they have tried all other measures before breaking the window.

Further, there has been no evidence that the passage of these kinds of bills would result in a rash of car window smashing across the state. This bill protects the average constituent who wants to do the right thing, and probably would not stand idly by while a dog is in distress anyway despite the current absence of this law. This bill would simply protect them under the outlined limited circumstances.

For these reasons, the Animal Legal Defense Fund strongly supports the enactment of HB 1513 and respectfully requests that it be passed by this committee.

Aloha Chair Gates, Vice Chair Kahaloa, and Committee Members.

The Hawaiian Humane Society appreciates the opportunity to offer comments on House Bill 1513, which limits civil and criminal liability for persons who remove unattended animals from motor vehicles that are in physical danger if the actions are reasonable, in good faith, and in accordance with other requirements.

The Hawaiian Humane Society is deputized to enforce animal laws for the City and County of Honolulu. We are also a member of the Hawaii Animal Welfare Association, which represents the animal service providers across the state. Neither Hawaiian Humane nor its colleagues in the other counties could find evidence of animals being harmed due to an inadequate law enforcement response to calls about animals locked in cars.

In addition, this bill may constrain the existing authority of law enforcement in these cases by requiring - on page 5, lines 15 and 16 - that a reasonable effort to locate the owner must proceed the rescue of the animal. Emergency responders do make that effort now if time allows, but they have the discretion to act immediately.

We appreciate the compassion of the advocates for this measure, but we can find no evidence that the current law enforcement response is inadequate to protect animals.

Aloha. I write in support of HB1513. I am concerned when I see dogs locked in vehicles in full sunlight on a warm or hot day. I recognize that newer models of cars may have the capacity for the air conditioning to be on while the vehicle is unattended, but if I have reason to believe there is no a/c and it's a hot day, I'd like to know that I would be protected under the law in case I felt the need to intervene, for ethical reasons. In the past I've called a police officer to assist when I've had any doubt, but sometimes the officers are not immediately available to assist. If this law does pass, I think it would (also) be helpful for there were a public service campaign to ensure that dog owners post signage for their car window(s), to indicate their animals are safe and cool (with air conditioning) in their (newer) vehicles when unattended, to avoid further liability on the Good Samaritan. And also to clearly deliniate for the public, what consitutes a "hot day", and what sort of air flow would be appropriate and safe if a dog or other animal had to be left unattended in their vehicle at all. For example, many believe a "crack" open in the windows would suffice, but a veterinarian will tell you that just a few inches of air flow in a window or two is not enough for a vehicle to be sufficiently cool if the temperature is, for example, 80+ degrees-- the animals' lives could still be at risk. Thank you for this opportunity to submit my testimony.

I oppose HB 1513. While I understand the basis of this is to protect the actions of "Good Samaritans" that are trying to rescue a dog in need. I can tell you first hand, people are real quick to jump to conclusions without knowing all the details.

Sometimes the windows are left half open instead of fully open while the owner steps away for a few minutes because the dog is aggressive. Who is liable if the "Good Samaritan" gets bit trying to save a dog that doesn't need saving? Or, if the dog runs off and attacks someone else? Is it the owner, or the Samaritan whose actions caused the dog to escape? What if the dog runs off and is injured? Who is responsible for the veterinarian bills? This bill does not address those issues.

The other area of concern is pet theft. Someone could enter and damage a vehicle to steal a dog, and use the excuse that they were "saving it", even though the dog was perfectly fine. The bill would protect the criminal in this situation, and make it easier for them to engage in these sorts of activities without any responsibility or penalties' for the damage they cause.

Therefore, since there are a lot of ambiguities that need to be clarified with this bill, I urge you to OPPOSE HB 1513.

Members of the House Agriculture Committee:

The Pacific Pet Alliance is a Hawai'i non-profit organization that promotes responsible pet ownership through education and advocacy.

The Pacific Pet Alliance (PPA) would like to submit concerns for your consideration regarding HB 1513.

PPA aligns with the American Kennel Club's views that no dog should be left in a vehicle if its comfort, health, and safety is in question. "Good Samaritan" legislation must provide a balanced approach that protects both the health and safety of dogs and the interests of responsible dog owners.

We are concerned that HB 1513 could lead to unintended consequences that could actually harm animals and punish responsible owners, and should be amended to allow for recourse for an owner who did take proper steps to ensure their animal's safety was protected (such as proper ventilation, air conditioning, blankets, or other protocols appropriate for the breed). Owners should also be exempt from liability for their dog harming someone as a result of breaking into the vehicle, which would be especially important if the animal flees the car and becomes at-large.

The Pacific Pet Alliance respectfully asks this committee to consider these concerns when deciding on HB 1513.
