In consideration of HOUSE BILL 180, HOUSE DRAFT 1 RELATING TO CESSPOOLS

House Bill 180, House Draft 1 proposes to: 1) create within the Department of Health's Wastewater Branch a cesspool conversion section, which will be responsible for facilitating the conversion of cesspools within the State; 2) establish and appropriate funds for two full-time equivalent positions within the cesspool conversion section in fiscal years 2023-2024 and 2024-2025, and add two additional full-time equivalent positions within the section in fiscal year 2024-2025. The Department of Land and Natural Resources (Department) supports this bill.

Cesspools can cause harm to water quality within adjacent groundwater, anchialine, and coral reef systems by introducing elevated amounts of organic nitrogen and phosphorus, pathogens, and other contaminants. Contaminants emitted from cesspools can harm aquatic ecosystems by encouraging algal blooms and can also pose a threat to human health. The Department supports the allocation of additional resources to the Department of Health to facilitate the conversion of cesspools, which will help reduce future contamination of Hawai'i's fragile aquatic areas.

In support of House Bill 180 House Draft 1 RELATING TO CESSPOOLS

House Bill 180 House Draft 1 creates within the Department of Health's wastewater branch a cesspool conversion section and establishes and appropriates funds for positions within the cesspool conversion section. The Hawai'i Climate Change Mitigation and Adaptation Commission (Commission) supports this measure.

The Hawai'i Climate Change Mitigation and Adaptation Commission consists of a multijurisdictional effort between 20 different departments, committees, and counties. Removal of cesspools for all properties within the Sea Level Rise Exposure Area (SLR-XA), is imperative to the health of nearshore waters and for members of the public accessing coastal resources. Removal may not be achievable by 2050 as directed by state law without viable alternatives for replacement. The Commission's 2022 update to the *Sea Level Rise Vulnerability and Adaptation Report* Recommended Action 6.1.1 states that the state should sponsor research and development efforts to expand affordable and actionable conversion options for shoreline property owners. Recommended Action 6.1.1 also counsels that options should account for SLR-XA projections of coastal erosion and associated land loss, and potential failure of onsite sewage treatment systems resulting from sea level rise-induced groundwater inundation.

Cesspools on the shoreline and in the coastal zone will be an increasing source of nonpoint source pollution as groundwater rises and coastal erosion accelerates. Recommended Action 6.4 counsels that the state should expand policy directives beyond the existing income tax credits and requirement for removal by 2050. Specifically, policy must address existing cesspools in the coastal zone in relation to enforcement of existing laws and regulations and removal of unpermitted shoreline hardening.

My name is Lyndsey Garcia, Director of Advocacy, testifying on behalf of the Hawai'i Association of REALTORS[®] ("HAR"), the voice of real estate in Hawai'i and its over 11,000 members. HAR **supports** House Bill 180, HD1, which creates within the Department of Health's wastewater branch a cesspool conversion section, which will be responsible for facilitating the conversion of cesspools within the State. Establishes and appropriates funds for two full-time equivalent positions within the cesspool conversion section in fiscal years 2023-2024 and 2024-2025, and two additional full-time equivalent positions within the section in fiscal year 2024-2025. Hawai'i Association of REALTORS[®] supports the goal of protecting our drinking water, streams, ground water, and ocean resources. We recognize that cesspool conversion is important to preserve our environment. There are approximately 83,000 cesspools divided into three priorities¹ across the state (48,596 on Hawai'i Island; 14,300 on Kauai; 11,038 on Maui; 1,400 on Molokai; and 7,491 on O'ahu) with only 27 years to meet the state's mandate to convert all cesspools to a Director of Health approved wastewater system. To convert 83,000 cesspools by 2050, at least 3,000 cesspools would need to be converted per year. As such, a Department of Health Wastewater Branch Cesspool Conversion section with additional employees may help with homeowner outreach, education as well as facilitating different funding and financing options for the conversion of cesspools in the state.

For the foregoing reasons, Hawai'i Association of REALTORS[®] supports this measure. Mahalo for the opportunity to testify.

The Hawai'i Reef and Ocean Coalition (HIROC) is a group of scientists, educators, filmmakers and environmental advocates who have been working since 2017 to protect Hawaii's coral reefs and ocean.

The Hawai'i Reef and Ocean Coalition STRONGLY SUPPORTS HB180!

Hawaii has a public health problem with water pollution from cesspools. We have over 80,000 cesspools that discharge about 50 million gallons of raw sewage into our groundwater every day! Cesspool upgrade, conversion, or sewer connection is needed now to protect the health of Hawaii's people from pollution from cesspools. Sea level rise will exacerbate the public health problems as it will cause some more cesspools near the shoreline or in low lying areas to overflow onto the surface.

The recent report of the cesspool conversion working group recommended that we upgrade the cesspools that cause the most pollution by 2030.

Upgrading cesspools will require a significant effort and a commitment of additional personnel and resources at the Department of Health and elsewhere.

This bill would supply the Department of Health with some of the resources needed to facilitate the conversion of cesspools within the State. The bill will create a cesspool conversion section within the Department of Health's Wastewater Branch responsible for facilitating the conversion of cesspools within the State. It would establish and appropriate moneys for two new full-time equivalent positions within the new cesspool conversion section in fiscal year 2023-2024, and two additional full-time equivalent positions in fiscal year 2025.

These resources are needed to process applications and help cesspool homeowners begin to convert their cesspools Please pass this bill!

Aloha, Chair Au Bellati, Vice-Chair Takenouchi and Members of the Committee:

On behalf of the non-profit WAI: Wastewater Alternatives & Innovations, I am writing in **strong support of HB180 HD1.** This bill will create a new Cesspool Section in the Dept. of Health's Wastewater Branch to help expedite the conversions of cesspools across the state. Currently, the rate of conversions is about 150-200 per year, but that will need to ramp up to more than 3000 per year to meet the state's deadline under Act 125.

Hawaii has more than 83,000 cesspools across the state, discharging 52 million gallons of raw sewage each day into Hawaii's waters. That's similar to a massive sewage spill every day! The people of Hawaii need this law to make sure their wastewater systems aren't polluting the groundwater or nearby surface waters. As a member of the State's Cesspool Conversion Working Group over the last four years, we believe that creating a new Cesspool Section and hiring positions to staff (two to start in 2024-2025 and two more to follow in 2024-2025) will be crucial in helping the state to fulfill its mandate under Act 125 to convert all cesspools by 2050.

WAI is dedicated to protecting our drinking water, groundwater and near-shore ecosystems by reducing sewage pollution from cesspools and failing septic systems. Our goal is to help find more innovative, affordable, and eco-friendly solutions to wastewater management. Better sanitation systems reduce sewage pollution and make properties more valuable, while also protecting public health, groundwater, streams and our coral reefs and coastal areas.

Hawaii is struggling with serious sewage pollution problems, and the state has a mandate to make sure all cesspools are converted in the next three decades. Creating a new Cesspool Section will be the first major step forward in working with wastewater engineers and contractors in processing permits for cesspool conversions. As part of the new section, new staff members will need to streamline the permitting process so that it's faster and more efficient.

This bill creates a practical and expedient way to set up a new office in DOH's Wastewater Branch that is solely focused on helping wastewater engineers, contractors and homeowners with the permitting process to convert cesspools to wastewater systems approved by the DOH. It will also help the state meet the mandate to convert all cesspools by 2050. Mahalo for your leadership on this issue and support of this bill.

I live in Kona and am concerned about the massive numbers of cesspool sewage disposal on the Big Island. I have a degree in Environmental Health from Oregon State University and many years of on site sewage disposal methods and effectiveness they have in removing pathogens into the environment. Cesspools do not have any adequate pathogen removal capability in volcanic geological formations that exist on the Big Island. These type of formations do not provide the soil structure to support organisms capable of reducing or eliminating the pathogens. Adequate soil structure in coastal areas here are minimal or non existent. Therefore improperly or non existent sewage treatment allows these pathogens to enter our ocean and wreak havoc on the fragile coral reef system. Also nitrate loading is occurring which adds nutrients that fertilize seaweed that chokes out the sensitive reef ecosystem. Honorable Chair Belatti, Vice-Chair Takenouchi, and Committee Members:

The County of Kaua'i **supports HB 180** to create within the Department of Health's Wastewater Branch a Cesspool Conversion Section, which will be responsible for facilitating the conversion of cesspools within the State. It also establishes 2.0 full-time equivalent positions in fiscal year 2023-2024 and 2.0 additional full-time equivalent positions in fiscal year 2024-2025 within the cesspool conversion section.

Infrastructure to provide water and dispose of wastewater and solid waste is critical to supporting sustainable growth on Kaua`i. This entails providing safe and sanitary wastewater disposal solutions for growing areas and converting cesspools that create environmental pollution and potential health hazards. The State Department of Health (DOH) estimates 13,688 cesspools on Kaua`i, with Kaua`i having the highest density of Individual Wastewater Systems (IWS) in the State at 32 units per square mile. Currently, these IWS are regulated by DOH who uses the County's building permitting process to determine if a property needs to upgrade a cesspool to a septic system. However, a faster and more efficient system is crucial to meet the State's mandate under Act 125 and accelerate cesspool conversion.

HB 180 offers critical capacity and personnel resources to DOH's Wastewater Branch by enabling a dedicated office to assist wastewater engineers, contractors, and homeowners with the permitting process. It also offers a centralized resource to assist with the complicated nature of cesspool conversion and upgrades, including financing, public outreach and education, and facilitating partnerships.
