DEPARTMENT'S POSITION: The Department of Human Services (DHS) provides comments on this measure and proposes amendments. DHS respectfully requests that any appropriation not replace or reduce priorities identified in the executive budget and forthcoming Governor's Messages.

PURPOSE: This bill adjusts the method by which the Department of Human Services shall calculate payments to providers of medical care and long-term supports and services. Appropriates funds. (HD1)

DHS appreciates the intent to clarify and adjust the Medicaid fee schedule and to determine rates for non-institutional long-term supports and services. DHS conferred with Representative Hashimoto on a similar bill HB 1438. Rates that do not have Medicare rates for equivalent services, such as all home and community-based waiver services, are to be reviewed and determined by DHS at least every five years. An example of such a review is MQD's

December 2022 Home and Community Based Rate study for community care foster family homes (CCFFH), Expanded Adult Residential Care Homes, in-home services, and case management services.

This measure also amends the budget medical care appropriation process. DHS's "medical care appropriation" budget request is to be based on the current Medicaid fee schedule. However, the majority of the Medicaid budget is for payments to health maintenance organizations and prepaid health plans referenced in (d); such a budget request would not reflect the total medical care appropriation needed.

Additionally, to provide more meaningful information in the report to the legislature, we suggest the report focus on the "provider rates determined by the department for services without Medicare comparisons to be reviewed on a consistent schedule." Since the other payment rates are tied to Medicare or are payment rates to managed care organizations, the remaining rates that may require a report would be the ones determined by the Department, which are added through this measure. Therefore, we respectfully request amendments (highlighted) to reflect the full budget medical appropriation request as well as a targeted report:

"(e) The Department shall prepare each biennial budget request for a medical care appropriation based upon the most current Hawaii medicaid fee schedule available at the time the request is prepared [-] and the payment rates pursuant to (d). The legislature shall consider the rates determined by the Department pursuant to subsection (c).

The director shall submit a report to the legislature on or before January 1 of each year when the Department reviews rates without medicare comparisons indicating an estimate of the amount of money required to be appropriated to pay providers [at the maximum rates permitted by federal and state rules in the upcoming fiscal year.] according to the rates determined by the Department without medicare comparisons pursuant to subsection (c)."

Finally, if the appropriation is to fund the result of the Home and Community Based Rate (HCBS) study conducted by the Med-QUEST Division and reported in the legislative report, SR 4 (SLH

2022), we note that HB 1341 provides a strong purpose statement and an appropriation of \$30.2M to fully fund the "High" scenario for the select HCBS services. If the appropriation is to fund rate reviews, we would note that American Rescue Plan Act, Section 9817 funds have already been designated for the upcoming fiscal year for this purpose. Therefore, the Department's reference would be to delete the appropriation in Section 2 and to support HB 1341 as long as it does not replace or reduce the priorities in the executive budget and forthcoming Governor's message(s).

Aloha Co-Chairs Mizuno and Belatti and Members of the Committees:

My name is Keali'i Lopez and I am the State Director for AARP Hawai'i. AARP is a nonpartisan, social mission organization that advocates for individuals age 50 and older. We have a membership of nearly 38 million nationwide and nearly 140,000 in Hawaii. We advocate at the state and federal level for the issues that matter most to older adults and their families.

AARP supports H.B. 222 which adjusts the method by which the department of human services shall calculate payments to providers of medical care and long-term supports and services.

AARP appreciates the inclusion of long term care support and service providers who care for many kupuna needing assistance whether in an institutional setting or in their home which is their preference. In a 2021 quantitative research study among Hawai'i residents age 45 and older, an overwhelming number of individuals expressed a desire to remain in their homes and community as they age. 83% of those surveyed said that it is extremely or very important for them to stay in their home as they get older, and 75% said it was important to have affordable long-term care options in their community. Nearly two-thirds (65%) of Hawai'i residents age 45+ are extremely or very concerned about being able to age in place.¹

AARP feels strongly that Hawaii should expand funding for a wide range of home and community based services (HCBS) through Medicaid, and that state should fund the services needed to meet individuals' long term care services and support needs and allow them to remain in the community. We caregivers also need to sustain our living expenses. The rate of \$41.06 per day is degrading to the line of work that we do, that is \$1.71 per hour. TESTIMONY IN SUPPORT OF HB222, HD1 with Amendments

We submit this testimony as a coalition in strong support for HB222, HD1, with recommended amendments. We are the Presidents from Five Organizations representing nearly 85% of the community caregiver industry with about 1800 members.

Our first suggested amendment is to provide a sound preamble in the bill, which displays the history and significance of the community based caregivers and care homes. Attached is the recommended preamble starting with **The Legislature finds...**

We request the preamble or introduction section of HB222, HD1 be amended to add the following:

The legislature finds that nearly one third of Hawaii's residents and half of all keiki are enrolled in Medicaid. Since the start of the coronavirus disease 2019 pandemic in March 2020, Medicaid enrollment has increased forty per cent. However, timely access to providers can prove difficult, especially in rural areas where health care providers are in short supply. In 2022, the State had a shortfall of more than seven hundred fifty full-time physicians and nearly four thousand nonphysician, patient-facing health care workers, such as nurses, technicians, and patient service representatives.

The legislature further finds that due to the significant number of Hawaii residents receiving Medicaid coverage, health care providers often receive less reimbursement from Medicaid than from Medicare or commercial insurances for the same service. While some providers are reimbursed at cost or at the same rates as Medicare such as large hospitals, large nursing centers, and providers who perform certain services most individual health care professionals, such as physicians, psychiatrists, psychologists, community based caregivers, advanced practice registered nurses, nurses, certified nursing assistants, and nurse assistants are not. Lesser reimbursements contribute to the challenges providers face in sustaining practices, leading some health care providers to limit or refuse to accept Medicaid patients. If only the large hospitals and large nursing centers receive Medicaid reimbursement equal to the Medicare reimbursement rate, this will cause a substantial reduction of the number of community based care homes in the State who will receive significantly less than health care providers at large hospitals and nursing centers. The potential closure of community based care homes which is a vital part of the State's long-term health care continuum and provides 24/7 care to over an estimated 12,000 patients many of whom are Medicaid patients will lead to a significant number of patients transferring from these community based care homes to large nursing centers and hospitals. The hospitals and nursing centers will not be able to accept the thousands of patients who may transfer after a significant transfer of patients. Therefore, the Legislature finds it is vital to ensure community based caregivers, such as be not limited to:

(1) Community care foster family homes issued a certificate of approval pursuant section 321-483, Hawaii Revised Statutes;

(2) Adult residential care homes type I licensed pursuant to section 321-15.6, Hawaii Revised Statutes;

(3) Expanded adult residential care homes licensed pursuant to section 321-15.62, Hawaii Revised Statutes; and

(4) Developmental disabilities domiciliary homes licensed pursuant to section 321-15.9, Hawaii Revised Statutes;

The legislature further finds that the department of human services med-QUEST division completed a study of home and community based rates paid for community care foster family homes, expanded adult residential care homes, and other home and community based services. The department of human services med-QUEST division contracted Milliman, an actuarial firm, for a wide range of services and to conduct the study. The study commenced in July 2022, and the department of human services med-QUEST division issued the final report on December 30, 2022.

The legislature also finds that a key part of the rate study included stakeholder outreach and engagement with home and community based services providers and their associations, collecting provider cost and wage survey data, and getting provider feedback on draft rate calculations. Not surprisingly, the provider surveys showed significant wage pressure given the current labor market. The rate study methodology used wage and salary data for direct care staff and supervisors, employee-related expenses, transportation and administration, program support, overhead, and Bureau of Labor and industry wage indices to pay for employee benefits such as health insurance.

The legislature believes that the pandemic dramatically impacted healthcare and long-term care delivery systems. Many of these changes as they relate to patient preferences, facility staffing practices, and technology utilization will persist long after the pandemic abates. Accordingly, now is an opportune time to determine the long-term continuum of health care reimbursement and reviews ways that it can be objective and fair to promote patient care quality, support livable wages for staff, and maximize efficiency.

The legislature further finds that the med-QUEST division should undertake rate studies to better understand how the pandemic has shaped long-term care These studies should consider how patient providers. preferences have shifted away from institutional settings and to home and community based care homes; how patient needs evolve with the aging population; the growing complexity of patient care; and what can be done to align Medicaid reimbursement with equal to such reimbursement to the large hospitals and nursing centers in Specific attention is also necessary on programs Hawaii. that reward high-quality care; incentivize accepting and caring for Medicaid beneficiaries, especially those with complex needs; pay wages necessary for the recruitment and retention of staff across the long-term care continuum; and consider the need to update the aging physical infrastructure of many of the State's facilities.

The legislature also finds that it is important to focus on home and community based services providers who serve groups with high utilization of services and who have gone the longest without a rate update such as case management agencies, community care foster family homes, and adult day health and day care centers. The Centers for Medicare and Medicaid Services is also changing payment methods for nursing facilities. State Medicaid agencies will need to adopt new reimbursement methodologies that align with the new federal payment system. These all create opportunities to revise how providers of long-term care are reimbursed to better meet current and future needs.

Accordingly, the purpose of this Act is to appropriate moneys for the achievement of fair and full funding, including estimate payment increases, of Medicaid home and community-based services.

The second amendment (Prior to SECTION 3) we suggest is on page 4, end of line 3 after the sentence "amount of money required to be appropriated to pay providers" add the following:

(1) Community care foster family homes issued a certificate of approval pursuant section 321-483, Hawaii Revised Statutes; and

(2) Adult residential care homes type I licensed pursuant to section 321-15.6, Hawaii Revised Statutes; and

(3) Expanded adult residential care homes licensed pursuant to section 321-15.62, Hawaii Revised Statutes; and

(4) Developmental disabilities domiciliary homes licensed pursuant to section 321-15.9, Hawaii Revised Statutes;

According to the rates determined pursuant to subsection (C).

We are incredibly overwhelmed with gratitude that Congress is now listening to our petition for an increase in Medicaid-Home and Community Base Services pay.

We are foster home operators in the Waipahu area. Other than our AFHA Association, we share ideas and learn from each other in solving concerns and providing excellent care to our clients.

Our clients come to our foster home with underlying medical, physical, mental, and emotional problems. Caregivers embrace them and work hard to meet the client's needs when they are under our care in our homes.

Because of these clients' conditions, they are even more prone to getting sick, either related/unrelated to their current underlying conditions upon admission. During such, which happens very frequently, we, the caregivers, are on 24/7 to monitor the client, communicate with their doctors, case management in charge, and update their families with the client's current condition.

In addition, we hire our secondary caregiver for 4 to 6 hours at a rate of \$15 an hour to cover for us to bring our clients to their doctor appointments and shopping for their food, medicine, and other household needs.

Caregiver services also include charting/documentation and client's care, such as bathing, driving, meal preparation, household chores, laundry, and shopping. Though we commit to these tasks while they are under our care, a pay increase would definitely be a great incentive to provide more quality service and in making our home more of a "client's home away from their own home."

My name is Jolly Orozco. I have been a caregiver for the past 19 years and I strongly support HB222-HD1 to raise our reimbursement rate; for which we have not seen a raise for over 14 years. As caregivers, we work tirelessly to provide more than adequate care services to the Kupuna of Hawaii. Our work duties include everything you could possibly imagine if you were to take care of your own parents or a child per say. This job is 24/7 365 days a year, and a reimbursement rate of \$44.16 a day does not adequately compensate for the blood, sweat, and tears we put into our profession of taking care of the people that came before us.

\$44.16 is not improper compensation for the hours and work put in, but the lack of raises also does not follow industry trends or the rise in inflation. Over the past 14 years, most other industries, along with the minimum wage in Hawaii, have increased to follow inflation. The lack of raises in our profession have made it difficult to keep up with the cost of living in Hawaii which makes it hard to be able to stay in this profession.

Chairs Mizuno and Belatti, Vice Chairs Amato and Takenouchi, and Members of the Committees:

The Adult Foster Homecare Association of Hawaii (AFHA) **strongly supports HB222 HD1**, which adjusts the method by which the department of human services shall calculate payments to providers of medical care and long-term supports and services.

Community care foster family homes (CCFFHs), which supplies over 2,000 beds statewide to elderly and disabled Hawai`i residents, have not seen any increase in reimbursement for over 14 years. We've borne the brunt of inflation and other cost increases. 14 years – we are at a loss for words.

We applaud the state for commissioning the Home and Community-Based Services (HCBS) Rate Study Report by Milliman last year. Finally, someone has validated what we have been saying for the last 14 years. For years, it's as if no one has taken us seriously, taking us for granted. Finally, someone is recognizing our plight as an industry and the challenges we face.

Based on the Milliman Report, the Department of Human Services, Med-Quest Division (Med-Quest) concluded: "It is also important to focus on HCBS providers who serve groups with high utilization of services and who have gone the longest without a rate update such as case management agencies, **community care foster family homes**, and adult day health and day care centers." (Emphasis added.)

Ironically, the recognition of our hardship comes from an outside consultant from out-of-state. Perhaps a broader national perspective accentuates how far behind CCFFHs lag behind and how we are undervalued. We emphatically join Med-Quest in their observation that it is time "to revise how providers of long-term care are reimbursed to better meet current and future needs." Now is the time!

We were already the lowest paid in the nation – below even the "low" end of the spectrum according to Milliman. Inflation, which spiraled out-of-control, has exacerbated the challenges. Our industry is one in which the younger generation in our country have little interest. Rarely does a young person today have ambitions to become a CCFFH or to open a care home. We need to set a solid foundation for the future.

Being a foster home caregiver has its advantages and disadvantages. Caring for 2 or 3 elderlies gives the convenience of staying home while rendering service to them and no need to dress up, drive to the workplace. The main disadvantage is its a very low paying endeavor. Comparing the compensation of the caregivers working in hospitals, facilities and other home setting care giving facilities, the payment of a foster home operator is very low. With a 24/7 job and responsibility, less than \$2 an hour is far from a decent compensation. The workload and the responsibility is too heavy.

A pay increase is badly needed especially at this time when the prices of all goods and services skyrocketed and the mere pay that we receive is just enough for survival.

Doing this job needs some destressing and relaxation. But with the reimbursement we are receiving, we cannot afford to pay a substitute who can come and take over so we can get out of our homes and recharge to keep our sanity and have some rest & relaxation. When we take an extended vacation, say a week or two, it is already very costly so many of us are burnout and thinking to give up.

Some of us foster home operators are even resorting to have the "unlicensed care homes" or having an "illegal addition of client" just to make both ends meet. If the compensation is good enough, I believe that the proliferation of unlicensed care homes will be curtailed.

We had been clamouring for the overdue pay raise for the longest time. Recently, there is a raise of meager \$3 a day. What can this insignificant amount do to help ease the burden? Running a foster care home for the elderly is in many ways a joy and a higher calling.

Bringing comfort and security to the twilight years of my clients by providing them with basic needs as well as enrichment activities gives me a sense of purpose and the satisfaction of knowing I positively impact the lives of others. My job is to take care of my clients to the best of my ability and I am my own boss.

Running a foster care home for the elderly is also, however in many ways, a BIG challenge.

I can't leave my home without a substitute caregiver, which I can't afford due to the high cost of employee maintenance and inflation which means even basic errands and helping my kids is a constant source of worry, not to mention I haven't had a vacation for years.

I gross what would seem to many a fairly high amount of income each month, but the amount of food, electricity, laundry, toilet paper, and cleaning supplies the clients incur leaves me with barely enough to cover my mortgage, bills and certainly not enough to hire a substitute so I can have a life.

Under the current compensation system for 1 private and 1 medicaid, I have about enough per month profit, which goes to state and federal taxes, enough to spend on myself each month, which makes this a sustainable business, but not a profitable one.

And let's not forget as a self employed small business owner I have no medical dental or 401K anymore.(thanks to our significant other who include us with their employer benefits plan}

Some of my fellow CCFFH owners have given up and gone back to working in hospitals again because there is simply no incentive to keep operating long term in the current economic climate.

The fact remains that our state needs us. You need us. We are front liners in our own right. Without us half the Kupuna we give care to would end up flooding long term care facilities and the other half would slip through the cracks and end up homeless. Dear Legislature:

I, Cynthia Gima, am sending you my testimony in STRONG SUPPORT HB222, PAY INCREASE which will be held February 7, 2023, 8:45am, Rm 211. We have not received an increase for **14 plus years**. I'm in this business because of my passion to help people who are not able to care for themselves, but it is becoming very hard to survive with the pay we are currently receiving for our services. As much as I love caring for the elderly it's becoming very difficult economically to maintain a balanced life, both to my patients and my family.

The following are just some examples of why we strongly need our pay increases:

-Cost of utilities, electricity, water, sewer costs that clients use.

-Property, general and income taxes

-Food and supply costs for clients.

-Gas used when bringing clients to their doctor appointments.

-Transportation costs for our clients who require assisted transportation, fees average \$70-\$120 depending on the distance.

-Car and Liability Insurance required in the home to follow state regulations.

-Normal way of living for the family is sacrificed with a foster home.

-Caregivers must budget/pay when we; take vacation, are sick (no sick leave), bereavement leave, take clients to their appointments, shop for client needs, attend special occasions, attend meetings, rallies, educational sessions, or just want to spend quality time with my family. We have to budget this on \$44.16/day, which is why we are asking for \$20 plus more per hour.

-Caregivers will work while sick due to not wanting to have to pay for a substitute and average way less sleep than health recommendations.

-Caregivers provide 24/7 care to their clients, we deserve a quality lifestyle also but it's impossible to do so with the pay that we are receiving.

-What type of job hasn't received an increase in pay in **14 plus years**, absolutely everything went up except for our pay and yet we still provide 24/7 care to our clients.

It's not hard to figure out the math, \$44.16/day received but pay subs \$100 plus/day, please let us know if there are any other people that you know of in the workforce that is faced with these types of numbers. It's basically we are paying anytime we are not with our clients.

Before you all vote, please put yourself in our shoes providing best care for our Kupuna 24/7 with a pay of \$44.16 daily which came to an effect January 2023. Prior to January 2023 the daily service pay rate was \$41.06 and the attached document shows that rate effective January 1, 2009, which proves that caregivers were working for the same pay for over 14 years.

I strongly believe that in order to maintain the integrity of our profession and to ensure that kupuna are cared for properly caregivers should be rewarded with pay that is indicative of the time, effort and care that they put in. Another key factor on the importance of this bill is to make sure quality caregivers are retained and stay in Hawaii instead of moving to the mainland to work for better pay.

For all these reasons, I strongly support HB222.

Providing client satisfaction around-the-clock is a difficult task. We take care of everything for them, including bathing them, changing their diapers, carrying them during transport, exercising them, feeding them, entertaining them, watching out for their safety, taking them to the doctor, and more. Aloha to our hard working Legislatures:

I have been a caregiver for 13 years. Throughout these many years, I have cared for all sorts of clients; difficult, easy, hospice, behavior and others and their daily rates are the same despite their conditions. Caregivers are very deserving to receive a much higher increase to help us maintain our foster homes, maintain reliable and caring substitute caregivers to provide the best services and care to our clients and their families. As you know, we have to care for clients 24/7 plus we drive/accompany clients to their appointments, plus we buy them food. If we need to go to our own appointments, grocery or just to go to the mall shopping or to relax, we have to hire substitutes. Finding a substitute is very hard because they are asking for higher pay. Substitute rates are going for between \$15.00 - \$20.00 sometimes more depending on the no. of clients you have and their conditions. This is not affordable for caregivers if the daily rates remain the same with very low yearly increases, if you have all medicaid clients. We may be lucky to admit private clients, but the majority of the time, they are private for only 3 or 4 months then convert to Medicaid. When clients become Medicaid, caregivers have to refund the excess paid when they were private from the month they were approved, so at the end, not a private, it's medicaid.

I fully support this bill HB222-HD1 and I ask for your SUPPORT, as well.
